The future growth of the community is headed in a direction where budget amendments will be discussed annually as priorities and future opportunities present themselves for the City Council to take action.

<u>Section 2.</u> The sums shown on Exhibit "A" are hereby appropriated from the respective funds for the payment of expenditures on behalf of the City government as established in the approved amended annual budget document for the fiscal year ending September 30, 2022.

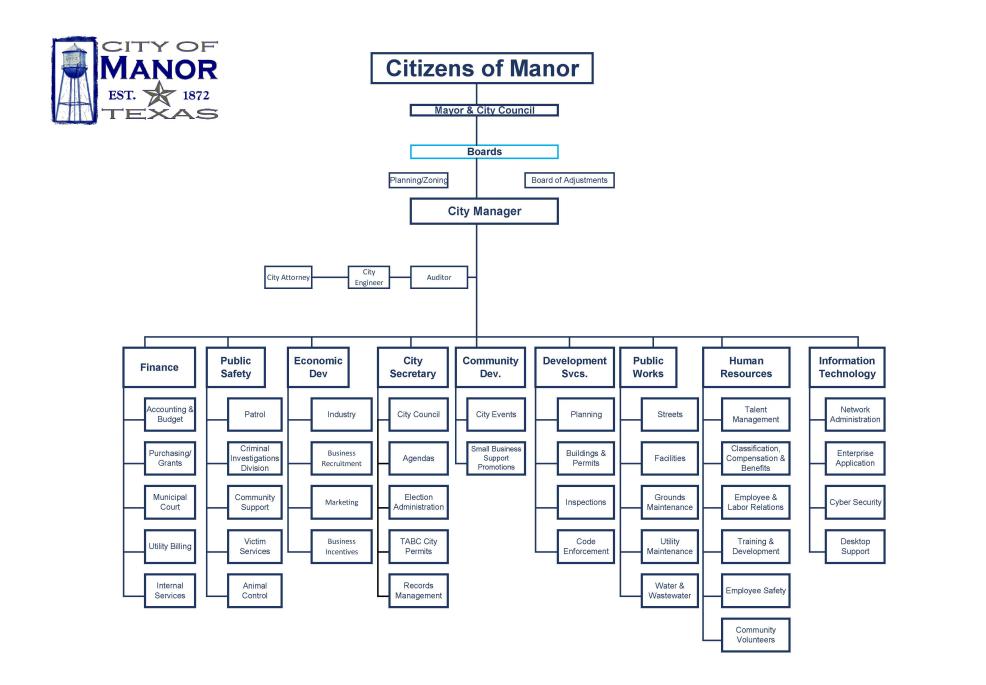

Mayor and City Council,

In accordance with the provisions of Article III Section 8.04 of the Manor City Charter, the proposed *Annual Operating Budget* for the City of Manor for the Fiscal Year of October 1, 2021 through September 30, 2022, is hereby presented for your consideration.

The grand total of all appropriations for all departments, operations, and functions proposed for the FY 2021-2022 Amended Annual Budget is \$19,979,898 to be generally distributed as described herein.

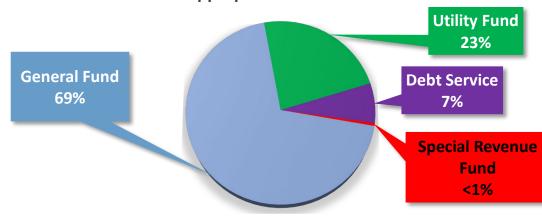
The proposed FY 2021-2022 Amended Annual Budget is a zero based, balanced, and appropriately conservative financial plan wherein all operating expenditures are supported by revenue generated during the fiscal year; and was developed through a comprehensive review of financing for all existing programs, operations and services. The FY 2021-2022 Amended Annual Budget as proposed is delineated into four (4) basic funding categories:

* **General Fund (\$19.9M)** – revenues and expenditures related to the provision of primary or traditional city services whose main financial support comes from tax dollars

* Utility Fund (\$6.8M) – an enterprise fund monitoring all financial transactions relating to the provision of potable water and sanitary sewer services through the city's systems

* **Debt Service (\$2.2M)** – all proceeds and expenditures related to servicing, annual debt payments, and/or management of various debt obligations

* **Special Revenue (\$.057M)** – revenues and expenditures related to various projects and programs that are supported by a dedicated revenue stream



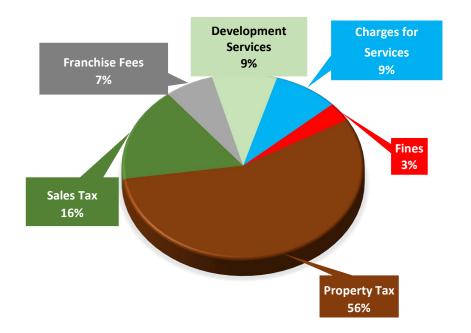
Total Appropriations - All Funds

FY 2021-2022 AMENDED ANNUAL BUDGET-BUDGET HIGHLIGHTS

General Fund Revenue

The General Fund is the City of Manor's principal operating fund for essential city services and is supported by a variety of revenue sources. Property (Ad Valorem) Taxes and Sales Tax, however, provide the primary funding support as the graph below shows.

- Property Taxes Property tax revenue in FY21-22 is moderate growth in the city's taxable valuation, as home construction is anticipated to continue at its present rate throughout the fiscal year.
 - The FY21-22 Amended Annual Budget has adoption of a tax rate of \$0.7827. This rate will lower the tax rate from \$.8161 by \$.0334.



- Sales Tax The State of Texas imposes a 6.25% sales and use tax on "all retail sales, leases and rentals of most goods, as well as taxable services". The City of Manor imposes as additional 2.0% sales tax to create a maximum combined rate of 8.25%. Of that total Austin MTA (Capital Metro) receives 1.0%, and Travis County Emergency Services District 12 0.05%. The City has experienced steady annual increases in sales tax revenue over the last decade, but the last two years have produced historical income levels:
 - Total Sales Tax Revenue was \$2.1M by FY21-22 year-end

The General Fund is the general operating fund and the largest fund of the city as it includes all traditional government services such general administration, street and drainage, maintenance, development services, police and courts, and parks.

The Utility Fund accounts for the city's water and wastewater enterprise. Unlike the general fund it operates as a proprietary fund functioning more like a business.

The Restricted Funds are used only for specific purposes. Reveues and payments are limited either by state law or local ordinance.

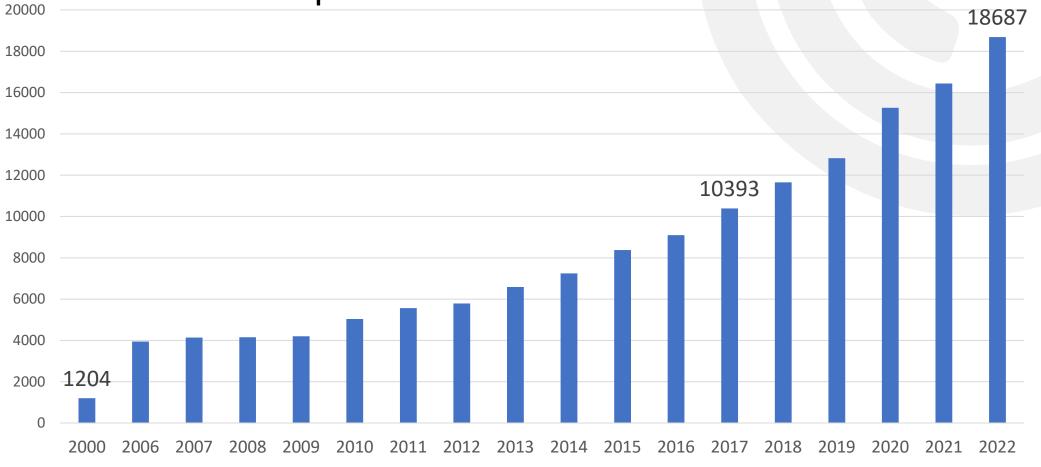

2021 Certificates of Obligation/Capital Improvement Program

Late 2021, the City Council approved the issuance of the Certificates of ٠ Obligation (COs) in a total amount of \$6.36M to fund various water and wastewater projects.

A majority of Council supported the proposed Capital Improvement Projects (CIP) Program. The purpose of these bonds is to pay for contractual obligations of the City to be incurred for the following purpose, to wit; (1) design and construction of, and the acquisition of equipment and other property for, the improvement and expansion of water and sewer lines, the construction of new water and sewer lines, the addition of new ground storage tanks and pumps, and the expansion of one or more lift stations; and (2) the payment of professional services and costs of issuance related thereto.

^{*}Graph shows population within City limits

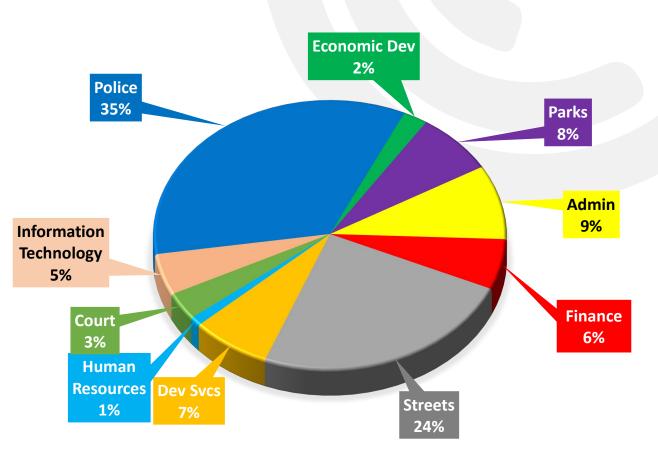

General Fund Expenditures

The General Fund is the primary operating fund of the City of Manor and is utilized to account for all costs traditionally associated with city government. The proposed FY 2021-2022 Amended Annual Budget includes total General Fund expenditures of **\$13.8M.**

Within City of Manor operations, General Fund Expenditures are those costs associated with the provision of essential city services including, but not limited to public safety, parks, public works, mobility and asset maintenance. The primary sources of income supporting the General Fund are Property and Sales Taxes.



General Fund

Article III Section 8.05 of the Manor City Charter states "the City Manager is responsible for the timely preparation and presentation of the budget". The **General Fund** is the primary operating fund in the budget used to account for resources not required to be accounted for in other funds devoted to specific activities. It is used to account for operations of basic City functions such as public safety, public works, cultural and leisure programs, community planning/development plus direction and management of all municipal functions. Services provided by the City are classified according to activity and presented as operating departments in the Budget.

As a spending plan for the year the budget contains estimates of revenues expected to be generated in the forthcoming year as well as the cost of programs that are planned for the year. Two basic elements of all funds are revenue and expenditures, the latter of which authorize expenditures for line items that appear in each departmental breakdown. These are detailed in the budget document for each activity in each fund. The former are estimates of fiscal resources that are expected to be generated during the subject fiscal year and are intended to finance programs of "Expenditures" for that same time frame.

Total revenue received for the 2021-22 fiscal year is \$19,979,898. Direct expenditures were \$13,793,603. The following are general comments on sources and expected trends of revenue for the General Fund.

General Fund Revenue Summary

Revenues are generally a function of certain "rates" applied to specific quantifiable amounts such as assessed property values, volumes of water used, a percentage of gross revenues (franchise fees), etc. The chart summarizes revenue for the general fund by major funding category. This is followed by a more detailed look at revenue by general category.

RESOLUTION NO. 2023-10

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MANOR, TEXAS, DESIGNATING PUBLIC WORKS VEHICLES AS EMERGENCY VEHICLES PURSUANT TO CHAPTER 541, SUBCHAPTER C, SECTION 541.201 OF THE TEXAS TRANSPORTATION CODE.

WHEREAS, the Texas Transportation Code (TTC) Section 370.177 provides for the imposition of fees when a vehicle travels through a toll collection facility on the turnpike;

WHEREAS, TTC Section 370.177 provides an exception from the toll requirement for emergency vehicles properly identified and authorized pursuant to TTC Section 541.201;

WHEREAS, TTC Section 541.201 allows a city to authorize municipal department or public service corporation emergency vehicles as emergency vehicles exempt to the toll requirements in TTC Section 3701.177; and

WHEREAS, The City of Manor desires to designate certain vehicles utilized by the Public Works Department as emergency vehicles pursuant to TTC 541.201.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY OF MANOR, TEXAS, THAT

Section 1

The facts and recitations contained in the preamble of this Resolution are hereby found and declared to be true and correct.

Section 2

The City Council hereby designates vehicles utilized by the Public Works Department as emergency vehicle pursuant to Texas Transportation Code (TTC) Section 541.201(D), a copy of which is attached as **Exhibit "A"**. License plate numbers for the specific vehicles being designated include:

Sidewalk maintenance within TxDOT ROW has generally been the city's responsibility for maintenance. TxDOT will be installing sidewalks and pedestrian ramps when they install the new traffic signal at N. FM 973 and Murchison, by Lagos Elementary, and they have provided the city with this Asset Maintenance Form that provides that the city will maintain, control, supervise, and regulate those sidewalks and pedestrian ramps.

With few exceptions such as: Legal Work; Documents created in InDesign or that contain Form-Based code requirements; Creation of Fee Schedules; Gender Neutral Review/Implementation; External Linking; or codifying a newly adopted Term Change, your annual fee will be known, empowering you and your community to send us all your legislation for one annual fee.
- Reduced Administrative Processing
- Consistent Budgeting. Easily budget for your supplementation costs.
- Increased Transparency

Inflation Adjustment

Over the past 10 years, Municode has only raised prices two times. They have raised the prices for the Online Code Hosting service in 2012 and raised prices slightly in 2017.

As we are all experiencing in our day to day lives, the U.S. Dollar has had an average inflation rate of 3.31% per year between 2017 and today, producing a cumulative price increase of 21.58%. In 2022 alone, the rate of inflation was just below 8% nationwide. In order to keep up with the increasing pressures of inflation and to ensure Municode is making the necessary investments in us, their team and their products, the following adjustments will be made:

- <u>Supplementation Page Rates</u>: If we would like to remain with the per page billing model, the per page rate will increase approximately 30%.
- <u>Supplementation as a Service</u>: In order to help keep our costs down, if we opt for the Supplement as a Service model, the price quoted, typically represents only a 10% price increase over the three-year average of city's supplementation bills, plus a 14% increase in your administrative support fee.
- <u>Online Code Hosting and any Electronic Products</u>: With our next renewal, our annual fee will increase 14%.

Addendum 1

This agreement ("Agreement") is explicitly agreed to by the Customer listed on the Statement of Work. All terms used in this Agreement that are not otherwise defined shall have the definition ascribed to it in the Statement of Work.

1. Scope of Services. The Services provided to Customer under this Agreement are set forth in the CivicPlus Statement of Work signed by the parties (the "SOW"). Customer may purchase additional services for additional cost at any time upon mutual written consent of the Parties, including but not limited to updating the frequency of Supplement updates, additional labor required because of delays, errors or omissions on the part of Customer.

2. Limitations of Services. Annual Recurring Supplement Service does NOT include:

a. Additional copies, reprints, binders and tab orders;

b. Documents drafted in InDesign or that contain form-based code requirements, are subject to additional editorial fees;

c. Legal work, creation of fee schedules, gender neutral review/ implementation, external linking;

d. Codifying a newly adopted term change legislation. This may be subject to a one-time additional editorial fee. Material to be reviewed upon receipt;

e. Online Code hosting and online features, this is listed separately

For services outside the scope of the Annual Recurring Supplement Services, a per page rate of \$23 will be applied.

3. Each document for processing should be its own individual file, named by its ordinance number. Customer should send in all documents to CivicPlus as MS WORD versions or a convertible PDF version.

4. Term and Termination. This Agreement shall remain in full force and effect for an initial period of one year commencing on the Effective Date ("Initial Term"), at the end of the Initial Term, this Agreement shall automatically renew for additional one-year terms (each a "Renewal Term"). If either Party does not intend to renew this Agreement, they shall provide sixty days prior notice to the end of the then-current term. Either party may terminate this Agreement for cause in the event the other party materially breaches any term of this Agreement and does not substantially cure such breach within thirty days after receiving notice of such breach. A delinquent Customer account remaining past due for longer than 90 days is a material breach by Customer and is grounds for CivicPlus termination.

5. Compensation. Unless otherwise stated in an SOW signed by the Customer, the Customer shall pay CivicPlus for the Services annually at the start of each Renewal Term, within 30 days of the date an invoice is sent.

Customer is responsible for providing all necessary and correct documentation, materials and communication in a timely manner in order to enable CivicPlus to perform the Services and acknowledges CivicPlus cannot begin performance of the Services until all necessary documentation, materials and communication is received.

CivicPlus is not a law firm and may not perform services performed by an attorney, and the Services contemplated herein do not constitute a substitute for the advice or services of an attorney.

In the event either party is unable to perform its obligations under the terms of this Agreement because of acts of God, strikes, damage or other causes reasonably beyond its control, such party shall not be liable for damages to the other for any damages resulting from such failure to perform or otherwise from such causes.
