He also went over an interlocal they have with Wall to help cover the area so there is always an ambulance available. He went over the statistics for the year.

Council Member Lee inquired about the shared services and how it came about. He also inquired about dropped calls.

Council Member Mangan stated that the budget is coming up and residents should pay attention as these costs will be absorbed.

Council Member Triggiano inquired about the cost associated with the call to a resident.
