Mayor Donovan read the following proclamation into the record.

Honoring the Belmar / Lake Como Saint Patrick's Day Parade on the Occasion of Its 50th Anniversary

WHEREAS, In 1974, the newly formed Jerry Lynch Club created and led the first Belmar St. Patrick's Day Parade up Main Street. Men and women of the Jersey Shore joined together and marched in honor of Saint Patrick. The parade was intended to be a showcase for the "Irish Riviera." Entertained by marchers, bands, and a lot of fire engines, crowds lined the streets early on in this parade.

WHEREAS, the parade developed rapidly and attracted statewide attention within four years of its inception. Close to a thousand marchers participated, and the crowds kept growing. By 1981, New Jersey Transit added special trains on parade day to accommodate the ever-growing number of spectators from North Jersey and New York.

WHEREAS, by 1985, the parade had grown to the point that it needed its own Committee. The Executive Committee was formed to deal solely with the job of putting a parade on the street. The group boasted 25 volunteer members and was led by chairman, Dave Stanley. To this day, the Committee is composed entirely of volunteers.

WHEREAS, the following year, another tradition was born with the inception of the Investiture Mass at St. Rose R.C. Church and parade spectators neared 80,000!

WHEREAS, in 1992, the newly formed Friendly Sons of the Shillelagh Jersey Shore joined the parade. Because they were new, they were at the back of the parade. After marching, their fellow Shillelaghs from Old Bridge and Essex, came back and marched with the Jersey Shore Shillelaghs.

WHEREAS, by 1993, the parade consisted of more than 4,000 marchers, 35 bands and 20 floats. Within 10 years the numbers grew to over 5,500 marchers and more than 40 bands. Roughly 200,000 spectators reveled in what the parade had become.

WHEREAS, In 1999 the newly formed Women of Irish Heritage of the Jersey Shore marched for the first time in the parade and have done so every year since.

WHEREAS, in 2004 the Parade Committee sadly said goodbye to Dave Stanley. The parade had grown substantially in size, and coordination had become almost a full-time job from December to March. Two new leaders were named as Parade Chairmen, Chip Cavanagh and Bill O'Connell.

WHEREAS, in 2008 Bill O'Connell assumed the position of Treasurer and Chip Cavanagh that of Chairman.

WHEREAS, in 2013 the parade celebrated its 40th anniversary and honored the original parade Committee, Ed Hendrickson, Andy Gallagher, Anne Aker, Jerry Lynch, Fran Lynch, Dick McMorrow, Paul Caverly, Jackie Cavanagh, Tim O'Leary, Charlie Sylvester and Dave Stanley.

WHEREAS, in 2020 Jerry Lynch passed away, and wife, Fran Lynch died in 2021. Jerry and Fran were the founders and members of the original Committee and put their hearts and souls into this parade.

WHEREAS, the parade celebrates its 50th year in 2023. The parade remains the largest St. Patrick's Day Parade in the state of New Jersey. The parade draws more than 100,000 visitors to see the sprawling sea of pipe bands and parade floats. What started as a dream and a plan by a young Jerry Lynch Association has become one of the highlights of and has transformed into one of the great Irish events of the Saint Patrick's Day Season!

RESOLUTION 329-2023

- **WHEREAS**: Local Government is facing the largest budget increase for property/casualty insurance since the mid-1980s; and
- **WHEREAS**: The property/casualty budget for the typical municipality has already experienced a 20% to 25% increase since 2021 and will experience another 12% to 20% increase in 2024; and
- **WHEREAS**: New Jersey now has the highest workers' compensation premium rates in the country based on data from the U.S. Bureau of Labor Statistics; and
- WHEREAS: Workers' Compensation escalated because New Jersey judges are now reopening cases up to four and five times, whereas in the past they rarely reopened a case more than once; and
- WHEREAS: Workers' Compensation also escalated because of a 2021 Department of Labor decision that directed workers' compensation to pay many accidental disability claims that previously were paid by the pension plans; and
- WHEREAS: Another recent law created a presumption that firefighters diagnosed with cancer are eligible for workers' compensation; and
- WHEREAS: During the COVID 19 Pandemic, the Legislature approved a law that made COVID contracted by first responders and essential employees compensable under New Jersey's workers' statute resulting in the COVID cost per employee being the second highest in the country; and
- **WHEREAS**: Liability has increased because of the erosion of Title 59 protections in New Jersey's courts. Judges are now reluctant to grant summary judgement dismissing even frivolous claims because of the 2021 New Jersey Supreme Court decision in Gonzalez v. Jersey City; and
- **WHEREAS**: The recent amendment in the sexual molestation statute of limitations also increased Title 59 liability costs. In some cases, towns are being sued based on allegations going back to the 1970s; and
- WHEREAS: Property premiums are increasing rapidly because the world-wide frequency of large natural disasters has almost tripled since 2000. New Jersey alone was hit with Hurricane Irene in 2011, Superstorm Sandy in 2012 and Tropical Storm Ida in 2021; and
- **WHEREAS**: Property insurance premiums are also indexed to replacement values that have jumped because of supply chain issues and the labor shortage; and
- WHEREAS: Cyber liability premiums have more than doubled in recent years. Organizations without strong cyber risk controls are finding it difficult to purchase any coverage.

NOW THEREFORE BE IT RESOLVED BY THE NEW JERSEY LEAGUE OF MUUNICIPALITIES THAT:

- 1) The Legislature is urged to adopt budget and levy cap exemptions for property/casualty insurance and claims; and
- 2) The Administration and the Legislature should not adopt additional legislation or regulations that will increase municipal claims without a thorough and complete analysis of the cost; and
- 3) The New Jersey Department of Labor, the New Jersey Department of Banking and Insurance and the New Jersey Department of Community Affairs should meet with representatives of municipal government to discuss ways to reduce property/casualty costs.

He also reported on the Broad Street County drainage project as well as the park projects that have taken place over the year. He thanked everyone that was involved in decorating the town for the holidays and he also thanked Carmen Triggiano and Rayn Travers for overseeing the holiday decorations throughout town.

Administration and Finance Committee - Council Member Olivera thanked the committee and council for all their hard work and support for the administration and finance committee throughout the year. He also thanked Administrator Tom Flarity, Municipal Clerk Barbara Ilaria and Amy Spera from the finance office for their tireless efforts throughout the year and previous years. He stated that these people make the council jobs as stewards of the town much easier, and he thanked them for allowing the council to achieve their goals through the offices. He reported on the hiring of a personnel officer and what she has brought to the table throughout the year and thanked her for all she does for the borough. He stated that it is impossible to list all the work that the clerk's office does, but he went over some items for the purpose of showing the shear volume of processing which included boat slips, dog licenses, use of borough property requests, Sea Watch lockers, OPRA requests, resolutions and ordinances.
