Regular Meeting of Mayor and Council was convened at 7:00 p.m. on January 17, 2023 with Council President Jeff Lee presiding. This meeting was held in person at Borough Hall and via Zoom.

Council President Lee read the statement re: Open Public Meetings Act of 1975 and that adequate notice has been provided by transmitting the Resolution of Annual Meetings to the Asbury Park Press and the Coast Star, by posting it in the Borough Hall on a bulletin board reserved for such announcements, and by posting it on the official website of the borough.

Council President Lee stated that zoom meetings are a courtesy and that there is an issue with the audio coming in from the participants on zoom. He advised that there will be no comment from the participants on zoom because of the issue with the audio.

Council President Lee welcomed the audience and invited them to join in a moment of silent prayer and a salute to the Flag.

ROLL CALL: Present: Council Members Bruce Bresnahan, Brian Holly, Jeff Lee, Michael Mangan, Gregg Olivera, and Lori Triggiano.

Also present was Borough Attorney Mark Kitrick and Borough Administrator Thomas Flarity.

Council Member Triggiano made a motion to remove the engineer's report from the agenda, seconded by Council Member Mangan. Motion carried unanimously.

Audience Participation

Council Member Triggiano made a motion to open the meeting to the public on agenda items, seconded by Council Member Bresnahan. Motion carried unanimously.

There being no comment Council Member Holly made a motion to close the public portion, seconded by Council Member Olivera. Motion carried unanimously.

Approval of Minutes

Council Member Bresnahan made a motion to approve the minutes, seconded by Council Member Holly. Motion carried unanimously.

Municipal Beautification - Discussion

Council Member Holly stated that he has reached out to the Sea Lavender Club and others within the community to try and do a better job around town bringing more plant material in. He stated that he has noticed a lot of hardscapes, macadam sidewalks but there really is not a downtown that sparks. He wanted to try and budget for some beautification around town and start a beautification committee and wants to take a more formalized approach to the downtown area, parks, and beach area. He stated that there is discussion about the South Street parking lot where some trees were taken down, the sign being in disrepair and beautifying that area and the parking lot. He wanted to bring this forward to the Mayor and Council to see if this is something to move forward with.

Council Member Mangan applauds the idea and thinks it is great. He stated that there are a few different ways to get this done. He stated that it is important to get the council onboard with this direction. He stated that there is room in the budget for small projects like this which can be discussed at the budget meetings.

Council Member Olivera is in favor of this beautification project and believes that some falls on recreation, open space, environmental, public works, finance, beach and code. He stated a cross functional committee with people from public works and potential recreation and someone from finance committee would be a good start.

Council Member Triggiano and Council Member Bresnahan agree with what previous council members stated and are onboard with this beautification committee and project.

Council Member Holly stated that the plaza could use a really nice landscape or possibly add another gazebo in the center and have a better presence of trees and shrubs.

Council Member Olivera confirmed that this committee will bring in residents for their input similar to the Citizen Advisory Committee is organized.

Council Member Mangan stated that an ad hoc committee from the council can steer it which possibly would include Council Member Holly from public works, Council Member Olivera from finance and himself from recreation. He stated that if there is authorization tonight a committee meeting can take place to start and hammer out details for the next council meeting and come back with more information and thoughts.

Code and Land Use Committee – Council Member Triggiano reported on the permits that were issued through the zoning/construction department and she reported on the warnings and summonses that were issued.

Administration and Finance Committee – Council Member Olivera stated that he does not have anything to report at this time.

Recreation Committee – Council Member Mangan welcomed Chief Tumminelli to his first council meeting. He reported on the fieldhouse and advised that it is up and running with lots of borough events. He stated that recreation will be doing a follow up presentation to the one that was done at the end of the year, and he is looking at that the end of February to update the year end numbers.

Public Safety Committee – Council Member Lee thanked Chief Tumminelli and congratulated him on his appointment to chief. He reported that the surrounding towns have been experiencing recent attempts of theft from motor vehicles. He stated that the police department would like to remind citizens to lock the doors of the vehicles and remove any valuable items and also if you see suspicious activity please call the police department. He went over the police officer recruits that started at the Monmouth County Police Academy to become Special II officers for this upcoming summer. He reminded citizens of the ordinance that requires all vehicles to be removed from the roadway when there is enough snow accumulation that requires plows to be on the road. He stated that the Borough has received their StormReady Certification which gives a certification through 2026 which adds to our annual CRS rating and insurance premium discount. He stated that there are only 18 municipalities in New Jersey that have qualified for this designation.

Public Works and Construction Committee - Council Member Holly welcomed Chief Tumminelli and stated he is looking forward to working with him. He thanked everyone involved in getting the Borough through the CRS designation. He reported on the new park and how well it is being used and the last phase of the project. He went over Euclid and Mount Lane repairs.

Beach Committee — Council Member Bresnahan welcomed Chief Tumminelli and reported on the bathrooms at the beach and that the Main Street bathrooms will remain open from sunrise to sunset. He reported that the playground at Sea Watch is being worked on and is hoping that it will be repaired by summer. He reported that the Brielle Road bathrooms are being looked into and the Inlet building will need the second floor finished to house the lifeguards when a storm rolls in. He reported that according to the State there needs to be 3 buildings that the lifeguards can go when a storm rolls in which would be Sea Watch, Main Beach and the Inlet buildings.

Audience Participation

Council Member Olivera made a motion to open the public portion, seconded by Council Member Mangan. Motion carried unanimously.

Shane O'Boyle, 41 Fisk Street inquired about a height difference between residential and commercial buildings in town and why.

Council Member Mangan stated that there are different heights set and advised that the zoning map would show what zone every property in Manasquan is in and each zone has its own limits for height depending on what type of building it is. He stated that is how it is done in New Jersey where local towns decide what zone rules are which includes how big the building can be, how much of the property you can cover as well as height of the buildings. He went over the reasons for changing the height of buildings after Superstorm Sandy.

Nancy Jordan, 261 Euclid Avenue voiced her support for beautification in the borough. She stated that the Sea Lavender Garden Club is entering 30 years of service to the community with 124 members and 48 members actively involved in their gardens. She stated that participation in the beautification of the borough is important, and the borough should look into getting some funding from the State.

Ron Jacobson, 59 McClean Avenue voiced his concern about the CVS project and the tracking of mud and dirt onto the street.

Council Member Mangan made a motion to close the public portion, seconded by Council Member Holly. Motion carried unanimously.

Council Member Triggiano made a motion to close the regular meeting at 7:36 p.m., seconded by Council Member Holly. Motion carried unanimously.
