Council Member Read made a motion to open the meeting the public, seconded by Council Member Mangan. Motion carried unanimously.

Dick Meincke 36 M. McClellan inquired about the committee reports.

Council Member Mangan made a motion to close the meeting to the public, seconded by Council Member Walsh. Motion carried unanimously.

Council Member Mangan made a motion to amend the agenda to include committee reports and to include a second audience portion, seconded by Council Member Walsh. Motion carried unanimously.

Committee Reports

Public Works Committee – Council Member Walsh reported that he will be working with the code department to enforce the tree ordinances. He stated that he has not been able to meet with the Sea Lavender Garden Club but the plan is to increase their budget.

Administration Committee – Council Member Read reported on the boat slip rentals and advised that there are 18 slips available for the lottery which closes on Thursday. He reported that a survey will be going out to get input from the boaters to better serve them. He also reported on the program that the borough has regarding reporting a concern which is located on the front page of the website. He reported on the new registrar fees and that the borough should be receiving more money as compared to last year.

Beach & Recreation Committee – Council Member Mangan advised that everyone is working on the budget and one of the big things to fund with the 2020 budget is the start of the parks improvement plan which would be a sustainable plan. He also reported that the borough is working on a DEP permit for the beach, employee appreciation programs, improvements to junior guard program, parking lot meters, Sea Watch property improvements, and the Main Beach building repairs.

Public Safety Committee – Council Member Lee reported that budget review is under way with capital expenditures, vehicle maintenance plan, looking for ways to support first aid, and improvement on N. Main Street crosswalk. He thanked Administrator Flarity for his guidance with the courts and trying to alleviate the crowds in the hallway during court days. He stated that he was very impressed with a program led by Council Member Bryant "The Voice of Democracy" for the high school students. He went over the award to Officer Smith who was awarded officer of the year by the Manasquan VFW. He went over an event that occurred here at Borough Hall where Officer Smith helped a 98 year old World War II veteran to help the veteran get the necessary help. He advised that Detective Lt. Greg Restivo and Detective Ken Hamill will start a 4 day class on interviewing and interrogation techniques which is being hosted at Rutgers.

Code & Zoning Committee — Council Member Bryant reported on the VFW Veterans of Foreign Wars Citizen Award luncheon where Sergeant Keith Smith was recognized as was the Mayor for Citizen of the Year, Fire Fighter of the Year was Tom Schofield, and reported on the students that placed from the elementary and the high school. He also advised of students who have moved on to the State and the Teacher of the Year Andrea Trischita. He reported on the code/construction numbers for February. He stated that they will be reviewing fees for possible changes in the upcoming months.

Mangan - reported that parking passes can be purchased through Community Pass starting April 1 with a limited amount of parking passes available for purchase online and in person purchase will start April 13 at St. Denis. He went over the hours of sale for pre-season and pick up instructions.

Administration Committee – Council Member Read congratulated the high school boys' basketball team as they won the shore conference championships over Toms River North 75 to 49. He stated that this is the first time since 1957. He reported that the high school hockey team is 3 time Dowd champions.

Audience Participation

Council Member Read made a motion to open the meeting to the public, seconded by Council Member Mangan. Motion carried unanimously.

Mary Ryan, 113 Beachfront thanked everyone for their work. He thanked Council Member Read for highlighting the Report a Concern program on the website. She inquired about the tug boats and the cranks in the river.

Mayor Donovan stated this is not a borough project and he is not sure of what they are doing. He believes they are staging there and there might be some dredging further north. He believes it would be the Army Corp of Engineers running this project.

Ms. Ryan inquired about the beach and DPW departments being merged.

Council Member Mangan advised that the two departments are not merged and he was just thanking both departments for getting the beaches ready.

Ms. Ryan inquired about Erik Ertle overseeing the DPW working on the beach in the winter time.

Council Member Mangan stated that there is an agreed upon list of maintenance items that will be done by DPW. He stated that the Beach and DPW are working together on beach items.

Ms. Ryan thanked Jay for his involvement with the VFW program.

Jeff Eirich, 76 N. Main Street thanked council for their efforts with the issues with the new high school fields.

Dick Meincke, 36 N. McClellan inquired about the beach meters and if it will affect the Inlet parking. Council Member Mangan stated that they are looking into pay stations for the parking lots only.

Mary Ryan, 113 Beachfront inquired about the 98 year old veteran who came to the police station for help. She recommended the Coast Star do a story on this.

Council Member Lee made a motion to close the public portion, seconded by Council Member Mangan. Motion carried unanimously.
