The Manasquan Planning Board held an in person and zoom special meeting on January 24, 2023 at 4:00 pm with Chairman Neil Hamilton presiding.

Mr. McGill swore in Peter Sanquini and Al Yodakis

Mr. Sanquini stated that after the discussions of the last meeting one of the items that was discussed was the removal of the storage area on the east side next to the garage and expand the storage space in the rear to go in line with the deck. He stated that he has done that and revised the drawings to make those changes as requested. He stated that the roof over the deck will be a modification that will done.

Mr. Apostolou inquired about the siding being different.

Mr. Sanquini stated that there will be no siding change in the plans and will be the same siding as the front of the structure.

Mr. Yodakis stated that the applicant made all the changes that were requested of them and that is going to bring their building coverage down to 31.95% and recommends that the board approve 32%. He stated that the variances that are being requested are the building coverage at 32% and a rear yard setback of 21.55'
