SECTION 1: Chapter 2 entitled Administration of the Revised General Ordinances of the Borough of Manasquan and Section 2-5.20 entitled Standing Committees is amended and shall read as follows:

2-5.20 Standing Committees Designated

The following standing committees of the Council, consisting of three (3) council members each shall be appointed as follows.

- a. Administration
- b. Shared Services and Grants
- c. Land Use
- d. Public Safety
- e. Public Property
- f. Community Services

SECTION 2: Chapter 2 entitled Administration of the Revised General Ordinances of the Borough of Manasquan, and Section 2-5.26 Administration Committee, Section 2-5.27 Shared Services and Grants Committee, Section 2-5.28 Land Use, Section 2-5.29 Public Safety Committee, Section 2-5.30 Public Property Committee, and Section 2-5.31 Community Services Committee is amended and shall read as follows:

2-5.26 Administration Committee

The Administration Committee shall have primary responsibility for the following described activities and matters:

This committee will oversee matters related to borough operations, budgeting, and personnel management.

2-5.27 Shared Services and Grants Committee

This committee will explore collaborative opportunities with neighboring jurisdictions, as well as seeking and managing grants to maximize resources to efficiently fund borough projects.

2-5.28 Land Use Committee

This committee will be responsible for reviewing and making recommendations on zoning, land development, and planning initiatives to support sustainable growth and development within the borough.

2-5.29 Public Safety Committee

This committee will oversee matters related to law enforcement, emergency services, and community safety and will work to enhance and promote public safety measures.

2-5.30 Public Property Committee

This committee will manage and maintain public facilities, parks, and infrastructure projects to uphold the quality of borough-owned properties.

2-5.31 Community Services

This committee will be responsible for enriching the quality of life for Borough residences by overseeing recreational programs, social services, and cultural initiatives that strengthen community bonds.

Any construction of a new home or an addition of 500 square feet or greater shall plant two (2) shade trees on their property or provide five hundred dollars (\$500.00) per tree to the Municipal Tree Escrow Fund.
