**Resolution Expressing Support for Legislation  
Increasing State Funding to The “Shore Protection  
Fund” from \$25 Million to \$50 Million(A-639/S-1071)**

**WHEREAS**, the State of New Jersey maintains the Shore Protection Fund, which was established in 1992; and

**WHEREAS**, the Shore Protection Fund provides important funding that allows the State and Municipalities to engage in cost-share partnerships with the U.S. Army Corps of Engineers on shore protection projects including beach restoration and maintenance; and

**WHEREAS**, the Shore Protection Fund is funded by State Realty Transfer Fee revenues, and is currently capped at \$25 million, an amount that was last adjusted in 1999; and

**WHEREAS**, following the devastating effects of Superstorm Sandy, it has become evident that the current funding to the Shore Protection Fund is inadequate for allowing the State and Municipalities to fund necessary recovery projects; and

**WHEREAS**, pending before the Legislature are bills A-639 and S-1071, which would increase the cap on funding to the Shore Protection Fund to \$50 million; and

**WHEREAS**, the Township Committee believes this proposed increase to the Shore Protection Fund is essential to protecting the shoreline of the Borough of Manasquan and that of every other Shore Community compromising the Jersey Shore.

**NOW, THEREFORE, BE IT RESOLVED** by the Borough of Manasquan, County of Monmouth, State of New Jersey, that it hereby expresses its support for an increase in funding to the Shore Protection Fund from \$25 million to \$50 million, as provided in the bills pending before the New Jersey Legislature as A-639 and S-1071.

**RESOLUTION IN SUPPORT OF THE MONMOUTH  
COUNTY PARK SYSTEM'S COASTAL AREA  
FACILITY REVIEW ACT (CAFRA) COASTAL  
GENERAL PERMIT APPLICATION TO THE NEW  
JERSEY DEPARTMENT OF ENVIRONMENTAL  
PROTECTION FOR THE FISHERMAN'S COVE  
CONSERVATION AREA HABITAT RESTORATION  
PROJECT**

**WHEREAS**, the Fisherman's Cove Conservation Area is a 55 acre wildlife preserve at the mouth of the Manasquan River on the Manasquan Inlet acquired by the Park System in 1995; and

**WHEREAS**, the Fisherman's Cove Conservation Area is an integral part of the Manasquan community providing a great place to fish, sunbathe, walk on the beach, play with your dogs; and is used by kayakers, fishermen, and wildlife enthusiasts; and

**WHEREAS**, the Fisherman's Cove Conservation Area has habitat areas consisting of tidal communities of mud flat, low salt marsh dominated by smooth cordgrass, and high salt marsh of salt meadow cordgrass and other habitat areas consisting of upland dune communities of beachgrass, bayberry, and tide bush, and an interior maritime shrub forest of black cherry, red cedar, and American holly; and

**WHEREAS**, the designation of Fisherman's Cove as a Conservation Area requires that the area be used for the protection and enhancement of valuable natural resources of County significance with development limited to low impact uses to support the enhancement of nature-oriented outdoor recreation; and

**WHEREAS**, Conservation Areas enhance the regional quality of life, public health, and public safety by improving water quality, protecting groundwater, preventing flooding, improving the quality of the air we breathe, providing vegetative buffers to development, and supporting habitats for wildlife; and

**WHEREAS**, the Monmouth County Park System has developed a plan for habitat restoration and enhancement because of the great value of establishing as close to a native coastal habitat as possible at Fisherman's Cove Conservation Area; and

**WHEREAS**, the Monmouth County Park System is required to obtain a CAFRA Coastal General Permit for the planned habitat restoration and enhancement; and

**WHEREAS**, the value of habitat restoration would come from not only the oasis for recreation and nature appreciation, it would equally be available refuge and stop-over for many coastal and migratory species that have fewer and fewer acres to utilize along the developed coastline; and

**WHEREAS**, the site has existing elements of salt marsh and coastal dune communities and these elements have great potential for restoration and/or enhancement. There is potential to restore back dune and maritime forest communities in the interior of the site and these elements would add to the diversity and habitat value; and

**WHEREAS**, an integral part of the restoration plan is the relocation of the summer-time over-flow beach parking area from its current location west of the Pompano Avenue Right-of-Way parking area to an area to the south of the Pompano Avenue Right-of-Way parking area; and

**WHEREAS**, the County shall, at its own expense, construct this new summer-time over-flow beach parking area to the south Pompano Avenue Right-of-Way parking area in accordance with the intent of the original 1994 Agreement Concerning Fisherman’s Cove; and

**WHEREAS**, the County shall construct this summer-time over-flow beach parking area to include beach parking for up to 400 vehicles in accordance with the intent of the original 1994 Agreement Concerning Fisherman’s Cove; and

**WHEREAS**, the County shall construct this summer-time over-flow beach parking area out of non-impervious surface materials in order to enhance the regional quality of life, public health, and public safety by improving water quality, protecting groundwater, and preventing flooding; and

**WHEREAS**, the relocation of the summer-time over-flow beach parking area will provide enhanced vegetative buffers to the surrounding development;

**NOW, THEREFORE, BE IT RESOLVED** that the Borough of Manasquan fully supports the Monmouth County Park Systems CAFRA Coastal General Permit Application to the New Jersey Department of Environmental Protection for the Fisherman’s Cove Conservation Area Habitat Restoration Project; and

**BE IT FURTHER RESOLVED** that the Borough of Manasquan requests that the New Jersey Department of Environmental Protection look favorably upon the application of the Monmouth County Park System for a CAFRA Coastal General Permit for the Fisherman’s Cove Conservation Area Habitat Restoration Project; and

**BE IT FURTHER RESOLVED** that the Borough of Manasquan supports the preliminary design of the Monmouth County Park System for the relocation of the summer-time over-flow beach parking area from its current location west of the Pompano Avenue Right-of-Way parking area to an area to the south of the Pompano Avenue Right-of-Way parking area per the attached map.

**ORDINANCE AMENDING SECTIONS 22-3 (WATER AND SEWER USAGE CHARGE) OF CHAPTER 22, WATER AND SEWER UTILITY OF THE REVISED GENERAL ORDINANCES IN ORDER TO INCREASE WATER AND SEWER RATES AND USAGE CHARGES IN THE BOROUGH OF MANASQUAN, COUNTY OF MONMOUTH, STATE OF NEW JERSEY**

**BE IT ORDAINED**, by the Borough Council of the Borough of Manasquan, in the County of Monmouth and State of New Jersey, as follows:

**SECTION 2:** Section 22-3 (Water and Sewer Usage Charge) of Chapter 22 (Water and Sewer Utility) of the Revised General Ordinances of the Borough of Manasquan is amended as follows:

- a. The charge for water and sewer usage shall be \$4.48 per 1,000 gallons or part thereof.
- b. The charge for water usage only shall be \$2.24 per 1,000 gallons or part thereof.
- c. The charge for sewer usage only shall be \$2.24 per 1,000 gallons or part thereof.
- d. Water and sewer usage shall be measured by the number of gallons of water use shown on the water meter.
- e. Any user found to be receiving water service that is not being metered shall be charged at the rate of \$2.24 per day.

**SECTION 3:** All ordinances or parts thereof inconsistent with the provisions of this ordinance are hereby repealed as to such consistency.

**SECTION 4:** If any section, paragraph, subdivision, clause or provision of this ordinance is adjudged to be invalid, such adjudication shall apply only to the section, paragraph, subdivision, clause or provision so adjudged and the remainder of this ordinance shall be deemed valid and effective.

**SECTION 5:** This ordinance shall become effective April 8, 2020 following its final passage and publication according to law.
