#### CITY OF MARSHALL CITY COUNCIL MEETING M I N U T E S Tuesday, February 13, 2024

The regular meeting of the Common Council of the City of Marshall was held February 13, 2024, at City Hall, 344 West Main Street. The meeting was called to order at 5:30 P.M. by Mayor Robert Byrnes. In addition to Byrnes the following members were in attendance: Craig Schafer, Amanda Schroeder, John Alcorn, See Moua-Leske and Steve Meister and James Lozinski. Absent: None. Staff present included: Sharon Hanson, City Administrator; Pamela Whitmore, City Attorney (via Zoom); Jason Anderson, Director of Public Works/ City Engineer; E.J. Moberg, Director of Administrative Services; Jim Marshall, Director of Public Safety; Scott Truedson, Wastewater Superintendent; Ilya Gutman, Plans Examiner; Quentin Brunsvold, Fire Chief; and Steven Anderson, City Clerk.

Members of the Rental Ordinance Committee were in attendance that included John Decramer, Mark Klaith and Jessica Bently.

#### Consider Approval of the Minutes from the Regular Meeting Held on January 23rd

There were no requests to amend the minutes from January 23<sup>rd</sup>.

Motion made by Councilmember Schafer, Seconded by Councilmember Schroeder to approve the minutes as presented. Voting Yea: Councilmember Schafer, Councilmember Meister, Councilmember Schroeder, Councilmember Alcorn, Councilmember Moua-Leske, Councilmember Lozinski. Voting Abstaining: Mayor Byrnes. The motion Carried 6-0-1.

#### Public Hearing and Consideration of Adoption of Article 18-VIII Residential Rental Code

Attorney Whitmore summarized the recent history of the rental code. In January 2023, the city considered a proposed rental ordinance which met push back from the community. The Council decided to not act on the proposed ordinance in January 2023, and directed staff to start a process for creation of a Rental Committee. The City Attorney drafted a registration-based ordinance for review and feedback from the Rental Committee once formed. The Rental Committee met five times to review the newly drafted ordinance – June 13, July 11, August 8, October 10, and October 31. The Rental Committee was made up of representatives of city staff, fire department, council, tenant advocates and landlords and was facilitated by John Decramer and Mark Klaith. The Committee participants included Zachary Gilman, James Carr, Brad Meulebroeck, Shawn Butler, Jessica Bentley, Angela Larson, Quentin Brunsvold, Steven Anderson, Jason Anderson, Sharon Hanson, Craig Schafer, and James Lozinski. The Rental Committee engaged in thoughtful and thorough discussion regarding the goals of the city, the interests of the community and the protections of the public. These discussions led to productive collaboration and revisions. On October 31, 2023, the Rental Committee approved, by unanimous vote, to recommend the residential rental registration ordinance. Attorney Whitmore suggested that if a motion were to be made that the term bi-annual be stricken and replaced with biennial. Bi-annual could mean twice in one year or every two years, and the intention of the committee was for registration to occur on even numbered years.

John Decramer, co-chair of the Rental Ordinance Committee, spoke about how the rental code was not a new concept to the City of Marshall. Various council members from at least the past five years have worked on or considered a rental ordinance. Mark Klaith, the other co-chair of the Rental Ordinance Committee, said the ordinance was for landlord and tenants to cooperate first and then bring in city staff for incompliance with city codes. As former Fire Chief, Klaith expressed that he wished the ordinance had more teeth to it than just registration, but it was a good start. Marta Faulkner, a tenant, spoke about her experiences and the conditions of her apartment complex. Curt VanMeveren, a landlord, also spoke about his experiences and asked various questions about the ordinance. Jody Arcand expressed concerns she had with management at Halter Villa Apartments.

Motion made by Councilmember Meister, Seconded by Councilmember Schafer to close the public hearing. Voting Yea: Mayor Byrnes, Councilmember Schafer, Councilmember Meister, Councilmember Schroeder, Councilmember Alcorn, Councilmember Moua-Leske, Councilmember Lozinski. The motion **Carried. 7-0.** 

Motion made by Councilmember Schafer, Seconded by Councilmember Moua-Leske to adopt Ordinance 24-003 Residential Rental Code. Voting Yea: Mayor Byrnes, Councilmember Schafer, Councilmember Meister, Councilmember Schroeder, Councilmember Alcorn, Councilmember Moua-Leske, Councilmember Lozinski. The motion **Carried. 7-0.** 

Motion made by Councilmember Meister, Seconded by Councilmember Moua-Leske to approve Resolution 24-016 amending the 2024 fee schedule to add rental registration fees and penalties. Voting Yea: Mayor Byrnes, Councilmember Schafer, Councilmember Meister, Councilmember Schroeder, Councilmember Alcorn, Councilmember Moua-Leske, Councilmember Lozinski. The motion **Carried. 7-0.** 

#### Public Hearing for an Ordinance Amending the City Charter

Attorney Whitmore provided a general overview of the proposed changes to the city charter:

- Deleted his/her, he/she and him/her preferred personal pronouns in favor of titles or nongendered pronouns.
- Amend existing language to comply with statutory changes related to special election dates.
- Amend existing language to clarify timing of council resignations and how to proceed if there is a tie on an appointment.
- Amend language regarding process and requirements for redistricting of wards to comply with statutory changes.
- Amend language regarding voting requirements if a member of the decision-making body joins the meeting remotely via interactive technology to comply with recent statutory changes.
- Adding language to provide the Council with authority to create a table for non-substantive ordinances, not of a general or permanent nature, that are not otherwise codified in code.
- Amend language of 5.02, expenditures for Petitioners, to comply with requirements set forth in a United States Supreme Court decision to allow hiring of individuals to go door to door to try to get signatures on a petition but to still prohibit paying individuals people to sign the petition.
- Adding language to Section 7.01 to clarify that Council may, through adoption of policy, create authority for the City to identify and expend funds on expenditures that benefit the community as a whole; are directly related to governmental functions; and primarily benefits the public interest (not private interest). This allows the city more flexibility to promote and support its community.

Councilmember Schroeder who served on the Charter Commission said the commission members all agreed that it was good that the charter was being updated to comply with state laws.

Motion made by Councilmember Lozinski, Seconded by Councilmember Alcorn to close the public hearing. Voting Yea: Mayor Byrnes, Councilmember Schafer, Councilmember Meister, Councilmember Schroeder, Councilmember Alcorn, Councilmember Moua-Leske, Councilmember Lozinski. The motion **Carried. 7-0.** 

Motion made by Councilmember Schafer, Seconded by Councilmember Schroeder to adopt Ordinance 24-004 amending the City of Marshall charter. Voting Yea: Mayor Byrnes, Councilmember Schafer, Councilmember Meister, Councilmember Schroeder, Councilmember Alcorn, Councilmember Moua-Leske, Councilmember Lozinski. The motion **Carried. 7-0.** 

# Vacation of Alley and Utility Easement in Schwan's Corp I Addition - 1) Public Hearing on Resolution Granting Petition; 2) Consider Resolution Granting Petition for Vacation

Jason Anderson informed the council that a petition was received for the vacation of an alley and a utility easement between Lot One and Lot Two, Block Three of Schwan's Corp I Addition. The petition was for the location of the future aquatic center site at the corner of Saratoga and College Drive. All utility companies were contacted regarding the vacation and only Bluepeak responded that they have facilities in the easement area. Bluepeak indicated that a plan was in place to relocate the facilities in 2024. Motion made by Councilmember Schafer, Seconded by Councilmember Schroeder to close the public hearing. Voting Yea: Mayor Byrnes, Councilmember Schafer, Councilmember Meister, Councilmember Schroeder, Councilmember Alcorn, Councilmember Moua-Leske, Councilmember Lozinski. The motion **Carried. 7-0.** 

Motion made by Councilmember Schafer, Seconded by Councilmember Alcorn to approve Resolution 24-017 Granting Petition for Vacation of an Alley and Utility Easement. Voting Yea: Mayor Byrnes, Councilmember Schafer, Councilmember Meister, Councilmember Schroeder, Councilmember Alcorn, Councilmember Moua-Leske, Councilmember Lozinski. The motion **Carried. 7-0.** 

#### Project AP-003: Airport Snow Removal Equipment (SRE) Building – Consider Award of Contract

Director Anderson said that in 2023 this project had originally been bid out and came in overestimate and was rejected. The existing building did not adequately accommodate all airport maintenance equipment storage needs, therefore the city contracted TKDA the engineering firm that did the original bid to rework the project and come up with a new bid proposal. The new facility was planned to be constructed on the East Building Area of the airport which would be on Madrid Circle. The Project had been identified on the Airport CIP since FFY2011. Bids were received on 01/23/2024 and five bids were received with Sussner Construction, Inc. of Marshall being the low responsive bid. The SRE Building project was presented to the Airport Commission at their meeting on 02/06/2024 and the Airport Commission recommended unanimously to award the contract to Sussner Construction, Inc., including the bid alternate for landscaping, for \$2,913,100.00. Cost share was identified in TKDA's recommendation letter and was estimated at \$646,911.92 for the City of Marshall's local share. The local share included engineering fees for construction project administration. Councilmember Lozinski mentioned that the city council had rejected the bids from last year and the project had now become considerably cheaper. Councilmember Schafer echoed the sentiments of Councilmember Lozinski and commented that a new tenant at the airport had started construction of a hanger that would be located next to the proposed site of the proposed SRE building.

Motion made by Councilmember Lozinski, Seconded by Councilmember Schafer to award the contract of Project AP-003 to Sussner Construction. Voting Yea: Mayor Byrnes, Councilmember Schafer, Councilmember Schroeder, Councilmember Alcorn, Councilmember Moua-Leske, Councilmember Lozinski. Voting Nay: Councilmember Meister. The motion **Carried. 6-1**.

#### Mayor Byrnes at 6:28 PM called for a short recess and at 6:33 PM resumed the meeting.

#### <u>Project WW-005: Highway 23 Lift Station Improvements Project – 1) Phase III Pump Selection; 2) Consider</u> Authorization to Advertise for Bids for Wastewater Highway 23 Lift Phase IV Wet Well Renovation

Scott Truedson presented the request for Project WW-005. At the May 9, 2023, meeting the City Council rejected the single bid for the Highway 23 Lift Station Improvement Project and adapted a four-phase plan for the improvements. Phase I consisted of installing new VFD drives and a new transfer switch. At the July 11, 2023, meeting the City Council approved the wastewater department to purchase two Flygt pumps for Phase II of the Highway 23 Lift Station Improvements Project. Phases I & II were completed in 2023. Phase III of the project was to purchase the remaining two pumps for the lift station. The Wastewater Department had received an updated quote from the local Flygt pump supplier, Electric Pump, for 2024 and the cost of the pumps had been held to the same price as the pumps that were purchased in 2023.

Phase IV would consist of:

- Removal of the four existing submersible pumps, wet well piping and guide rails.
- Renovation of wet well structure with concrete repairs as needed, and new coating system.
- Installation of the four new pumps supplied by the city.
- Installation of new piping in the wet well structure.
- Bypassing pumping of the lift station while renovations work is being completed.

Motion made by Councilmember Lozinski, Seconded by Councilmember Meister to authorize purchase of two Flygt pumps for \$100,994.00. Voting Yea: Mayor Byrnes, Councilmember Schafer, Councilmember Meister, Councilmember Schroeder, Councilmember Alcorn, Councilmember Moua-Leske, Councilmember Lozinski. The motion. **Carried. 7-0.** 

Motion made by Councilmember Lozinski, Seconded by Councilmember Meister to authorize advertisement for bids for Phase IV of the Highway 23 Lift Station Wet Well Renovation Project. Voting Yea: Mayor Byrnes, Councilmember Schafer, Councilmember Meister, Councilmember Schroeder, Councilmember Alcorn, Councilmember Moua-Leske, Councilmember Lozinski. The motion **Carried. 7-0.** 

#### <u>Project AP-003: Airport Snow Removal Equipment (SRE) Building – TKDA Professional Services Agreement-</u> <u>Construction Phase</u>

Director Anderson explained the professional services agreement with TKDA for the Airport SRE Building Construction Phase. The agreement will cover TKDA services to help administer the construction of the SRE Building and ensure compliance will all plans and specifications. The Airport Commission recommended at their February 6, 2024, meeting to enter into the agreement with TKDA. The cost of construction phase and closeout phase was not to exceed \$280,200 for services identified in the scope. Costs would follow the funding split that was identified for the SRE Building with local costs estimated at \$39,277.40 for the services with the rest being covered by State and Federal funding. Councilmember Lozinski questioned if under this contract would TKDA essentially become the construction manager for the project. Director Anderson confirmed that TKDA would oversee the project and work closely with the construction companies, but the city engineering department would be still involved. Motion made by Councilmember Schafer, Seconded by Councilmember Alcorn to authorize the professional services agreement with TKDA for the SRE Building construction phase for an amount not to exceed \$280,200 and contingent upon State and Federal grant funding. Voting Yea: Mayor Byrnes, Councilmember Schafer, Councilmember Meister, Councilmember Schroeder, Councilmember Alcorn, Councilmember Moua-Leske, Councilmember Lozinski. The motion **Carried. 7-0.** 

#### Instrument Landing System (ILS) Replacement at the Airport - TKDA Professional Services Agreement

In January 2023, the city received a letter from MnDOT regarding the replacement of the Instrument Landing System (ILS) at the Municipal Airport, which was owned by MnDOT. The ILS is a radio navigation system that provides shortrange guidance to aircraft and allows them to approach a runway at night or in poor weather conditions. The ILS system has reached a point where the manufacturer would no longer service and repair equipment, and MnDOT would like to replace our system as soon as they are able. The project requires City participation, and the city is responsible for civil sitework and building costs, while MnDOT is responsible for covering the costs of the ILS equipment. In 2023, the city was asked by MnDOT to send a grant request letter for a civil site work construction project. Following Council authorization at the February 14, 2023, meeting, city staff submitted a grant request letter for a project. MnDOT never responded to the grant request and now a year later MnDOT is ready to proceed with the project. The first step to moving the project forward was to authorize an engineering contract with TKDA for engineering design services. With City Council authorization, city staff would submit again to MnDOT for a grant to help cover costs. The Airport Commission at their meeting on February 6, 2024, voted unanimously to recommend approval of the agreement with TKDA to the City Council. City staff anticipated a 70-30 cost split with MnDOT, resulting in a local cost of \$28,320. The 2024 capital budget included the ILS project at a total cost of \$1,000,000, with \$300,000 included for local costs. Some of the equipment was already on hand from MnDOT and was being stored at the Municipal Airport for Marshall and other airports around the state.

Motion made by Councilmember Meister, Seconded by Councilmember Schafer to approve the professional services agreement with TKDA for the ILS Replacement project at the airport for an amount not to exceed \$94,400 and contingent on MnDOT grant funding. Voting Yea: Mayor Byrnes, Councilmember Schafer, Councilmember Meister, Councilmember Schroeder, Councilmember Alcorn, Councilmember Moua-Leske, Councilmember Lozinski. The motion **Carried. 7-0.** 

#### Consider Adoption of an Ordinance Amending Interim Cannabis Prohibition

The City adopted Ordinance 23-015 on July 27,2023 to allow the City Council time to study and consider adoption or amendment of reasonable restrictions on the operation or location of commercial businesses related to cannabinoid products, including retail stores in the City of Marshall offering Cannabis products, and Lower-Potency Hemp products, for the purpose of protecting the planning process and the health, safety, and welfare of the public. Commercial businesses involved with limited manufacturing, and the transporting, or delivery and distribution of infusion based lower potency hemp beverages did not pose a risk to the health, safety and welfare of the public since the operation of those businesses do not result in an introduction of THC related intoxicating products for off sale use by the public within the City of Marshall. Commercial businesses involved in testing, manufacturing, transporting, or delivery and distribution of lower potency hemp edibles and hemp-derived consumer products would not result in increased exposure or availability of these intoxicating products to youth in the community. Opportunities existed for commercial businesses in the City to provide services involving the manufacturing, transporting, or delivery and distribution of lower potency hemp beverages; and that opportunities existed for commercial on-sale liquor licensed establishments to sell lower potency hemp beverages on their premises, all of which will benefit commerce in the City. The Legislative and Ordnance Committee met on January 9, 2024, and recommended that registration fees be waived during 2024 and a fee/registration process begin in 2025.

Motion made by Councilmember Meister, Seconded by Councilmember Moua-Leske to adopt Ordinance 24-002 Amending the Interim Cannabis Prohibition to allow the manufacture of THC beverages by brewers and distilleries, and to allow on-site consumption of THC beverages for holders of an on-sale intoxicating liquor license issued by the city. Voting Yea: Mayor Byrnes, Councilmember Schafer, Councilmember Meister, Councilmember Schroeder, Councilmember Alcorn, Councilmember Moua-Leske, Councilmember Lozinski. The motion **Carried. 7-0.**

- (b) Every vehicle used to collect garbage, refuse, or recyclable shall have the name of the owner or operator and the city license number under which it is being operated on the body of the vehicle, or on a durable metal or wood plaque which shall be fastened to the body, at all times when the vehicle is used for collecting garbage, refuse, or recyclable.
- (c) All licensed haulers shall provide to the city at the city's request, a list of all names and addresses of all their customers within the city.

Background Information:	Attached please find a copy of the preliminary plat of Channel Parkway Addition in Marshall, Minnesota.
	The Economic Development Authority has been working with the Southwest West Central Service Cooperative (SWWC) to determine a new location for the agency's administrative offices. The SWWC is currently located in the former Market Street Mall and has explored several relocation and redevelopment opportunities. It was determined that a new facility would best meet the needs of the organization, including the addition of training facilities for staff and the community. SWWC's proposal includes the construction of a 16,000 sq ft facility on the city-owned property located in Parkway at the corner of London Road and Channel Parkway. SWWC employs 459 people with 52 staff on-site in Marshall with an 18-county service area. SWWC supports schools, cities, counties and government agencies with educational and administrative services including learning centers, special education services, enrichment programming, professional
	development, technology services, and more. The property that is being considered for development is located at the intersection of Channel Parkway and London Road. Creation of a parcel for this proposed development requires a platting process because this land has never been platted and City Ordinance requires land to be platted prior to the subdivision and sale of land.
	Attached please find a copy of the Engineer's Report of Preliminary Plat Review. Copies of the proposed subdivision have been sent to the local utility companies, and their requirements, if any, have been incorporated into the plat.
	Per adoption of Ordinance 23-024 on 11/14/2023, the public hearing on the preliminary plat is now conducted at the Planning Commission meeting instead of at the City Council meeting.
	At their meeting on 02/14/2024, Pieper made a motion, second by Agboola, to recommend approval of the preliminary plat of Channel Parkway Addition to the City Council, subject to utility companies review and recommendations. All voted in favor.

- 1. Finding that the project is in the public interest because it will encourage the growth of commerce and industry, prevent the movement of current or future operations to locations outside Minnesota, result in increased employment in Minnesota, and preserve or enhance the state and local tax base.

BE IT RESOLVED by the City Council of the City of Marshall, Minnesota (the "City" or "Issuer") as follows:

Section 1. <u>Recitals</u>.

WHEREAS, Minnesota Statutes, Sections 469.152-469.1655, as amended (the "Act"), authorizes the City to issue revenue bonds to finance, in whole or in part, the costs of the acquisition, construction, reconstruction, improvement, betterment, or extension of a project constituting any properties, real or personal, used or useful in connection with a revenue producing enterprise, whether or not operated for profit; and

WHEREAS, as a condition to undertaking the project and issuing revenue bonds under the Act, the City Council of the City must find that the project furthers the purposes stated in Section 469.152 of the Act and the Commissioner of the Minnesota Department of Employment and Economic Development ("DEED") must approve the project on the basis of preliminary information the Commissioner of DEED requires, as tending to further the purposes and policies of the Act; and

WHEREAS, prior to submitting an application to DEED requesting approval of a project, the City Council of the City must conduct a public hearing on the proposal to undertake and finance the project, and notice thereof, stating the time and place of the hearing, the general nature of the project and an estimate of the principal amount of bonds or other obligations to be issued to finance the project, and that a draft copy of the proposed application to DEED, together with all attachments and exhibits, will be available for public inspection, must be published at least once not less than 14 days nor more than 30 days prior to the date fixed for the hearing, in the official newspaper and a newspaper of general circulation of the City; and

WHEREAS, in order to issue the revenue bonds or other obligations as obligations the interest on which is not includable in gross income for federal income tax purposes, a public hearing must also be held in accordance with the requirements of Section 147(f) of the Internal Revenue Code of 1986, as amended (the "Code"), and Treasury Regulations promulgated thereunder (the "Regulations"); and

WHEREAS, Foundation for Innovation in Education, a Minnesota nonprofit corporation ("Borrower"), has requested that the City issue one or more series of revenue bonds, to be designated Public Project Lease Revenue Bonds (SWWC Service Cooperative Project), Series 2024 (the "Bonds") and loan the proceeds derived from the sale of the Bonds to Borrower, pursuant to the terms of a Loan Agreement between the City and Borrower (the "Loan Agreement"). Proceeds of the Bonds will be

applied by Borrower to the following purposes (collectively, the "Project"): (i) the acquisition, construction, and equipping of an approximately 16,100 square-foot facility (the "Facility") to be located at or about the intersection of Channel Parkway and London Road in the City of Marshall, Minnesota (the "Facility"); (ii) the funding of capitalized interest; and (iii) the payment of a portion of the costs of issuing the Bonds; and

WHEREAS, the Facility will be owned for federal tax purposes by the Borrower and will be leased to and operated by the Southwest West Central Service Cooperative ("Cooperative" or "SWWC"), a service cooperative and a public corporation and agency established pursuant to Minnesota Statutes, Section 123A.21, as amended (the "Cooperative Act"). SWWC was formed by agreement pursuant to the Cooperative Act as a public corporation and agency for the purpose of providing educational programs and services to its members, including independent school districts, cities, counties, and other governmental agencies, as well as nonprofit organizations, and on its members' behalf, which activities constitute "essential public and governmental purposes" under the Cooperative Act.; and

WHEREAS, the Borrower has represented to the City that it is exempt from federal income taxation under Section 501(a) of the Internal Revenue Code of 1986, as amended (the "Code"), as a result of the application of Section 501(c)(3) of the Code; and

WHEREAS, the Bonds proposed to be issued by the City to finance the Project and related costs will constitute revenue bonds secured solely by: (i) the lease payments derived from the lease arrangement between the Borrower and the Cooperative (collectively, the "Lease"); (ii) a pledge and assignment of all revenues of the Cooperative, including membership fees and grants; (iii) other revenues pledged to or otherwise received by the Borrower, except for those revenues necessary for ordinary operational expenses and required under Minnesota law; (iv) a debt service reserve fund to be held by the trustee for the benefit of the holders of the Bonds, if applicable; and (v) other security provided or arranged by the Borrower or the Cooperative; and

WHEREAS, the Bonds shall not constitute a debt of the City within the meaning of any constitutional or statutory limitation; shall not constitute nor give rise to a pecuniary liability of the City or a charge against its general credit or taxing powers; shall not constitute a charge, lien, or encumbrance, legal or equitable, upon any property of the City other than the City's interest in the Loan Agreement; and

WHEREAS, under the Loan Agreement, the Borrower will be required to make payments thereunder in amounts and at times sufficient to pay the principal of, premium (if any), and interest on the Bonds when due, and the loan repayments required to be made by the Borrower to the City under the terms of the Loan Agreement will be assigned by the City to the trustee for the Bonds to secure the payment of the principal of, premium (if any), and interest thereon.

## NOW, THEREFORE, BE IT RESOLVED THAT:

1. A notice of the public hearing shall be published in accordance with the requirements of the Act and Section 147(f) of the Code and related Regulations. The costs of the preparation and publication of such notice of public hearing shall be paid by the Borrower or the Cooperative. The Borrower and the Cooperative shall work with the staff of the City and Kennedy & Graven, Chartered, as Bond Counsel for the City with respect to the Bonds, to coordinate the publication of such notice in the official newspaper of the City and a newspaper of general circulation in the City. The notice of public hearing shall be published in substantially the form attached hereto as Exhibit A, once on a date not less than 14 days nor more than 30 days prior to the date of the public hearing.

2. The City Council will conduct the public hearing on Tuesday, March 26, 2024, or on another date as is deemed appropriate by City staff, with respect to the proposal of the Borrower and the Cooperative to undertake and finance the Project and related costs and with respect to the issuance of the Bonds, as requested by the Borrower and the Cooperative.

3. The City hereby grants preliminary approval for the issuance of the Bonds for the purposes referenced in this resolution and in an aggregate principal amount not to exceed \$11,000,000, subject to the approval of the Project by DEED, as required by the Act, and subject to the mutual agreement of the City, the Borrower, the Cooperative, and the initial purchaser(s) of the Bonds as to the details of the Bonds and provisions for their payment. In all events, it is understood, however, that the Bonds shall not constitute a pecuniary liability or charge, lien, or encumbrance, legal or equitable, upon any funds, assets, taxing powers, or any other property of the City except the City's interest in the Loan Agreement; and the Bonds, when, as, and if issued shall recite in substance that the Bonds, including interest thereon, are payable solely from the revenues received from the Loan Agreement and other property pledged to the payment thereof, and shall not constitute general or moral obligations of the City. The Bonds shall not constitute a debt of the City within the meaning of any constitutional or statutory limitation. The holder(s) of the Bonds shall never have the right to compel any exercise of the taxing power of the City to pay the outstanding principal of the Bonds, or the interest thereon or to enforce payment thereof against any property of the City.

4. It is hereby found and determined that the Project furthers the purposes set forth in the Act and the Project constitutes a "project" within the meaning of Section 469.153, subdivision 2(b) of the Act.

5. In accordance with Section 469.154 of the Act, the City shall cooperate with the Borrower and the Cooperative in submitting the proposal for the financing of the Project to DEED, including the execution of necessary documentation by City officials.

6. In accordance with Section 469.154, subdivision 7, of the Act, the officers, employees, and agents of the City are hereby authorized and directed to encourage the Borrower to target employment opportunities to qualified individuals who are unemployed or economically disadvantaged. Such individuals may be identified by mechanisms as are available to the Borrower and the Cooperative, such as a first source agreement in which the Borrower agrees to use a designated employment office as a first source for employment recruitment, referral, and placement, and by other means.

7. The Borrower shall pay to the City any and all costs incurred by the City in connection with the Bonds or the financing of the Project, whether or not the financing of the Project is approved by DEED, whether or not the financing is carried to completion, and whether or not the Bonds or operative instruments are executed and delivered. In addition to the application fee paid by the Borrower or by the Cooperative on behalf of the Borrower to the City on or before the date hereof, the Borrower shall also pay to the City upon closing on the Bonds a one-time administrative fee equal to (A) 0.25% of the original principal amount of the Bonds in excess of 10,000,000, which fee shall be set forth in the Loan Agreement.

8. Kennedy & Graven, Chartered is authorized to act as bond counsel ("Bond Counsel") for the City with respect to the Bonds and to assist in the preparation and review of necessary documents relating to the Bonds. The Mayor, the City Administrator, Finance Director, and City Clerk and other officers, employees, and agents of the City are hereby authorized to assist Bond Counsel in the preparation of such documents. 9. The adoption of this resolution does not constitute a guaranty or firm commitment that the City will issue the Bonds as requested by the Borrower and the Cooperative. The City retains the right in its sole discretion to withdraw from participation and accordingly not to issue the Bonds, or issue the Bonds in an amount less that the amount referred to herein, should the City at any time prior to issuance thereof determine not to issue the Bonds, or to issue the Bonds in an amount less than the amount referred to in paragraph 3 hereof, or should the parties to the transaction be unable to reach agreement as to the terms and conditions of any of the documents required for this financing transaction.

10. (a) The United States Department of the Treasury has promulgated final regulations governing the use of the proceeds of tax-exempt bonds, all or a portion of which are to be used to reimburse the City or a borrower from the City for project expenditures paid prior to the date of issuance of such bonds. Those regulations, Section 1.150-2 of the Regulations, require that the City adopt a statement of official intent to reimburse an original expenditure not later than sixty (60) days after payment of the original expenditure. The Regulations also generally require that the bonds be issued and the reimbursement allocation made from the proceeds of the bonds occur within eighteen (18) months after the later of: (i) the date the expenditure is paid; or (ii) the date the expenditure is paid. The Regulations generally permit reimbursement of capital expenditures and costs of issuance of the bonds.

(b) The City reasonably expects to reimburse the Borrower for the expenditures made for costs of the Project from the proceeds of the Bonds. All reimbursed expenditures shall be capital expenditures, a cost of issuance of the Bonds, or other expenditures eligible for reimbursement under Section 1.150-2(d)(3) of the Regulations and also qualifying expenditures under the Act.

(c) Based on representations by the Borrower and Cooperative, no expenditures for the Project have been made by the Borrower or the Cooperative more than sixty (60) days before the date of adoption of this resolution other than: (i) expenditures to be paid or reimbursed from sources other than the Bonds; (ii) expenditures permitted to be reimbursed under prior regulations pursuant to the transitional provision contained in Section 1.150 2(j)(2)(i)(B) of the Regulations; (iii) expenditures constituting preliminary expenditures within the meaning of Section 1.150-2(f)(2) of the Regulations; (iv) expenditures in a "de minimis" amount (as defined in Section 1.150-2(f)(1) of the Regulations); or (v) pursuant to a declaration of official intent by the Borrower in accordance with Section 1.150-2 of the Regulations.

(d) Based on representations by the Borrower, as of the date hereof, there are no funds of the Borrower reserved, allocated on a long term-basis or otherwise set aside (or reasonably expected to be reserved, allocated on a long-term basis, or otherwise set aside) to provide permanent financing for the expenditures related to the Project to be financed from proceeds of the Bonds, other than pursuant to the issuance of the Bonds. This resolution, therefore, is determined to be consistent with the budgetary and financial circumstances of the Borrower as they exist or are reasonably foreseeable on the date hereof.

11. This resolution shall be in full force and effect from and after its passage.

### NOTICE OF PUBLIC HEARING ON THE ISSUANCE OF CONDUIT REVENUE BONDS PURSUANT TO MINNESOTA STATUTES, SECTIONS 469.152 TO 469.1655

NOTICE IS HEREBY GIVEN that the City Council of the City of Marshall, Minnesota (the "City") will conduct a public hearing on Tuesday, March 26, 2024, at or after 5:30 p.m. in the Council Chambers of the Marshall City Hall, 344 West Main Street, Marshall, Minnesota, to consider a proposal by the Foundation for Innovation in Education, a Minnesota nonprofit corporation ("Borrower"), for the issuance of one or more series of taxable and/or tax-exempt conduit revenue bonds or other obligations (the "Bonds"), under Minnesota Statutes, Sections 469.152 to 469. 1655, as amended, the proceeds of which are proposed to finance all or a portion of the costs of (i) the acquisition, construction, and equipping of an approximately 16,100 square-foot facility to be located at or about the intersection of Channel Parkway and London Road in the City (the "Facility"); (ii) the funding of capitalized interest; and (iii) the payment of a portion of the costs of issuing the Bonds (collectively, the "Project"). The Facility will be owned by the Borrower and will be leased to and operated by Southwest West Central Service Cooperative (the "Cooperative"), a service cooperative established pursuant to Minnesota Statutes, Section 123A.21, as amended, and used by the Cooperative and its members, including public school districts, cities, counties, and other governmental units or nonprofit organizations, as an administration, office, meeting and training center. After the public hearing, the City Council will consider adoption of a resolution giving final approval to the issuance of the Bonds and loaning the proceeds thereof to the Borrower to finance the Project. The aggregate face amount of the Bonds proposed to be issued to finance the Project is presently estimated not to exceed \$11,000,000.

The Bonds if and when issued will be special, limited revenue obligations of the City, and the Bonds and interest thereon will be payable solely from the revenues and assets pledged to the payment thereof. No holder of any Bond will have the right to compel any exercise of the taxing power of the City to pay the Bonds or the interest thereon, nor to enforce payment against any property of the City except money payable by the Borrower to the City and pledged to the payment of the Bonds. Before issuing the Bonds, the City will enter into one or more loan agreements with the Borrower, whereby the Borrower will be obligated to make payments at least sufficient at all times to pay the principal of and interest on the Bonds when due.

A draft copy of the proposed application to the Department of Employment and Economic Development for approval of the Project, together with all attachments and exhibits, shall be available for public inspection following the publication of this notice, at City Hall during normal business hours. Anyone desiring to be heard during the public hearing will be afforded an opportunity to do so.

Background Information:	The EPA has approved the City of Marshall's request for a chloride variance on February 1. The MPCA is now working on issuing our new NPDES permit which should be in place by March 1.
	To meet new wastewater NPDES chloride discharge limits the City of Marshall has been participating in a water softener optimization/rebate program since July 2022. This has been possible due to an MPCA grant along with funding from the wastewater budget.
	The rebate grant program will be ending on June 30, 2024, or when funds are depleted. Wastewater has budgeted for the rebate program in 2024 to cover matching and engineering fees.
	Staff would like to use any remaining wastewater budgeted funds to continue the rebate program after the grant has expired for the rest of 2024 or until funds run out. Further, City staff is requesting to continue funding a water softener rebate program in future years with Wastewater Department funds. Continuing to fund a water softener rebate program will help ensure that the Wastewater Treatment Facility remains in compliance with its NPDES discharge permit. Included in the packet is a Resolution for City Council consideration of continual funding for a local water softener rebate program.
Fiscal Impact:	Wastewater has remaining budgeted funds in 602-49500-58180 Refunds & Reimbursements.
Alternative/ Variations:	None
Recommendations:	that the City Council authorize City staff to utilize any remaining funds to continue the water softener rebate program for 2024 or until those funds are depleted.

#### **RESOLUTION NUMBER 24-025**

## **RESOLUTION CREATING WATER SOFTENER REBATE PROGRAM**

WHEREAS, the City of Marshall's Municipal Wastewater Treatment Facility (WWTF) is required by the Minnesota Pollution Control Agency (MPCA) to reduce the discharge of chlorides into the Redwood River by 2024; and

WHEREAS, a large portion of chloride discharge comes from water softener salt that is sent into the sanitary sewer collection system which flows to the WWTF and is discharged into the Redwood River; and

WHEREAS, chlorides cannot be removed through conventional mechanical treatment systems, so the City of Marshall and Marshall Municipal Utilities (MMU) worked together and upgraded MMU's Water Treatment Plant to produce a softer water to help attain compliance with the required limits set by the MPCA; and

WHEREAS, the City of Marshall WWTF will be issued a new National Pollutant Discharge Elimination System (NPDES) permit PERMIT# MN0022179 for wastewater effluent discharged into the Redwood River; and

WHEREAS, the new NPDES PERMIT# MN0022179 will take effect on March 1, 2024; and

WHEREAS, the new NPDES permit includes a variance for chloride reduction that includes an interim chloride limit of 468 mg/l; and

WHEREAS, the city will need to meet a final limit of 261 mg/l beginning March 1, 2034 once the variance term expires; and

WHEREAS, water softening units have a useful lifespan that varies from 10-20 years and property owner's are not likely to replace their water softening units frequently enough; and

WHEREAS, studies support a finding that replacing water softening units will decrease chloride concentration levels at the WWTF; and

WHEREAS, reduction of chloride concentration levels promotes health, welfare and safety of the community, and furthers a public purpose; and

WHEREAS, Council has authorization through Section 7.01 of the City Code to adopt this type of program; and

WHEREAS, it is deemed prudent by the City of Marshall to offer a rebate program to help offset the cost of replacing water softening units to incentivize the replacement of water softeners to help meet chloride concentration limits at the WWTF; and

WHEREAS, the WWTF will budget annually for funding the water softener removal and replacement rebates to serve the greater good of the community and the environment and to help the WWTF meet MPCA-required chloride concentration limits at the WWTF; and

WHEREAS, to be considered for a rebate water softeners must be programmed for a minimum 4,000 grains/lb of salt efficiency; and

WHEREAS, the City of Marshall City Council shall have oversight and review of all budgeted dollars for the rebate program annually during city budget preparation.

NOW, THEREFORE, BE IT RESOLVED by the Common Council of the City of Marshall as follows:

- 1. The City shall establish a water softener removal or replacement rebate program.
- 2. The rebate program shall be effective upon approval of this Resolution.
- 3. The rebate amount shall be \$500 to remove a water softener or \$500 to replace a water softener with a new, efficient water softener.
- 4. Rebate amounts shall be reviewed annually and approved with the current City Fee Schedule.

Passed and adopted by the City Council this <u>27<sup>th</sup></u> day of <u>February</u> 20<u>24</u>.

# Phosphorus

- \* New more stringent limits will need to be reached June through September.

- \* The EPA needed to approve our request for a variance before the MPCA could issue our new NPDES permit.
- \* On February 1, the MPCA received EPA approval and is currently working on issuing our permit.
- \* The new permit will become effective on March 1, 2024.
- \* Because of the new limits we are currently updating all Significant Industrial agreements.

	This project has been presented and discussed at the following PI/T meetings: 01/24/2023, 02/14/2023, 10/24/2023 and 02/13/2024. In addition, a public informational meeting was held on 01/18/2024. Notices were mailed to all owners. No property owners attended the meeting.

# 1.0 SCOPE

This Feasibility Report as authorized by the City Council, covers the following proposed improvements: reconstruction and utility replacement on Lyon Circle off East Lyon Street West of the intersection of Jewett Street and East Lyon. Utilities will be installed, including watermain and sanitary sewer, Storm Sewer, on Lyon Circle. Other items of work included in this project are pavement removal, aggregate base, concrete surfacing, curb and gutter and other minor work.

# 2.0 BACKGROUND / EXISTING CONDITIONS

#### <u>Street</u>

City records indicate that this circle was originally constructed in 1981. The existing pavement surface had fallen apart and is currently a mix of millings and gravel.

The existing segment of Lyon Circle measures approximately 41-FT as measured from the back of curb to the back of curb with a 50' radius on the circle. Currently, the existing segment of Lyon Circle is wide enough to accommodate two travel lanes and parallel parking on both sides of the street.

There is currently no sidewalk on Lyon Circle, we do not recommend adding sidewalk to the circle.

#### **Utilities**

There is currently 6" PVC watermain and 8" VCP sanitary sewer along this segment of Lyon Circle. Properties adjacent to Lyon Circle are serviced by aging sanitary service lines. The existing sanitary main in the circle is 8" vitrified clay pipe (VCP) and is in poor condition. There is 12" RCP storm sewer crossing the north end of Lyon Circle. Storm sewer is recommended to be replaced under a new valley gutter.

# 3.0 PROPOSED IMPROVEMENTS

## <u>Street</u>

A bituminous pavement section will be proposed and discussed in this feasibility report. Staff is proposing a street section comprised of a 4" thick bituminous surfacing, a 12" thick section of Class 5 aggregate base. A geotextile fabric will be placed on the subgrade prior to the placement of the class 5 aggregate. A 6" perforated drain tile shall be installed at the back of the curb below the aggregate base to provide subsurface drainage for the street section.

The proposed roadway on Lyon Circle (as measured from curb face to curb face) will be 32-FT with a 40.5' radius on the circle. The project proposes two 13-FT travel lanes and two 3' wide recovery areas. It is the opinion of staff that the proposed road width will be adequate to serve the corridor.

A 10-FT sidewalk opening will be installed on the north end of the circle for future 10' wide bike path to be installed.

## **Utilities**

The proposed utility improvements include installing new sanitary sewer, sanitary services throughout the block with service lines extended into the adjacent properties.

The watermain improvements will consist of installing a new hydrant for fire protection. The new hydrant will connect to the existing 6" PVC watermain.

The sanitary sewer system improvements will include installing new manhole, sewer main, and sewer services along Lyon Circle. The main will be new 8" PVC main. New sewer services will be installed to the right-of-way (ROW) with a minimum 4" pipe size. Storm sewer will be improved under the new valley gutter.

# 4.0 STATEMENT OF PROBABLE COST

The estimated costs to complete the proposed improvements are shown below. The estimated construction costs include a 10% allowance for contingencies and a 16% allowance for administrative and engineering costs. The unit prices for each item of work used in determining the estimated cost of construction is based on previous projects similar in nature and is subject to change.

# 5.0 PROPOSED ASSESSMENTS

The adjacent properties will not be assessed for the watermain improvements. All costs for watermain and related work will be paid by MMU.

The adjacent properties will not be assessed for sanitary sewer main improvements. All costs for sanitary sewer main will be paid by the City of Marshall Wastewater Department. Sanitary sewer service lines and connection points to the main will be assessed to the adjacent property owners according to current sanitary sewer assessment procedures.

Costs for the street replacements will be partially assessed to the adjacent property owners in accordance with the most recent Special Assessment Policy and partially funded by the Surface Water, Wastewater Department, and MMU.

A preliminary assessment roll showing the estimated assessments for each benefiting parcel, City Participation, and utility participation will be prepared at a later date for consideration by the City Council in accordance with the most recent Special Assessment Policy.

# 6.0 FEASIBILITY/CONDITIONS/QUALIFICATIONS

The proposed improvements as described in this report are necessary, cost-effective, and feasible from an engineering standpoint. The feasibility of this project is contingent upon the findings of the City Council pertaining to project financing and public input.
