At 3:08 PM, Co-Chair Tofte called the meeting to order.

Motion by Knife Sterner, Seconded by DeCramer to approve the minutes from the February 2, 2022. All approved.

Co-Chair Tofte provided discussion on the recent World Café that happened at the end of Cultures on the Prairie. The event was well attended, and the Commission is looking forward to reviewing the information compiled by the YWCA. Tofte asked for further discussion on the April 30 World Café hosted by the School District. There was a consensus from the Commission to have the World Café subcommittee continue to work on the planning on the event.

Co-Chair Tofte introduced Pablo Obregon, Community Engagement Officer and Ku Lor, Rural Equity Specialist with Southwest Initiative Foundation. Pablo provided additional background information on Welcome Week 2022 via PowerPoint.

Discussion points included population and diversity changes in cities within our region, the Grow Our Own initiative, Welcoming America Week themed Belonging Begins with Us which will be held September 9 -18, 2022. In 2021 there was a total of 11 Communities that participated in Welcoming Week.

Member Nicole DeBoer commented on a grant that the community of Windom applied for and received for Welcoming Week. DeBoer provided additional insight on SMAC's grant process for 2022.

There was additional discussion from the Commission and the 2021 involvement with Welcoming Week.

Further discussion from the Commission included the invitation to additional partners and to call the Welcoming Week Subcommittee together at the April meeting.

City Clerk Kyle Box provided additional information on calling for co-chairs. The Commission previously voted to keep one existing co-chair in rotation. Box clarified the two previous nominations, Michele Knife Sterner and Marcy Heemeyer. Both nominees are still accepting of the position.
