#### Call to Order

#### **Diesel Fuel Tank Update**

Dean Coudron shared preliminary quotes as follows: Fix existing 1,000-gallon underground tank at \$19,500 or provide a new above-ground tank at \$38,000. Dean to obtain additional info on relative cost of standard tank vs. fire rated tank with the hope that the cost of tank

replacement can be less expensive than the quoted \$38,000. Considering the age and condition of the existing tank, the Commission believes that a new above-ground tank is a better long-term solution.

FAA 5010 inspection identified some crops being too close to the runway. City to verify the distance from the runway centerline to the adjacent property line.
