4. MPR Department Forestry Update - Matthew Perkins

MPR City Arborist Matt Perkins provided an Urban Forestry 2021 At a Glance update, as well as a brief look ahead to the projects he will work on in 2022. Copies of his PowerPoint slides are attached to these meeting minutes.

Commission Feedback:

- Jo Greer She asked Matt to explain what a Tree City USA in more detail. It is a designation to show that our community cares about and recognizes the value of trees, as a member of the National Arbor Day Foundation. The City of Meridian has been a Tree City USA for 19 years in a row.
- **Keith Bevan** -He thanked Matt for all he does as an arborist and appreciates having the trees in our system.

He asked Matt to explain more about Code Enforcement inspections. *Matt gets calls about Code Enforcement issues; i.e., if someone had a nuisance tree that may be hazardous and hanging over, etc.*

5. MPR Department Master Plan Update - Steve Siddoway

MPR Director Steve Siddoway reported Art Thatcher with GreenPlay reached out and conducted some leadership interviews with all the MPR Commissioners, Mayor and City Council—thank you!

 Public Involvement Week – The week of November 15, 2021 the Department held a series of focus groups and stakeholder interviews. There were 8 different focus groups – teens, seniors, City departments, and in general with participants representing ACHD, West Ada School District, ITD, Meridian Library, WARD, irrigation districts, Cole Valley Christian School, MDC, Meridian Chamber of Commerce, Downtown Business Association, MPAL, Boise Area Pickleball Association, City of Eagle, Ada County Waterways, and many others.

There were approximately 39 focus group attendees who provided feedback. That week culminated in an open pubic forum at Meridian City Hall. The meeting was recorded of the findings from that week in all the focus group interviews and is available online.

- 2) <u>Survey</u> = There are two versions of the survey:
 - ✓ A statistically valid random sample survey that was a mailer to randomly selected households throughout the community. This survey went out the week of November 22 and is still open.

✓ Soon the same survey will be open to the general public (but with a separate URL for tracking separately). This is the plan.

- 3) <u>Community Center</u> There are a couple of questions in the survey about the new community center. The MPR Department is awaiting feedback on the uses and types of spaces citizens would like to see in a new facility. Over the next two weeks at the staff level, the Department will hold with the GreenPlay team a kickoff brainstorming/concept planning effort for the community center, based on what they know today. The public process for this will kick off in January 2022.
- 4) <u>GRASP Analysis</u> This is a GIS-based inventory of all of the MPR Department's parks, facilities, and amenities that not only looks at what and where they are, but their condition. During the public involvement week in November, GreenPlay's GIS team came to town and went through all of the City's parks and inventoried them, including amenities within them for a ranking process. The first draft of the analysis has been delivered to MPR staff members who are reviewing it and get it back to them by the end of next week. This is a big process and is underway.
- 5) <u>Website</u> If anyone would like to review the results from the public involvement week and view Art Thatcher's recorded presentation, visit this link: <u>www.meridiancity.org/parks/masterplan</u>. This website will continue to be updated with more and new information as it continues to come out through this process.

Commission Feedback:

- **Mandi Roberts** Will the GIS team take that inventory and look at a Citywide population-based analysis in GIS where they can look at areas that might be growing as more people are coming in for a higher demand? *Yes, they do a wonderful job with their level of service analysis and consider barriers, arterials, the freeway, etc. They do a spatial level of service and look at pathway connections and walkability. The Department will receive a robust set of findings in the spring.*
- **Dom Gelsomino** As they get into the master plan and the new year in planning Discovery Park, Phase 2, he has a candidate for a new community garden, which he will pass along to Mike Barton. *The Department is looking for the next big community garden champion/leader.*

6. 2022 MPR Commission Leadership Elections - Jo Greer

MPRC President Jo Greer reported each year elections are held in December; one for President and the other for Vice President. The current Vice President—Keith Bevan declined the automatic nomination for President and instead would like to rerun for reelection for a second term as Vice President, which Keith confirmed. There were no other nominations for Vice President. Commissioner Jo Greer was willing to serve another term as President, so she nominated herself. There were no other nominations for President.

President Jo Greer entertained a motion to elect Jo Greer for President and Keith Bevan for Vice President in 2022. Commission President Dom Gelsomino moved to elect Jo Greer for President and Keith Bevan for Vice President. Commissioner Jennifer Bobo second the motion. All were in favor of the motion.

Congratulations to Jo Greer as the President and Keith Bevan as Vice President. The Commission leadership is effective January 1, 2022.

7. Brainstorm & Identify 2022 All-Commission Goals – Steve Siddoway

Staff Reports

8. MPR Staff

Parks Superintendent Mike Barton reported on the following:

- <u>Discovery Park, Phase 2</u> Council approved the contract to break ground anytime. They
 are getting all the final agreements in place with ACHD regarding right-of-way and the
 Williams Pipeline agreements, as well as bonds and insurance, making project boards,
 and discussing logistics on where to put construction items and staging.
- <u>Lakeview Golf Course</u> MPR staff members have plans for the irrigation system renovation at almost 100%. They will look at one final review soon which will then go out to bid. The process will then begin with evaluating bids. In addition, they have been evaluating the fees for the last month or so, due to the cost of inflation. MPR staff will present some suggested fee increases to the Golf Course Focus Group and then to City

Council. Mike has been gathering a lot of background information and factfinding in preparation.

Recreation Manager Garrett White reported on the following:

- <u>Arts & Culture</u> He has been busy conducting Arts & Culture Coordinator interviews and reviewing applications. He hopes to have Audrey Belnap's replacement on board on January 3, 2022 (her last day is January 7,2022).
- <u>Concessions</u> He continues working with the Purchasing Department in putting out RFPs for parks on Monday, December 13. The Department has three snow cone sites open—Storey Park, Tully Park, and Bear Creek Park. The Settlers Park concessions building is up for an RFP, as well as Discovery Park.
- <u>Pool</u> He has been doing pool inspections and learning the operations. He has been working with Legal on a potential draft reimbursement agreement with WARD.
- <u>Coordinators</u> They have been busy with activities for Christmas in Meridian, sports leagues, and volunteer tasks.

Pathways Project Manager Kim Warren reported on the following:

- <u>Pathway Infill Projects</u> The Creason Pathway and the two Linder Road projects will be submitted to ACHD this week. Locust Grove is on the heels of this. A couple of the other various projects have taken a back burner but are still a priority and on the list. They will push more on the Five Mile Pathway segment between Ten Mile Road and Black Cat and then the Meridian Road and Victory segment.
- <u>Five Mile Pathway Striping</u> Just this week was some striping of the Five Mile Pathway, which is the main pathway in Meridian, for the purpose of calling attention to it and as a means of wayfinding. This is a contiguous route through the city that people may not be aware of.
- <u>ULI Partnership</u> Council approved the panel contract yesterday, which was on the consent agenda. MPR staff have been meeting internally to chip away at the tasks the ULI needs from the MPR Department, as they are planning to come out in May 2022. Next up is to be more specific about defining a study area where they can apply the questions MPR staff has specifically asked them about.
- <u>Plan Review</u> She has been reviewing a lot of plans.

Adjourn

Commission President Jo Greer entertained a motion to adjourn the meeting. Commissioner Dom Gelsomino moved to adjourn. Commissioner Keith Bevan seconded. The vote was unanimous and in favor of the motion.

There being no further business, the meeting adjourned at approximately 7:06 p.m.





<u>City Arborist's Report</u>: Matthew Perkins

1. **Tree Pruning** – I will work throughout the winter on contract pruning work orders for this fiscal year and update tree inventory as I go along.

- 2. **IPM (Integrated Pest Management)** I am working on putting together treatment plans and maps for pest and disease management in all of the Meridian trees, including the Lakeview Golf Course, for 2022.
- 3. **Tree Planting** I will make a big push to get all vacant tree planting locations replaced with new trees this year. Over the last couple years, I have worked on removing dead, diseased trees and stumps and can finally focus on replacing and planting new trees. I am currently putting together maps of all planting locations and putting together an order for trees from the nurseries based on species availability.
- 4. **Christmas Tree –** The 2021 Christmas Tree will be removed from Generations Plaza, and the hunt for the 2022 tree will begin.
- 5. **Downtown Tree Well Work –** Plans for the contract work on pavers and tree wells in downtown are in place and moving forward.

Recreation Division

Recreation Manager's Report: GARRETT WHITE

- 1. WARD Pool Transfer Logistics Within the past two months, the Meridian Pool has been inspected by Idaho Pool Remodeling, Superior Pools, and Deep Kleen Pools to determine any necessary repairs that they deemed were critical to the operations of the pool. During the inspection process, I also invited the YMCA pool maintenance staff, the Nampa Recreation Aquatics Manager, and our Parks Maintenance Manager to walk through the facility. After all inspections were done, I compiled a list of all critical pool repairs and recommended repairs and items that can help with efficiencies. Please note that not all items found were items that can be repaired by the three pool inspection companies. Some repairs are more specialized, such as concrete work, basic building maintenance, and painting. Those specialty repairs should be bid separate from the pool repairs.
- 2. <u>External Event Scheduling for 2022</u> I have been working with event organizers to confirm dates and event schedules for all events happening in our parks.
- 3. <u>Concessions RFP Release</u> I have been working with our Purchasing Department to release the Park Concessions RFPs for Discovery Park, Settlers Park, Storey Park, Tully Park, and Bear Creek Park. All submittals are in, and we will need to complete the review process.
- 4. <u>Arts & Culture Coordinator Hiring</u> We have completed the hiring of our new Arts & Culture Coordinator! Her name is Cassandra Schiffler! We are excited to
