AMENDMENTS TO THE MORGAN COUNTY DEVELOPMENT REGULATIONS (CHAPTERS 1-4)

Planning Director, Chuck Jarrell reviewed the proposed amendments to the Morgan County Development Regulations.

<u>MOTION</u> by Commissioner Ainslie, Seconded by Commissioner Kurtz to approve the text amendments to Chapters 1, 2 and 3 of the Morgan County Development Regulations and to delete Chapter 4 in its entirety.

Commission Riden asked for clarification regarding the suggested changes on pages 171, 172 and 173.

Commissioner Ainslie clarified that the suggested changes on pages 171, 172 and 173 were not included in his motion.

Motion passed 3-2 with Chairman von Hanstein voting with the motion and Commissioners Riden and Harris voting in opposition.

FIRST READING/PUBLIC COMMENTS CHAPTER 10 ANIMAL ORDINANCE REVISION

Animal Services Director, Hope King presented the proposed revisions to Chapter 10 of the Animal Ordinances of Morgan County.

Chairman von Hanstein opened the floor for public comments:

MORGAN COUNTY PLANNING & DEVELOPMENT IS REQUESTING TEXT AMENDMENTS TO THE MORGAN COUNTY ZONING ORDINANCE CHAPTER 5.5 MINIMUM REQUIRED YARDS AND BUILDING SETBACKS, AND TABLE 4.2 REGARDING DIMENSIONAL REQUIREMENTS

Planning Director, Chuck Jarrell presented text amendments to Articles 4 & 5 of the Morgan County Zoning Ordinance that were tabled at the 03/16/2021 BOC meeting pending the outcome of the development regulation amendments. The changes are necessary to prevent conflicting information in the Zoning Ordinance and Development Regulations.

<u>MOTION</u> by Commissioner Ainslie, Seconded by Commissioner Kurtz to approve the text amendments to the Morgan County Zoning Ordinance Chapter 5.5 Minimum Required Yards and Building Setbacks and Table 4.2 Regarding Dimensional Requirements as presented. **Motion passed 3-1** with Commission Harris voting with the motion and Commission Riden voting in opposition.

FIRE FIGHTING AUTOMATIC AID AGREEMENT REVISION

This is a revision to the automatic aid agreement between Morgan County and the City of Madison for firefighting services.



ABANDONMENT OF COUNTY ROAD 235

Planning Director, Chuck Jarrell presented a road abandonment request for CR 235. Mark Giles from Georgia Department of Transportation is requesting the county to formally abandon CR 235, Approximately 2,570 feet in length. CR 235 is a loop road on Athens Highway near the Apalachee River. The road has been closed for several years but was never formally abandoned.

The subject road only affects two property owners. Most, if not all, of the road is contained on property owned by Plainview Development, LLC. The Stratton's utilize one end of the road as part of their driveway.


ABANDONMENT OF A PORTION OF COUNTY ROAD 67, CUMMING DRIVE

Planning Director, Chuck Jarrell presented a road abandonment request on Cumming Drive, which is a dirt road located off Atlanta Highway.

Morgan County received a request to abandon approximately 1,595 feet of CR67, Cumming Drive. Barbara Williams Sauerbier requested that the County formerly abandon the portion of Cumming Drive that proceeds into her property. She has had issues with people trespassing on her property and would like to install a gate across the road at her property boundary.

This request will not impact any other properties that adjoin Cumming Drive.
