Lance Aldrich, Strand Associates, presented on the Drawings and Specifications for the expansion of the reed beds and replacement of the membrane liner of the flow equalization basin at the wastewater treatment plant have been completed and distributed to prospective contractors on June 13, 2023. He then explained the contract is a lump sum form of agreement with a few unit prices, or allowances, for repairs to the existing reed beds. The Engineer's opinion of probable construction cost is \$1,553,000. Bids were received on July 19, 2023.
