Mr. McCarthy stated that in June UL will condition a UL 268 listing on the 7th edition. After consultation with technical staff, Mr. McCarthy was asked to add a slide saying, "While the current referenced standard in Ohio is 2016 UL 268, the standards continue to be updated by UL, and this course provides education on the current UL standard, which exceeds the requirements set by the OBC referenced standard." It is slide number one in the attached set.
