Zero Lot Line Townhouse Buildings

As a follow up from the last meeting, staff presented the revised draft of proposed changes to the OBC Sections 106.2.1, 310.5.5, and 1301.1.1 to address zero lot line townhouse-type buildings. Mr. Pavlis made the motion to approve the revised draft language as presented by staff. Mr. Johnson seconded the motion. The motion passed unanimously.

# Commercial Energy Code Review

The committee continued discussions about the ASHRAE 90.1-2019. Mr. Denk shared his concerns with the language in ASHRAE 90.1-2019 Sections 6.4.3.6 (Humidification and Dehumidification Control) and 6.5.6.1 (Exhaust Air Energy Recovery for Nontransient Dwelling Units). The committee asked staff to research whether deleting these requirements would affect the COMcheck software report results. Mr. Yankie shared that ERV systems allow for easier balancing of HVAC systems and help to resolve condensation and mold issues that seem to be increasingly common. The committee discussed the option of allowing certain occupancies constructed of metal buildings to use earlier editions of the standard, but agreed that would likely complicate demonstrating compliance with the code when using COMcheck. No action was taken.

# OBC Draft rule review (Chapters 10-12 and 14-16)

Staff presented additional draft rules of the OBC and explained that staff would go through each chapter in greater detail at a later date to make the committee aware of the significant changes that staff is recommending for each chapter. No action was taken.

# November 17, 2022 Code Committee Meeting

# Call to Order

The meeting was called to order by Mr. Denk at 1:03 P.M.

# **Approval of Minutes**

Mr. Stanbery made the motion to approve the minutes of the Code Committee meeting held on October 20, 2022. Mr. Miller seconded the motion. The motion passed unanimously.

# Petitions

# Petition #22-03 OPC Section 312.2.2 – Tim Irven of Integrity Safety Solutions

Staff explained the history of the Ohio plastic pipe testing requirements in Section 312 of the OPC and that the petitioner is asking for recognition of a product that is not part of the plumbing system, but instead is part of the testing equipment used by the plumbing contractors to test the system for leaks. The committee tabled the item and asked staff to communicate with the petitioner and explain that the board does not typically adopt rules for equipment used to test plumbing systems and see if the petitioner understands and is willing to consider withdrawing his petition.

# Petition #22-04 OBC Ch 11 – Kim Boulter & Jennifer Corcoran of Changing Spaces Ohio

Ms. Boulter and Ms. Corcoran presented their unique challenges and experiences as parents of adult children that cannot use the toilet facilities as most of the population can. They have created a campaign to add adult changing tables in public buildings to allow children with similar needs and their families to participate in the same activities that most of us take for granted. They are asking the Board to adopt OBC language that requires adult changing tables in certain new buildings. The language has already been approved for inclusion in the 2024 IBC and the next edition of the ICC A117.1 standard. The committee was generally supportive of the concept but tabled the item and asked staff to work with the petitioners to clarify some of the language.

# **Recommendations of the Residential Construction Advisory Committee**

# Petition #22-01 RCO Ch 44 – Tom Moore of the Ohio Electrical Coalition

Staff explained that the petition to adopt the 2020 NEC was reviewed by the RCAC last month. The RCAC recommended adopting the 2020 NEC with some amendments. Staff stated that NEMA sent a letter to the Board requesting additional opportunity to provide comment on amendments. Mr. Stanbery made the motion to refer the petition back to the RCAC for reconsideration. Mr. Miller seconded the motion. The motion passed unanimously.

# **Old Business**

# **Commercial Energy Code Review**

Staff shared the COMcheck software checklists that users need to complete and certify when performing an ASHRAE 90.1-2019 energy code analysis to get the building model to pass. Two of the four sections proposed to be deleted by the committee (Section 6.4.3.6 (Humidification and Dehumidification Control) and Section 6.5.6.1 (Exhaust Air Energy Recovery for Nontransient Dwelling Units)) would require users to certify that they complied with the section in order to get the software to produce a passing score. COMcheck software allows the user to state that the section does not apply to the other two sections proposed to be deleted by the committee (Section 8.4.2 (Automatic Receptacle Control) and Section 8.4.3 (Electrical Energy Monitoring)). The committee did not wish to render the software useless and decided to not delete Sections 6.4.3.6 and 6.5.6.1. Staff provided commentary from the ASHRAE User's Guide and the IECC Commentary publications to help the committee members understand the intent of those sections. Mr. Denk would like input from Mr. Johnson and Mr. Yankie at the next meeting before ending discussions on the commercial energy code. No action was taken.

#### **OBC Draft rule review (Chapters 17-28)**

Staff presented additional draft rules of the OBC and explained that staff would go through each chapter in greater detail at a later date to make the committee aware of the significant changes that staff is recommending for each chapter. No action was taken.

# **New Business**

Mr. Miller mentioned that renewable energy sources such as solar and wind farms are becoming more frequently installed throughout the state and the technology and developers are steps ahead of the regulations that govern. He asked if the committee would be interested in learning more. The committee members agreed that would be a good idea. Mr. Miller and staff will work to schedule a presentation for the committee in 2023.

Mr. Miller made the motion to adjourn at 3:27 P.M. Mr. Stanbery seconded the motion. The motion passed unanimously.

#### **Company Narrative**

The International Code Council (ICC) is a nonprofit organization with more than 63,000 members, with more than 3,000 in the State of Ohio, that is dedicated to helping communities and the building industry provide safe, resilient, and sustainable construction through the development and use of model codes and standards used in design, construction, and compliance processes. ICC is the leading global source of model codes and standards and building safety solutions that include product evaluation, accreditation, technology, training, and certification. Most U.S. states and communities, federal agencies, and many global markets choose the International Codes (I-Codes) to set the standards for regulating construction, building safety, and major renovations, plumbing and sanitation, fire prevention, and energy conservation in the built environment. Ohio adopts Building, Residential, Fire, Plumbing, Mechanical and Energy Codes based on the I-Codes, in addition to several standards developed under the ICC Standards Development process.

The Council has nine offices throughout the United States and established regional operations in the Middle East and Oceania. ICC develops 15 International Codes, and the ICC Family of Solutions is active in more than 100 countries around the world. The Council has more than 500 highly qualified staff members that support the mission and vision of the Council and provides world class products and services to its members, jurisdictions, and member organizations.

The Code Council appreciates the opportunity to submit the following proposal in response to the Ohio Department of Commerce (ODOC) Request for Proposal (RFP) issued October 7, 2022, for a study of the profession of building code enforcement in Ohio and nationally to identify trends and best practices in code enforcement and fees of building departments and in compensation and qualifications for building department personnel ("Building Certification Study").

ICC is uniquely positioned to support the Ohio Board of Building Standards Building Code Study. We understand the RFP, and we can deliver the independent report by the deadline specified in the RFP.

The Study seeks an analysis of code official experience and certification requirements and best practices in these areas. Roughly two-thirds of states require or accept certifications that the Code Council develops to qualify code officials. The Code Council itself administers close to 60,000 certification examinations annually. The Code Council administers membership councils for different segments of the building safety profession as well as a Major Jurisdiction Committee and a state code officials working group. It regularly surveys these groups and its membership more broadly regarding construction industry trends. ICC brings to this Study a unique ability to query its membership alongside a distinct perspective in developing and administering certifications. Notably, ICC's members include both government code officials and third-party code officials, with whom governments contract to conduct code services.

The Study seeks an analysis of position qualifications and compensation and best practices in these areas. In addition to querying our membership, as noted above, the Code Council hosts the largest jobs site for code officials in the industry, which historically has featured more than 8,000 employers and assisted more than 21,000 job seekers. Nearly 370 positions are currently pending. Through surveying and its

Career Center, the Code Council has the ability to ascertain position qualifications and compensation details and trends, both in Ohio and nationally. The Code Council also has the expertise to research and report on fee structures, given many of our technical staff have worked closely with fee structures as building officials. ICC is a publisher of national building valuation data and the developer of codes that reference fee considerations.

We serve the 63,000 members of the Council who are either code officials (building, fire and otherwise) or construction industry members. The majority of our technical staff have experience in building department operations, specific construction industries, or trade organizations that support the construction codes and standards promulgated by the Council. Not only does our staff have the requisite experience to provide the deliverables to the State of Ohio, but we also have the staff capacity to perform the work and the desire to assist the state with the information needed.

## **Project Narrative**

The Ohio Board of Building Standards (Board) is seeking an independent expert perspective regarding the profession of building code enforcement to identify trends and best practices in code enforcement, qualifications for building department personnel, fees building departments charge for services, and compensation of the code enforcement personnel. The Board recognizes the challenge of recruiting qualified personnel and to provide code enforcement services to their communities in a cost effective, efficient, competent, and timely manner in the current employment and economic environment. This challenge is not strictly limited to Ohio but is a systemic issue that affects nearly all building departments and sub-departments throughout the country, regardless of location, compensation, size, or structure at a state-wide level.

The International Code Council recognized these challenges years ago and began studying this issue. In 2014, ICC and the National Institute of Building Sciences conducted an extensive survey of code officials and published a report outlining several demographics that show some of the future challenges of the profession. Several Code Council initiatives have been put in place to assist code officials with staffing challenges including Mentorship programs, a Board Shadowing program, the Emerging Leaders Membership Council, the Building Safety Career Path Initiative, Military Families Career Path Program and Safety 2.0. We are acutely aware of these issues on a national scale and well-equipped to conduct specific evaluation on several areas relevant to the State of Ohio and the ability of the Board and local jurisdictions to best provide services to constituents.

More recently, the Code Council conducted regular interviews of code officials and code departments on how they were managing changes due to the COVID-19 pandemic. These surveys resulted in a series of reports capturing best practices that helped inform jurisdictions nationwide. Additionally, our International Accreditation Service and Major Jurisdiction Committee compile best practices and lessons learned from code departments. We will leverage this experience and unprecedented access to code departments and code officials to develop the required deliverables.

As noted in the RFP, the study will be limited to only those jurisdictions that utilize code(s) published by the International Code Council as a basis for construction requirements.

#### **Project Work Plan**

The strategy of the Council is to leverage existing membership and resources, survey, and supplementing as necessary with additional research and outreach. In some applications, we plan to gather information from multiple resources to compare specific parameters where the study requires comparison of data throughout Ohio and the county. We will obtain information available by expanding existing research into statewide certification and training requirements, reviewing representative department practices, and analyzing ICC Job Center data. We may consider surveying some segments of our membership as well as direct engagement where clarification and further information is needed. As needed, we'll engage our membership councils and working groups, including our state code officials working group. We recognize that the information the Study is proposing to gather is not consistent from state to state, county to county, and city to city; this requires solid understanding of business practices and interpretation of data that only an experienced, well-rounded team can provide. It also requires the background to understand these nuances—background ICC possesses through our day-to-day engagement with these jurisdictions through our extensive government relations department and interactions with our members.

In terms of benchmarking best practices and employment characteristics, compensation, and fee structures, the Code Council would work with Ohio to determine several representative jurisdictions, and based on these selections, determine a comparable set of jurisdictions nationwide including but not limited to representatives from the Code Council's Major Jurisdiction Committee.

The Council plans to begin work upon contract commencement with continuing evaluation of the best practices, certification, compensation, qualification, fee, and state building departments throughout the balance of time prior to the submission of the report. The Council intends to provide the deliverable report as required by the estimated date of May 26, 2023.

#### Deliverables/Scope

#### **Best Practices – Nationally**

The study will include a summary and analysis of experience, examination, and certification requirements of building department personnel for agencies located outside of Ohio. The summary will be categorized by general employment categories such as: inspectors, plans examiners and building officials. Where requirements vary by discipline, we will document these variations.

In addition, we will identify any best practices discovered in the following areas:

- Efforts to recruit individuals from underrepresented groups.
- Trends moving toward privatization of code enforcement (e.g. self-certification and 3rd party/contract inspections, plan review, or building department services).

#### **Compensation Study – Ohio and Nationally**

The compensation study will establish appropriate benchmarking standards and conduct salary surveys for these positions including any specialties based on trade, i.e. structural, plumbing, electrical, fire protection, mechanical.

The study will review compensation plans (salary grade levels, steps and available benefits). The study research will include consideration and any special characteristic of the current challenges in recruiting and retaining employees. Where applicable, the Council will adjust compensation plans with relative cost of living and make that data transparent for discussion purposes.

ICC's Career Center, including its job posting board will also be queried to determine specific compensation characteristics of code enforcement personnel.

#### Fee Study – Ohio and Nationally

The study will include a summary and analysis of building department plan review and permit and/or inspection fees related to the delivery of professional service by the organization, including in Ohio-area departments and similar jurisdictions nationally.

The study will include information regarding the cost recovery of fee-related services of building departments. Where available by the jurisdictions, the overall cost recovery and a percentage of recovery will be provided.

The Council provides Building Valuation Data (BVD) and methodology to develop permit fees associated with construction and look at cost-based methodologies to determine service fees that will be provided as a function of the study. The BVD is updated at sixmonth intervals that provide the "average" construction costs per square foot, which can be used in determining permit fees.

#### **Position Qualifications – Nationally**

For comparative markets outside of Ohio, the study will include a summary and analysis of the job descriptions of building department code enforcement personnel, summarizing the specific characteristics and qualifications, including:

- Essential job functions
- Education/experience
- Knowledge/skills/abilities
- Working conditions (physical demands, work environment, and travel requirements)
- Certification/licenses/registrations requirements for the position(s).

The study will identify and note the differences by general code enforcement positions (building officials, plans examiners, and inspectors) and, where applicable, note any specialty or trade services such as structural, plumbing, electrical, fire protection, mechanical, and any other specialties that may exist though the evaluation.

The study will also note any trends because of the changing nature of construction and building safety industries.

This analysis will utilize ICC's Career Center, including its job posting board, along with member engagement as necessary.

# **State Building Departments – Nationally**

The study will include a summary and analysis of the above areas but with a focus on statewide level services supporting the built environment. The Council will leverage its involvement in code and standards adoption on a national level to identify all states that adopt codes statewide and where the state is involved in aspects of certifying jurisdictional agencies, and/or inspectors. The study will consider these state agencies with comparison to the State of Ohio Board of Building Standards.

This State-to-State evaluation includes any best practices regarding:

- Certification/licensing in code enforcement.
- Any trends moving toward privatization of code enforcement.
- Instances where reduced numbers of individuals are entering the construction and code enforcement trades and jurisdictional responses.
- Compensation of building department code enforcement personnel.
- State building department enforcement fees including, but not limited to application fee(s), inspection fees, and plans examination fees.

Several key Code Council staff, identified above, will work on this project, including staff with home offices based in Columbus, OH, and Las Vegas, NV. The work will be overseen by the officers identified as key personnel above.

The Council has more than 500 staff members. Should lead or key personnel become unavailable, staff adjustments can be made to meet the needs of the RFP.

Currently, we see no difficulty in meeting the project specification. If any difficulties arise during the evaluation period, we will contact the Board and resolve them proactively with the goal of meeting the study objectives.

#### Offeror's proposed compensation by deliverable

The below proposed compensation is based on the development and execution of a national survey; research and analysis of information that is publicly available or otherwise available to ICC; and interviews with departments as needed (e.g., where additional data that is not readily accessible is necessary for the analysis).

The below proposed compensation is based on research and analysis necessary to generate complete comparable sets of data, as requested by the RFP, for at least seven small, seven medium, and seven large representative jurisdictions nationwide, seven state code departments, and 12 Ohio jurisdictions (including major, mid-sized, and smaller jurisdictions). It is based on a salary review that considers low, median, and high benchmarks, and a fee review that considers fees for a residential structure and a commercial structure. The RFP seeks analyses of several questions on topics that are not publicly available or readily accessible that will require considerable outreach to generate representative responses (e.g., cost recovery, salary grade levels, trends in privatization in code enforcement, questions concerning challenges/best practices, etc.). In addition to surveying and reviews of readily availability information, the proposed compensation factors in the need for 15 interviews to address these questions.

ICC proposes compensation pursuant to a time and materials not to exceed agreement whereby ICC executive staff would bill \$330/hour, non-executive staff would bill \$275/hour, and external subcontractors \$260/hour, all of which are inclusive of fringe and indirect costs. We propose a project cap across all five deliverables of 125,000. This cap could be adjusted should ODOC consider reducing the number of representative jurisdictions considered and reducing the number of queries seeking information that is less readily accessible.

#### Summary

This study will provide the Board with scope of work from the RFP and best practices from jurisdictions from around the country as tools to address several factors that affect the industry in the State of Ohio. These factors include certification and code administration rules, compensation of personnel, training programs, promotion of shared services and regional intergovernmental cooperation, recognition of 3rd party and/or expanded special inspection, and service fees charged by building departments.

## Board of Building Standards Duties / Report Organization and Purpose

Revised Code § 3781.10(E) directs the Board of Building Standards to certify municipal, township, and county building departments and their personnel to enforce the administrative rules promulgated by the Board. As licensees of the Board, building departments and individuals certified by the Board are subject of review, investigation, and discipline by the Board for failure of proper enforcement of the Board's rules. Persons affected by the actions of Board-certified individuals and departments may file a complaint with the Board. Upon receipt of a complaint, Board Staff conducts an initial inquiry into the allegations and determines if there is enough basis to warrant further investigation. The complaint related to this report provided the basis for the Board to order staff to investigate.

This report provides a synopsis of the complaint, background, investigation findings, observations, applicable code requirements, as well as a conclusion and recommendation. This report provides adequate information to assist the Board in determining what actions, if any, it may take regarding evidence related to specific violations of the Board's rules. It does not address the rights or obligations of parties to any previous or pending enforcement action by a building department in the enforcement of the Board's rules. Parties should consult with their legal counsel regarding these matters.

## Allegation / Complaint Summary

On May 4, 2022, a complaint was received regarding the recent approval of the application of Andres Arocho, PI-interim on 2/25/2022 questioning the legitimacy of the experience indicated in his application and the concern that Mr. Arocho is not qualified to inspect plumbing systems. The complainant provided that an unnamed city employee was the source of the information providing that the experience listed by Mr. Arocho having worked for Fadenholz Plumbing for many years was falsified to ensure that he could be promoted to a plumbing inspector position within the City of Lorain Building Department. Board staff has contacted Mr. Arocho on May 10, 17, 18, and 24, and June 1, 2022, and requested that Mr. Arocho provide additional documentation to verify work experience since the complaint was filed. Staff provided a June 10, 2022, deadline for Mr. Arocho to provide tax, employment, or other experience verification records to the Board. As of this date, nothing has been submitted for review. Board staff have unsuccessfully attempted to contact Mr. Fadenholz to verify Mr. Arocho's work experience. Staff are also requesting investigation of those who provided Mr. Arocho assistance, mainly Mr. Velez who was alleged to have assisted him in preparing the application, and Mr. Fadenholz who apparently works for Luxury Heating Co. Inc., and who has and continues to employ Mr. Arocho, according to the current application. The City of Lorain Law Division has provided city records of Mr. Arocho's HR file on May 19,2022 and are looking into this matter also.

# Background

Mr. Arocho received his interim plumbing inspector certification on February 25, 2022. He has been working for the City of Lorain building department as a housing-property maintenance inspector for 3 years. His intent for seeking the Board certification was to become the backup plumbing inspector for the department where David Velez PI, is currently the primary plumbing inspector. Prior to the receiving the certification and the complaint, he had not performed any plumbing inspections. The other purpose for Mr. Arocho was seeking the certification for was to be mentored by Mr. Velez prior to his future retirement in December 2022, and to complete his testing for full certification.

#### Investigation Findings & Observations

Board staff interviewed Mr. Tim Fadenholz plumbing inspector #8496, on July 11, 2022. He indicated that Mr. Arocho was working with him as helper on projects to learn the trade and gain experience in plumbing installations. He said that they he is a licensed plumber who contracted with Lucas Plumbing, previously called Luxury Plumbing. Mr. Fadenholz did not have a company called Fadenholz Plumbing as Mr. Arocho indicated in the application for certification with the Board. He said Mr. Arocho helped on side jobs on an as needed basis, and he was not full time. He indicated that Mr. Arocho was paid in cash compensation.

Mr. David Velez, plumbing inspector #2277, was interviewed on July 12, 2022. He provided that his only involvement with Mr. Arocho's application to the Board was to review its contents to which he felt looked acceptable. At the time of the interview, Mr. Velez provided Mr. Arocho had not done any plumbing inspections for the city, largely due to the complaint sent to the Board of Building standards. City administration put those duties on hold until they learned more about the allegations.

Mr. Arocho, interim plumbing inspector #8773, was also interviewed on July 12, 2022, to discuss the allegations and the content included in his application. Mr. Arocho characterized his experience with Mr. Fadenholz as an alternative agreement for a learning opportunity. He worked part time on weekday evenings and weekends. He provided that 'Fadenholz Plumbing' worked for other companies as a sub-contractor and his work was direct with Mr. Fadenholz. He said he worked approximately 15 hours a week with him while working full time with the City of Lorain as a full-time city housing inspector. However, according to city records, Mr. Arocho' s Civil service application did not show his job with Mr. Fadenholz in the employment history section.

Board staff have made repeated attempts to encourage Mr. Arocho to provide additional information to clarify the information he provided in his application to the Board for the interim Plumbing Inspector certification. Letters, emails, and phone calls were made by Board staff between May 17, 2022, to August 25, 2022, to Mr. Arocho. Board staff also suggested that Mr. Fadenholz and Mr. Arocho request public records of those projects they worked on as indicated in Mr. Arocho's application to verify the experience claimed for approved projects by Board certified building departments as a means of substantiating the veracity of the work done. No further information has been provided by either party.

#### Code Requirements

4101:7-3-01 § (F) (7) (c) Residential and non-residential building department personnel certification.

(c) Grounds for revocation or suspension. The board shall revoke or suspend an individual's certification if the board concludes that the individual has committed one or more of the following:

(i) The practice of fraud or deceit in obtaining the certification.

(d) Revocation or suspension. In the event of suspension or revocation of a certification, the individual shall no longer hold out to the public or any jurisdiction that the individual is certified to exercise enforcement authority or holds the board certification which has been suspended or certification revoked. During a suspension, the certificate holder shall comply with the training, reporting, auditing, or other remedial action required by the board. In addition to such other authority the board may have, the board is authorized to revoke the individual's certification for failure to comply with such remedial requirements.

## Conclusion

Staff has documented that Mr. Arocho did not provide established employment history that could be verified through official documentation such as W-2's, 1099's, time records, copies of permits for the work claimed, or any other documentation required as listed in his Board application. Board staff requested initially to have received those types of documents by June 10, 2022. After further communication with Mr. Arocho who expressed desire to retain the certification, Board staff extended the deadline to August 25, 2022. In both cases, the certification holder did not respond with any information needed for verification to counter the allegations made by the complainant. Furthermore, the City of Lorain expressed concern that such work history was not listed in Mr. Arocho's Ohio Civil service application and that they were looking into this issue as well to determine if any action was needed at the City level. The outcome of this evaluation is not known. It appeared to Board staff that Mr. Fadenholz and Mr. Velez did not conspire in any way to assist Mr. Arocho in the completion of his application for certification, or to assist in fraudulent information to deceive the Board with its content.

#### Recommendations

Board Staff recommends closure of the investigation. Board staff recommends dismissal with no action against certification holders Timoteo Fadenholz, plumbing inspector #8496, and David Velez, plumbing inspector #2277. Board staff recommends a disciplinary action against Mr. Arocho to decertify the interim plumbing inspector certification #8773 of Mr. Andres Arocho, for failure to provide additional documentation as requested and required by Board staff for verification of his work experience as listed in his application dated January 29, 2022.

# Complaint and Investigation Consideration Status Report

To: Members of the Ohio Board of Building Standards (OBBS) for the November 18, 2022, Board Conference Meeting. The following is a list of submitted complaint(s) received after the previous Board meeting on October 21, 2022, for consideration of an action by the OBBS certification committee.

# New formal complaints:

A. John Perram, Plumbing Inspector #1153

On October 28, 2022, a formal complaint was received from Scott Schulke, Owner of S & S Contracting LLC, of Columbia Station, Ohio indicating that Mr. Perram was a behaving unprofessionally while performing a required inspection for a residential project located at 327 W. River Road. Mr. Schulke indicated that other contractors have experienced similar behavior and are now avoiding doing work in Medina County. Though Mr. Perram works for the Medina County Health District, he does hold OBBS certifications to enforce building codes.

Recommendation: Authorize investigation.

# B. Franklin Township/Columbus, Ohio

On October 27, 2022, a complaint was received from Jenn H., a concerned citizen, indicating that Ohio Building codes were not being followed for a salvage yard located at 2112 Eakin Road Columbus, Ohio, listed as KGC Freight. The complainant provided inspection citations that have been issued from 6/9/202 through 10/12/22 by the Franklin Township Fire Department. The owner has complied with older violations but is still being required for new. The authority having jurisdiction is the Fire department and they are currently continuing to monitor the property and violations. Any corrective measures in response to the violations cited by the Fire department that require building approvals would be enforced by the Franklin Township building department. Citations appear to be related to General means of egress and fire apparatus access into the site/buildings. Other citations include OFC violations of unsafe storage/stacking/combustible material requirements, fire protection systems and access to temporary unoccupied structures on the site. The Franklin County Zoning department is also involved with evaluating potential salvage operations violations.

<u>Recommendation:</u> <u>Dismiss complaint</u>. (Additionally, Board Staff will direct correspondence to Franklin County BD for coordination of enforcement where required related to Fire Department inspections/citations.)
