NB-1 Petition 21-01 (RCO Plumbing Code Reference)

Mr. Richards informed the Committee that the petitioner previously petitioned the Board to amend the Ohio Plumbing Code for installation of fittings which as approved and incorporated into the OPC. The petitioner is now requesting update to the reference of the Ohio Plumbing Code in the Residential Code of Ohio to changes made in 2018 rule package including the petitioner's approved language. Mr. Richards also summarized the other changes to the Ohio Plumbing Code that would also be applicable by referencing the 2018 OPC rule package changes into the RCO. After discussion, Mr. Phillips moved and Mr. Boeckermann seconded to recommend approval of the petition. Motion passed unanimously by roll call vote.

# NB-2 2021 IRC Review Preparation

Mr. Richards presented the list of significant changes to the 2021 IRC which the Committee will begin reviewing at the next meeting.

Mr. Johnson stated that he continues to participate in the ICC code development and that NAHB challenged ICC's process for the development of the 2021 IECC which partially led to IECC becoming a standard following ANSI-development process.
