The Commission has established time limitations of three (3) minutes per speaker on all items and an overall time limit of thirty minutes for nonagenda items. If more than 10 speaker cards are submitted for non-agenda items, the time limitation would be reduced to two minutes per speaker. If more than 15 speaker cards are submitted for nonagenda items, the first 15 speakers will be randomly selected to speak at the beginning of the meeting, with the remaining speakers given an opportunity at the end. (California Government Code §54954.3(b)). Pursuant to Government Code Section 54954.2, the commission is prohibited from taking action except for a brief response from the Council or staff to statements or questions relating to a nonagenda item.

The Oroville Planning Commission will review and provide comments on the construction of a new 72-unit apartment complex at 205 Table Mountain Boulevard (APNs: 031-053-067, 031-053-068, 031-053-071 through -076, 031-053-069, and 031-053-101). The subject property has a zoning designation of High-Density Residential (R-3) and a General Plan land use designation of Medium High Density Residential.
