#### 1. ORDINANCE TO LIMIT OR PROHIBIT THE SALE OF FLAVORED TOBACCO PRODUCTS IN OROVILLE

The Planning Commission considered recommending to the City Council adoption of changes to Title 17 of the Oroville Municipal Code in order to limit or prohibit the sale of flavored tobacco products.

Motion by Commissioner Sears and Second by Commissioner Flicker to recommend to council to take no action on the proposed Ordinance and to instead send a letter to the state to encourage quick adoption of regulations at the state level. Motion Passed.
