**Call to Order and Roll Call**

The Combined Bill Audit and Road and Bridge District Meeting of the Township Board was called to order by **Supervisor Schumann** in the Township Hall, 10802 S. Roberts Road, Palos Hills, Illinois at 6:34 P.M. Roll call was taken by the **Clerk** of the Township, **Jane Nolan**. Present were Trustees Brannigan, Riley and Woods, Supervisor Schumann and Highway Commissioner Adams. Also present was Township Attorney **Erik Peck** and Road and Bridge Administrative Assistant, **April Schrader**.

**Pledge of Allegiance**

**Supervisor Schumann** led the assembly in the Pledge of Allegiance.

**Disposition of Minutes from Previous Meeting**

**a. Approval of the Minutes of the Combined Bill Audit and Road and Bridge District Meeting – September 23, 2019**

**Trustee Woods** moved to approve the minutes of the September 23, 2019, Combined Bill Audit and Road and Bridge District Meeting. **Trustee Riley** seconded the motion. Roll call was taken. Ayes: Trustees Brannigan, Riley and Woods, Supervisor Schumann. Nays: None. Motion carried 4-0.

### a. Supervisor Schumann

#### 1. Authorization to Hire a New Health Service Employee

**Supervisor Schumann** reported that the new part-time employee at the Health Service is not an addition, she is a replacement.

He restated that Lindhal Bros Inc has received the contract for the paving for six to nine township roads depending on the time limit. BE IT ORDAINED by the PALOS TOWNSHIP BOARD, Cook County, Illinois as follows:

**SECTION 1 - INCORPORATION**

Heretofore, an ordinance entitled "BUDGET AND APPROPRIATION ORDINANCE FOR PALOS TOWNSHIP, COOK COUNTY, ILLINOIS, FOR THE FISCAL YEAR COMMENCING APRIL 1, 2019 AND ENDING MARCH 31, 2020 was duly passed and published according to law, there having been appropriated for the fiscal year beginning April 1, 2019 and ending March 31, 2020 the sum of ONE MILLION FORTY-ONE THOUSAND THREE HUNDRED SIXTY DOLLARS (\$1,041,360) for the General Town Fund and ONE HUNDRED EIGHTEEN THOUSAND NINE HUNDRED FIFTY EIGHT DOLLARS (\$118,958) for the General Assistance Fund for total appropriations for said fiscal year in the sum of ONE MILLION ONE HUNDRED SIXTY THOUSAND THREE HUNDRED EIGHTEEN DOLLARS (\$1,160,318) for the objects and purposes as set forth therein. Said Budget and Appropriation Ordinance as adopted on June 24, 2019 is incorporated herein by this reference.

## **SECTION 2 - TAX LEVY AMOUNT**

The PALOS TOWNSHIP BOARD, in accordance with the statutes in such case made and provided, has duly ascertained and hereby fixes and determines the total amount of appropriations for all corporate purposes legally made and to be collected from the tax levy for the current fiscal year to be the sum of \$965,800 for the Town Fund and \$136,000 for the General Assistance Fund, respectively, for a total levy in the sum of \$1,101,800.

## **SECTION 3 – TAX LEVY SUMMARY**

## **SECTION 4 – FILING**

The Township Clerk shall make and file a certified copy of this ordinance with the County Clerk of Cook County, Illinois, on or before the last Tuesday of December 2017.

## **SECTION 5 – SEVERABILITY**

If any section, subdivision, or sentence of this ordinance shall for any reason be held invalid or to be unconstitutional, such finding shall not affect the validity of the remaining portion of this ordinance.

### **SECTION 6 – EFFECTIVE DATE**

This ordinance shall be in full force and effect after its adoption as provided by law.

**GENERAL ROAD FUND LEVY**

General Road Fund, THREE HUNDRED SIX THOUSAND NINE-HUNDRED (\$306,900), needed for the several uses and purposes as follows, to-wit:

Making the amount to be raised by taxation and levied on all taxable property of said District for the uses and purposes aforesaid, for the General Road Fund, the sum THREE HUNDRED NINETEEN THOUSAND NINE-HUNDRED EIGHTY- FIVE (\$306,900).

It is hereby directed that said sum, if approved by the County Board of Cook County, or such part thereof as the said County Board shall approve, be and the same is hereby levied as General Road Tax against all the taxable property of said District for the year 2019.

**PART II**  
**SPECIAL TAX PURSUANT TO SECTION 6-601**  
**OF THE HIGHWAY CODE**

Pursuant to vote of the Electors of Palos Township Road District on December 13, 2001, and duly certified to the Clerk of Cook County, Illinois, all in accordance with Chapter 605, Section 5/6-601 of the Illinois Compiled Statutes (Section 6-601 of the Illinois Highway Code), a special tax for the purpose of constructing and maintaining gravel, rock, macadam or other hard roads, sometimes known as a Special Hard Road Tax shall be levied and extended by the Cook County Clerk on the taxable property of the Road District as equalized or assessed by the Department of Revenue.

It is hereby directed that the Clerk of Cook County, Illinois, shall cause such special tax levy as hereby certified to be extended on the tax books for the current year 2019 in the sum of FOUR HUNDRED SIXTY THREE THOUSAND ONE HUNDRED (\$463,100), all as required by Section 6-602 (605 ILCS 5/6-602) of the Highway Code.

We do further certify that pursuant to vote of the electors of Palos Township Road District on December 13, 2001, and duly certified to the Clerk of Cook County, Illinois, all in accordance with Chapter 605, Section 5/6-601, *et seq.* of the Illinois Compiled Statutes (Section 6-601, *et seq.* of the Illinois Highway Code), a special tax for the purpose of constructing and maintaining gravel, rock, macadam or other hard roads, commonly known as a SPECIAL TAX PURSUANT TO SECTION 6-601 OF THE HIGHWAY CODE shall be levied and extended by the Cook County Clerk. We do further certify that the sum of FOUR HUNDRED SIXTY THREE THOUSAND ONE HUNDRED (\$463,100) is the amount necessary to be levied and extended for said special tax on all the taxable property in said Road District for said purposes for the year 2019, as determined by the Highway Commissioner of said District.

We do further certify that the amount to be extended for the said special fund provided for herein is not more than 100 percent the amount extended for said tax in the preceding year.

We do further certify that said tax levy was determined by the Highway Commissioner on November 25, 2019, and adopted by this Board of Trustees on November 25, 2019, and that the same is now on file in the office of the Town Clerk and has no way been altered, amended or rescinded.
