APRIL 13, 2017

Call to Order

The General Meeting of the Palos Township Board was called to order by Supervisor Schumann in the Township Hall, 10802 S. Roberts Road, Palos Hills, at 6:38 P.M.

Roll Call

Roll call was taken by the Clerk of the Township, **Jane Nolan**. Present were Trustees Woods and Supervisor Schumann. Trustee Jeanes, with the approval of the Board, attended the meeting via telecommunication.

Absent: Trustee Riley

Trustee Brannigan She entered the meeting at 7:45 P.M.

Pledge of Allegiance

Supervisor Schumann led the assembly in the Pledge of Allegiance.

Supervisor Schumann stated that the citizens wishing to address the Board would take place next.

Mr. Ed Skrip, Palos Park, had questions concerning the current electric supplier the township had put in place for the unincorporated residents. Com Ed is now lower than the rate he has. **Supervisor Schumann** explained that energy rates fluctuate and then explained the situation. She will contact our supplier and call the resident back.

Mr. Skrip also had questions concerning the recent tax reassessment. All residents should appeal their taxes now. There are rising property taxes in Palos Township due to the quadrennial reassessment.

Mr. Skrip also questioned the status of the streets in McGuinnis Highlands. He stated that the streets in his area have never been re-surfaced. He did show pictures to the Board. (Bernice, Stephen and Walter Drives) A discussion followed.

Approval of Prior Meeting Minutes

a. Approval of Minutes – March 9. 2017

Trustee Woods moved to approve the minutes of the March 9, 2017, General Meeting. **Trustee Brannigan** seconded the motion. Roll call was taken. Ayes: Trustees Brannigan, Jeanes, and Woods, Supervisor Schumann. Nays: None. Motion carried 4-0.
