Roll call was taken by the Clerk of the Township, **Jane Nolan.** Present were Trustees Abuzir, Jeanes, Woods, and Supervisor Schumann, and Highway Commissioner Adams by telecommunication.

**Trustee Woods** moved to approve that Highway Commissioner Adams attend the meeting by telecommunication. **Trustee Jeanes** seconded the motion. The motion was passed unanimously.

# **Pledge of Allegiance**

Supervisor Schumann led the assembly in the Pledge of Allegiance.

# **Approval of Prior Meeting's Minutes**

**a.** Approval of Minutes of the Palos Township Board Meeting of September 26, 2022.

**Trustee Jeanes** moved to approve the minutes of the September 26, 2022 Township Board Meeting. **Supervisor Schumann** seconded the motion. Roll call was taken. Ayes: Trustees Abuzir, Jeanes, and Woods, and Supervisor Schumann. Nays: None. Motion carried 4-0.

# **Recognitions/Proclamations/Presentations/Communications**

**a.** Welcome Cook County Sheriff's Department and Recognition of their 100<sup>th</sup> Anniversary with a Proclamation from Palos Township.

**Attorney Peck** read the proclamation aloud. The proclamation was presented to the Sheriffs by **Supervisor Schumann**, and pictures were taken.

The Palos Township Board thanked the Cook County Sheriffs for all that they do and will continue to do. They will be sending Palos Township an oral history in the future.

- b. Motion to approve the Proclamation for the Cook County Sheriff's Department for their 100<sup>th</sup> Anniversary.
- c. Mr. Jim Seay Future Energy Program

Mr. Jim Seay discussed the electric aggregation program. He introduced his partner Mr. Brian P. Putkiewicz.

He stated that the price of energy from Com Ed was 11.4 and is now 11.8. He and his partner went to service companies for bids and they chose a company called MC2 which is one of the largest companies in the area and they came out with a rate of 9.19. This is a great rate at this time. It is a two-year contract which will start in March. They will start sending letters to the residents in the next 60 days. Brian and Jim will be available to answer any questions and to meet with residents concerning this.

The residents have the option to opt out at any time and go back to Com Ed at the end of the two-year period. Jim will go back to the supplier and renegotiate the contract along with including new suppliers. The contract must be signed tonight as the rates will rise tomorrow. Please forward any bills received to Jim Seay.

# **Reports of Officials**

a. Supervisor/Treasurer

**Supervisor/Treasurer** reported that the township is getting ready for the holiday distributions at both Thanksgiving and Christmas.

# b. Clerk

a. TOCC Notes on Symposium Saturday, September 24, 2022.

**Clerk Nolan** reported that she did attend this symposium. There were two break-out sessions.

One was about improving your Food Pantry and the other was about Township Foundation and the benefits of having one.

Some of the point stated were:

- 1. Township Foundations provide additional surveys to residents, and provide a way residents can give donations.
- 2. Foundations may engage in activities that are outside of the scope of township authority.

- 3. The Foundation does not "belong" to the township.
- 4. There are no "private benefits" included and there is no lobbying or political activity.
- 5. Getting involved in a foundation requires a good amount of work.
- 6. The township can give nothing to the foundation, but the foundation can give to the township.

There was also a Legislation Forum at the beginning of the symposium. Two state representatives spoke and answered questions.

Some of the things they feel townships can do to become more involved with their state representatives are:

- 1. Have zoom meetings with your state representatives.
- 2. Tour your township with your state representatives.
- 3. Ask your representatives the way to access grants.
- 4. Tell your representatives if there is a problem.
- 5. Show how your services are provided for at your township.
- 6. Improve your food pantries
- 7. Reach out to your representative for help to partner with state agencies.
- b. Notes from Cook County Elections Operation Center Tour and Information.

**Clerk Nolan** attended this tour and information event in Cicero, Illinois. She reported that it was a fantastic tour where she was able I to see how our elections are run and learn new concepts. The most impressive speaker spoke about mail ballots.

Some of the points of importance were:

- 1. Residents can track their mail ballot.
- 2. You will get an e-mail after they receive your ballot.
- 3. If you change your mind you can vote in-person as long as your ballot has not been returned.

4. There are secure boxes at all Early Voting places where you can leave your ballot and it will be date stamped.

Cook County has 803 polling places, 1400 precincts, and 54 Early Voting Sites.

# c. Highway Commissioner Adams

**Highway Commissioner Adams** reported that they have been doing some road surfacing lately. The Road District was not able to get material all summer due to the strike. There is a contractor who bore a hole through the bypass pipe at 130<sup>th</sup> Street which caused an obstructed and then caused a great deal of flooding. The bypass pipe from the creek was installed around 130<sup>th</sup> Street which eliminated the flooding in that area. This was the fault of AT & T. The Road District is working to get our money returned from them.

Th Highway District has come to a conclusion concerning 133<sup>rd</sup> Street. MWRD has now said the money for the Road District project will be \$130,000 instead of \$100,000.

The project should be done by the end of the year.

### **ORDINANCES vs RESOLUTIONS vs PROCLAMATIONS**

ORDINANCES establish a permanent rule of conduct, which will be in force/effect until changed or repealed by another ordinance.

-once passed, it becomes township law.

-formal expression of authority

-violation of an ordinance can be punishable by forfeiture, fine or imprisonment

Examples: Budget & Appropriation Ordinances

Township Road District allowing/prohibiting parking on streets

Township placement of signs prohibiting the carrying of concealed firearms

RESOLUTIONS will not always be intended to have a continuing effect.

-no forfeiture or penalty if there's a violation

-written expression of an opinion

-simply a statement agreed upon, with regard to, a certain proposition or to establish a policy

-may be considered a "one-time" proposition

-may be used to place a referendum on the ballot in an upcoming election

-bestow authority to take certain action

-designate someone to transact business

-may be used to show support of some idea or to honor an outstanding individual

**Examples:** Payroll Resolutions

Support of "Seeing Motorcycles" campaign

Intergovernmental Agreements

One-time transfer of monies from Town to Road District

### PROCLAMTIONS

-that which is proclaimed or announced officially (Webster's Unabridged Dictionary, 1966)

-to announce or make known publicly or officially; declare (Webster's Collegiate Dictionary, 2002) -to make plain, manifest -to praise laud

-to praise, laud

-look under "Declaration" (Merriam-Webster Thesaurus 1989)
