Supervisor Schumann led the assembly in the Pledge of Allegiance.

Approval of Prior Meeting's Minutes

Reports of Officials

a. Supervisor/Treasurer

1. 2019 Tax Appeal Outreach Palos Township Hall August 6, 2019.

Citizens Wishing to Address the Board

The following protestors, activists and residents addressed the Board.

Speaker #1

This speaker read from a long statement which began with “Dear White America...which went on and on about many things that happened over the years which she considered racist and the fault of “White Americans!”

Speaker #2

Hasam

Stated he had four or five questions he wanted the Board to answer. He was told this was not a questions and answer session. He said he received two invoices from the former security firm. The Board paid for 5 officers when they only saw 3. Where were the other 2? (they were there) He thinks this money could be used to get a better sound system or a larger room for the protestors, activists and residents to inhabit. Once again, he stated that the Clerk, Jane Nolan, (me) did not give him the last FOIA he requested on time. This is not true! (me) I have the returned FOIA to prove it as it was returned by the post office. It did not have the complete address. It was sent to the address that was listed. He did receive a second copy, but still will not come and see the original (which I have). This is obviously an incorrect accusation!

Speaker #3

This young girl was talking very loudly about the last two shootings, and screaming about language (?) of invasions and issues of white supremacy. She kept talking about what Trustee Brannigan said once again and slamming her and Commissioner Sean Morrison.

Speaker #4

The man stated that there is too much criticism against Trustee Brannigan. He feels only hate is left. The protestors and activists shut down arguments because they want to win. He stated that Mayors, City Officials, Congressmen, etc. should attend to see this for themselves and work for a solution.

Speaker #5

This resident stated that he has been coming to meetings for the last 16 months. He stated that all Americans are allowed to voice their opinions even if their comments may offend someone else. There are elections and discussions to stop meetings is not correct. He applauds the Trustees for standing up for that right.

Executive Session

No motion was made to enter Executive Session.

Adjournment

With no further business to come before the Board, **Supervisor Schumann** asked for a motion to adjourn the meeting. **Trustee Brannigan** moved to adjourn the meeting at 6:48 P.M. **Trustee Jeanes** seconded the motion was passed unanimously. Meeting adjourned.
