#### 5. Highway Commissioner's Report

**Commissioner Adams** informed the Board that the Road and Bridge District made it's final payment of \$35,000.00 to the Town Fund for the loan they received. The loan was due April 1, 2016, and is paid up now.

**Commissioner Adams** stated that the lawsuit is moving forward, but he has no new details at this time as Attorney Peck is not present.

Commissioner Adams discussed another issue with a concrete driveway which does not meet the Road District's specifications. This driveway is located at a residence on 82nd Court in unincorporated Orland Park. The new engineer from Morris Engineering is studying the paper work and original set of plans for this property. The original set of plans were approved by the Road District, but never submitted by the owner of the property. The owners never took out a permit, as they were supposed to do, but they just went ahead and did the work. Cook County allowed them to move into the residence. The Road District Attorney will have to deal with this issue as will the Road District.

There was a short discussion of trench drains which Commissioner Adams does not accept.

**Commissioner Adams** informed the Board of some details from a presentation concerning salt. This presentation took place at the Highway Commissioner's Association Meeting.
