Call to Order

The General Meeting of the Palos Township Board was called to order by Supervisor Schumann in the Township Hall, 10802 S. Roberts Road, Palos Hills, Illinois at 6:30 P.M.

Roll Call

Roll call was taken by the Clerk of the Township, **Jane Nolan.** Present were Trustees Brannigan, Riley and Jeanes, Supervisor Schumann. Also present was Township Attorney, Erick Peck.

At that point, all the protestors and activists began loudly yelling, "Hey, Hey, Ho, Ho Sharon Brannigan has to go." Some were screaming "you can't put us in jail." They all left the meeting escorted out by security and continued their protest outside. The meeting resumed at this time.
