FEBRUARY 11, 2019

Call to Order

The General Meeting of the Palos Township Board was called to order by Supervisor Schumann in the Township Hall, 10802 S. Roberts Road, Palos Hills, Illinois 60465 at 6:30 P.M.

Roll Call

Roll call was taken by the Clerk of the Township, **Jane Nolan**. Present were Trustees Brannigan, Riley and Woods, Supervisor Schumann. Also present was Township Attorney, Erik Peck.

Absent: Trustee Jeanes

Pledge of Allegiance

Supervisor Schumann led the assembly in the Pledge of Allegiance.

Approval of Prior Meeting's Minutes

a. Approval of Minutes – General Meeting January 14, 2019

Trustee Woods moved to approve the minutes of the January 14, 2019, General Meeting. **Trustee Brannigan** seconded the motion. The motion was passed unanimously.

Special Presentations/ Communications

There were no special presentations or communications at this meeting.

Reports of Officials

a. Supervisor/Treasurer

Supervisor Schumann reported that the Township received a "Souper Bowl" food delivery on February 12, 2019, from Palos West Elementary School. Palos East Elementary School did not donate this year, as they usually do. They donated to a different organization. She also reported that June 15, 2019, will be Township Day and the township will have their Health Fair on that day.

b. Clerk

Clerk Nolan stated that she will be sending the TOIPAC donation to TOI in Springfield tomorrow as she is waiting for the last donation.

Clerk Nolan also reported that she did attend the most recent TOCC Clerk's meeting in Niles Township.

Attorney's Report

Attorney Peck stated that he was unable to address the Attorney General's (Access Counselor) response to the recent alleged violation of the Open Meetings Act by the Township due to the meeting noise.

Reports of Standing Committees

a. Finance and Administration - Trustee Woods

Trustee Woods stated that he is working on the township budget, and he will have the partial document completed within a month or two.

b. Policy and Personnel - Supervisor Schumann

1. Re-appoint Patrick Lorenz to the Roberts Park Fire Protection District Board of Trustees

Trustee Woods moved to approve the re-appointment of Patrick Lorenz, Trustee, to the Roberts Park Fire Protection District. **Trustee Brannigan** seconded the motion. Roll call was taken. Ayes: Trustees Brannigan Riley and Woods, Supervisor Schumann. Nays: None. Motion carried 4-0.

Trustee Riley reported that the internet speed will be doubled on the township computers through Comcast.

d. Buildings and Grounds – Trustee Jeanes

One of the main leaders did not engage in the meeting this time, but she did attend.
