Clerk Nolan stated that this Democracy Update discussed the record number of primary election voters, (114,021), age of early voters, (72% were 50 years or older), busiest voting sites, the number of people who registered and voted on election day, (23,110) and also the percentages and ages of those who registered and voted on election day.

quote. It is a about \$2,000 to \$3,000 less than the GTSAC quote. He explained how the wiring will be installed. The total amount of money for project, labor and materials is \$5,067.60.

Subject: Democracy Update - May 2, 2016





#### Dear Friends,

I would like to announce the release of my office's <u>Post-Election Report</u> for the March 15, 2016 Presidential Primary. This year's primary shattered modern-day records dating more than 25 years. The popularity of initiatives such as Online Voter Registration and Election Day Registration, as well as 17-year-old registration and voting, proved there is a great desire by voters to take part in the electoral process. My staff analyzed the results from the primary election and produced in-depth analyses, charts, maps and graphs to spotlight the voting results and trends in Suburban Cook County.

#### Among the highlights in the report are:

- Voting before Election Day by mail, or during early voting and grace period voting - accounted for 22 percent of all ballots cast in this election.
- Early Voting set a new primary record with 113,641 ballots cast in a Presidential Primary.
- More than 23,000 suburban Cook County voters took advantage of Election Day Registration.

- Nearly 4,400 17-year-olds voted, accounting for 62 percent of the 7,085 17-year-olds who registered to vote.
- About 80 percent of voters who requested a mail ballot did so online.
- In the 90 days leading up to Election Day, more than 21,000 eligible suburban Cook County residents registered to vote online.
- Donald Trump won 25 of the 30 Suburban Cook County Townships, garnering his best total in Stickney Township, with 62.1 percent of the vote.
- Hillary Clinton received more votes than Sen. Bernie Sanders in 16 of suburban Cook County's 30 townships.
