# **Citizens Wishing to Address the Board**

The protestors/activists had started screaming and chanting before this meeting even began. They came with signs which each had a flower attached to it, and included the name of a person murdered in the New Zealand Massacre. They screamed that hate speech was responsible for killing all those people, and that the Board is responsible because it promotes "hate speech." Several in the audience screamed "You are murderers." It then turned into the usual chanting of "Hey, Hey, Ho, Ho! Sharon Brannigan has to go!" That was followed by "Racists Go Home!"

One resident tried to speak but could not as some of the group were screaming "Hate Speech Killed Me!" Several others attempted to speak and were told they should be censured. There was a person speaking at the microphone concerning the constitution and declaration, but the loud roar made it impossible to hear him.
