Tabitha Pollard, Finance Director, stated four participants turned in bids on July 8, 2022. This project will extend fiber optics from the Coppermine Sewer Plant to Taylor Farm Park, which will provide wi-fi to the public at the park. Ms. Pollard further stated that 36,000 feet of fiber will be installed between the two locations.

7. Public Hearing to receive comment concerning the FY2023 Proposed Budget:
Chairman Carmichael opened the Public Hearing. Tabitha Pollard, Finance Director presented a presentation and handouts of the information for the FY2023 proposed budget.

**George Jones, Transportation Director,** stated this property is for the construction of a single lane roundabout. He stated that although this project is on two State highways, SR101 and SR120, this is an important route for the County's citizens. He further stated the County should move forward with the project.

12. Purchase of two new pumps in the amount of \$187,781.16 from Xylem Water Systems USA, Inc. to replace pumps at Seven Hills Pump Station. Located in Post 4, funding will be from Water Capital funds:

Discussed action to approve the purchase of two new pumps in the amount of \$187,781.16 from Xylem Water Systems USA, Inc. to replace pumps at Seven Hills Pump Station. Located in Post 4, funding will be from Water Capital funds. Laurie Ashmore, Water Systems Director, stated we have received quotes for the repair of the old pumps and replacement of the old pumps. The cost of repair is approximately 80% of the cost to replace. The price of each new pump is \$86,390.58. Ms. Ashmore requests the Board of Commissioners approve the purchase of the two new pumps which also includes \$15,000.00 for shipping the pumps.

Chairman Carmichael asked what is the life span of the pumps.

Ms. Ashmore stated they typically last 20 to 25 years.

Commissioner Dunn asked about a Manufacturer's Warranty.

**Ms. Ashmore** stated the following: 100% warranty for the first 18 months, 50% warranty on 19 months to 39 months, and 25% warranty on 40 months to 60 months. There is a Xylem repair shop locally, if repairs are needed.

**Commissioner Kaecher** asked where the pumps are coming from.

Ms. Ashmore stated from Sweden or Norway.

**Commissioner Stover** asked if the pumps can be shipped from somewhere in America.

**Ms. Ashmore** stated the Xylem Pumps are manufactured overseas.

**Commissioner Stover** asked if there are any comparable American made pumps.

Ms. Ashmore stated there is not.

This project will last approximately three and a half years.
