23. Adopt Ordinance 23-01 Amending Chapter 6 of the Official Paulding County Code to provide for the Issuance of Packaged Distilled Spirits Licenses and to provide amendments to the Chapter consistent with State Law:

Discussed action to adopt Ordinance 23-01 Amending Chapter 6 of the Official Paulding County Code to provide for the Issuance of Packaged Distilled Spirits Licenses and to provide amendments to the Chapter consistent with State Law. Jayson Philips, County Attorney stated this is a new Ordinance that will regulate the package sales of Distilled Spirits, also known as Liquor. It was placed on the ballot in 2022, 73% of Paulding County voted to allow the sale of Distilled Spirits in the unincorporated parts of Paulding County. There will be two (2) Package Stores allowed in the County, one in the Cedarcrest/Seven Hills area and one in the New Georgia area. Applications to own and operate one of the Package Stores will be taken for sixty (60) days starting March 6, 2023. Each applicant must meet several qualifications. Once the application period closes the Marshals Beareu and Community Development will review the applications to insure all of the requirements are met. If there are multiple applicants that qualify one applicant will selected by the Alcohol License Review Board through a Lottery System. State Law provides what type of products can be sold. These stores will be allowed to sell alcohol, alcohol related products, mix products as well as cigars and cigarettes. Mr. Philips further stated this Ordinance will insure everything in the current code is consistent with State Law.

Discussed action to approve the Water System to partner with SERVLINE to provide Leak Insurance. Ray Wooten, Interim Water Systems Director stated in the past the County has had a certain way of treating those with high water bills due to a leak. SERVELINE has been working with 42 municipalities through out the State of Georgia. This will provide a \$2,500.00 adjustment from a leak to be handled by SERVELINE. If a residence is on both County water

and sewer they would be eligible to receive \$2,500.00 for each. The cost would be \$1.10 per month for water only residence and \$1.70 per month for water and sewer residence.

Commissioner Stover asked if proof the leak has been repaired by a plumbing company is required or can the homeowner repair the leak themselves.

Mr. Wooten stated a summary of the usage would tell if the leak was repaired, then you would turn your receipts for materials to SERVELINE for reimbursement.

Chairman Carmichael asked if we are ahead of the game getting Leak Insurance compared to the other surrounding municipalities.

Mr. Wooten stated forty-two (42) other municipalities currently have Leak Insurance, including Bartow and Polk County.

Commissioner Galloway asked if the \$2,500.00 adjustment would only be allowed for one (1) leak, per year.

Mr. Wooten stated it will cover a three month period up to twice a year.

Frank Baker asked if it is per meter.

Mr. Wooten confirmed it is per meter.

Commissioner Stover asked if it is only for Residential.

Mr. Wooten confirmed it is strictly for Residential.
