SUBJ: VEHICLE AND EQUIPMENT QUOTES

- 1. Per your directive I procured the quotes on the below vehicles and equipment.
- 2. I received a quote from a state contract vendor, Peach State Truck Centers, for a 2019 Freightliner M2 112 with a 30 ton roll off hoist. The price as quoted is \$144,128. This purchase will begin replacing our aging fleet of Volvo roll off trucks most of which have more than 600,000 miles and are beginning to need more expensive repairs more regularly. We currently have one truck down with a bad Engine Control Unit and estimated repair cost is over \$4000.00. The trucks are one of the most heavily used heavy trucks in our fleet based on their utility.
 - a. For comparison I also received a quote from a non-state contract holder who is a NJPA contract holder, MHC, on a similar truck, a 2018 Kenworth T880 with 30 ton roll off hoist. Price as quoted \$151,489, a \$7361.00 difference in price.
- 3. I received quotes on the renewal of the right of way mowing equipment lease which expires in July of this year. I received quotes from AgPro, Madison GA (John Deere), Atlantic & Southern, Tifton/Lakeland GA (Massey Ferguson), and Atlanta Kubota, Marietta GA (Kubota). Each company listed is state contract holder for their respective brands. All quotes were for 90hp, 2 WD agricultural tractors with air conditioned cabs capable of operating the 6 foot rotary cutters we currently operate and any future mowers we could potential utilize. The leases were all 3 year terms with 900 hours (Massey quoted 1000 hours) with extended warranties and an "up time guarantee" (provides a comparable machine in the event our machine is in at the dealership for more than 5 days)
 - a. AgPro provided a quote on the state contract for 4 John Deere 5090E series tractors for \$48,898.91 annually. These are the base model John Deere machine.
 - b. AgPro also provided a quote on 4 John Deere 5090M series tractors for \$46,024.52 annually. The AgPro representative explained the current cost difference were several incentives available through John Deere on the M series machines. It is also worth noting we current operate M series tractors. AgPro is also a far more local business with a mobile service vehicle available in the event one of our machines go down in the field.

- c. Atlantic & Southern provided a quote on the state contract for 4 Massey Ferguson 4709 tractors for \$49,070.68. There is not a servicing dealership within reasonable distance; however, the representative advised the company operates a mobile service vehicle. It was explained there would be a cost associated with this service that would not be covered under the warranty.
- d. Atlanta Kubota provided a quote on the state contract for 4 Kubota M5-091 tractors for \$42, 954.72. There is a servicing dealership for warranty repair and parts but in order to take advantage of the "up time guarantee" we would be required to use the dealership where we purchased the tractors. The cost of transporting the machines to Marietta could potentially get exorbitant quickly. Also these tractors are equipped with a front end loader as specified by the state contract. We feel the loader would be an issue for the application for which we use the tractors. Additionally the dealer retains the right to replace the tractors at any time during the lease potentially creating additional costs for damage we have not had the opportunity to repair ourselves.
- e. I feel we should go with the John Deere 5090M tractors even though they are not the lowest of the quotes. My decision is based on our familiarity with the John Deere equipment, proximity to service center, parts availability, and the fact that our seasonal mowing equipment operators are familiar with the John Deere equipment.
- 4. I received quotes on remote trench roller/compactors from 3 suppliers. After a diligent search of the Team Georgia webpage (houses all state contracts), I was unable to find a contract price or dealer for this particular piece of equipment. I received quotes from Lake Oconee Rental Eatonton GA, Yancey Rents (rental division of Yancey Bros) Macon GA, and Flint Equipment, Macon GA. All quotes were for a 2018 Bomag BMP-8500 trench roller. This piece of equipment is vital the replacement of under road culvert pipes.
 - a. Lake Oconee provided a quote of \$31,500.00. They are not a servicing dealer in the event we have a warranty repair.
 - b. Yancey Rents provided at quote of \$31, 250.00. They are an authorized dealer and would be able to perform warranty repairs.
 - c. Flint Equipment provided a quote of \$31,000.00. They are an authorized dealer and would be able to perform warranty repairs.
 - d. Based on the quoted price and previous experience with Flint Equipment, I recommend we make purchase from them.
