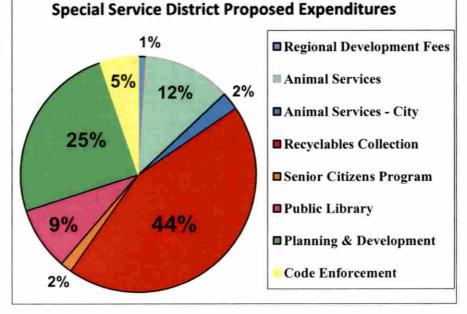

Public Notice

The Putnam County Board of Commissioners has established a Special Service District composed of the unincorporated area of Putnam County to comply with recent agreements between the County and City. The intent of the Special Service District is to ensure services provided primarily for the unincorporated area and services jointly funded with the City are funded with revenues generated from the unincorporated area. After applying revenue generated from these services, the Board of Commissioners need to levy a Special Service District millage rate of .355 to generate \$433,454 in tax revenue. The proposed tax levy on a non-homestead home with a fair market value of \$100,000 would be approximately \$14.20. The millage rate will be set at a meeting to be held at the Putnam County Administration Building, 117 Putnam Drive, Eatonton, GA on September 7, 2018 at 9:00 a.m.
