#### 8. COVID-19 Impact Discussion (BW)

Sheriff Howard Sills gave the current statistics for the number of people in Georgia with the virus and stressed that this is a "real thing." He stated that if he wasn't Sheriff he would be at home. He advised that he held a meeting yesterday with emergency personnel and heads of government. As of now courthouse services are normal, however, the Chief Judge has issued an order to postpone jury and grand jury trials. Also, the Sheriff's office will not close. He advised to contact your normal doctor if you feel you might have the virus or call 1-866-PUB-HLTH. Putnam General Hospital does have test kits; however, the tests are sent to a lab and take several days for results. The Governor originally asked for meetings to limit to no more than 50 people and that has now changed to 10. Everyone is being asked to self-quarantine ourselves as best we can for the next 8 weeks. If you know of mass events, let the Sheriff know. He also asked the commissioners to pass a resolution declaring a state of local emergency.

Tax Commissioner Pam Lancaster requested an extension for the due date of mobile home taxes to May 1, 2020. The normal due date is April 1st. She also advised that the Tax Commissioner's office is open for now, but subject to change.

#### **Called Meeting**

2. Update from Sheriff Sills (BW)
Sheriff Sills made the following statement. No action was taken.
"The Office of Sheriff carries with it the **duty** to preserve the peace and protect the lives, persons, property, health, and morals of the people."

That sentence was written by the Supreme Court of Georgia long ago and it established in Georgia Law what a sheriff has a duty to do. Georgia Law prescribes and authorizes various other law enforcement agencies and departments of government the authority to enforce certain laws within certain jurisdictions, etc., but only the sheriff has the aforementioned solemn duties. On Saturday evening I leisurely sat on my back deck enjoying the warm temperature while grilling pork chops for me and my wife. The trees in the back yard were all greening up and the dogwoods, azaleas, and other shrubs were in bloom. With the exception of a little pollen, it was the perfect Middle Georgia springtime day, but I was consumed with worry as never before. Next month I will begin my 47th year in law enforcement, and over these many years I have been exposed to many very dangerous situations. The grace of God coupled with my education and training has kept me from serious injury and enabled me to successfully manage every crisis I have faced during my career, but Saturday evening I found myself faced with a new kind of enemy, an enemy I can't arrest, an enemy I can't even see to shoot. That enemy of course is the Coronavirus/COVID-19. I felt nothing but guilt for lounging at home while the people of my community, whose lives and health I had the duty to protect, are in grave danger from this dreaded disease, but I simply didn't know what I should do next.

The President of the United States and our Governor have very explicitly told the public they need to stay at home for the next few weeks. To my knowledge, almost all of the schools in the nation are closed. The CDC and Georgia Dept. of Public Health have repeatedly warned us to frequently wash our hands, disinfect surfaces, and practice social distancing, along with a myriad of other warnings and suggestions. Yet as I traveled around our county on Saturday I saw far too many people simply going about their business and entertainment as nothing was afoot. I found at least 8 different restaurants operating with their dining rooms open. A couple of local fitness centers were also open as usual. I saw many other people at various locations all around the county who were engaged in anything but social distancing.

After dinner on Saturday, I decided I should call someone for advice about our present crisis, someone who I have absolute confidence in. I spoke at some length with one of the most respected pulmonologists in this state. This doctor is a little older than me and has practiced medicine for over 40 years. I only asked him two questions. The first question was could I do anything more than the procedures and prophylactic measures already given to me by the CDC and Health Dept. that could help protect my officers, staff, and prisoners in my jail during this pandemic. His response was a simple no, but said to utilize the protective procedures to the greatest extent possible. My second question was did he know of anything I should be doing as the sheriff of my county to protect the people. Again, his answer was relatively simple. He said, "Do everything you can to get people to stay at home and not spread this disease!" But he followed that up by saying, "I'm scared, I'm really scared that if something isn't done to slow the spread of this virus down, it's literally going to completely overwhelm our hospitals and medical systems' ability to handle it." That answer struck me like a slapjack to my forehead. With that response firmly implanted in my mind, I expressed my thanks to him for taking time to advise me and also expressed my thanks for all the professionals like him for their courage and dedication while being on the front line during this very dangerous time in our nation's history.

I am going to my county commission meeting this afternoon and will tell them that I believe it is now the time for them to pass some resolution that will legally restrict public gatherings and require everyone who possibly can, to stay at home and do so for at least the next couple of weeks. I will be asking the Mayor and Council of the City of Eatonton to promulgate a similar resolution, if it is legally necessary for them to do so. I think many public officials fear political backlash to ask for what many will immediately proclaim to be an unnecessary draconian measure like this. I have never been afraid of controversy, and I'm more than willing to take the heat from those in the public who will disapprove of my actions. Furthermore, I am fully confident in my resolve that it is my duty to stand up and request such measures at this juncture in time.

I implore you, I beg you, for the sake of your families, friends, and neighbors, please stay at home and follow the instructions of our medical professionals just as much as humanly possible for the next couple of weeks.

May God bless and guide us during these troubling times.

3. Public Health Discussion (BS)

County Nurse Manager Peggy Pettit gave the following update. No action was taken.

- 11 confirmed cases of the Coronavirus in our district
- Health Department does not do testing or collect samples physician must send in request for testing, testing only high-risk people: over 65, people taking care of elderly, working in nursing homes, jails, prisons, or in nursing homes, jails, prisons
- if you have symptoms stay at home for 7 days, including 72 hours after last fever
- if you come in contact with someone with the virus stay at home for 2 weeks
- Health Department is limiting services, limiting visits to 10 minutes or less
- Environmental Services handling items with the least contact as possible
- asking patients to wait in vehicle
- screening every person and asking pertinent questions

In addition, Chairman Webster provided an update from Putnam General Hospital: tested 5 people; all negative.

#### **RESOLUTION DURING LOCAL STATE OF EMERGENCY**

WHEREAS, on March 13, 2020, the President of the United States declared the ongoing Coronavirus Disease 2019 (COVID-19) pandemic of sufficient severity and magnitude to warrant an emergency declaration for all states pursuant to Section 501(b) of the Robert T. Stafford Disaster Relief and Emergency Assistance Act, 42 U.S.C. 5121-5207; and

WHEREAS, on March 14, 2020, Georgia Governor Brian Kemp declared a public health emergency for the State of Georgia, which was ratified by the Georgia General Assembly on March 16, 2020; and

**WHEREAS**, on March 16, 2020, the Mayor and Council declared by unanimous vote that a state of local emergency exists within the City of Eatonton; and

WHEREAS, on March 17, 2020 the Board of Commissioners of Putnam County adopted a resolution declaring a state of local emergency; and

WHEREAS, pursuant to O.C.G.A. § 38-3-28, the Board is authorized to provide for the health and safety of persons and property and to direct and coordinate the development of emergency management plans and programs in accordance with the policies and plans set by the federal and state emergency management agencies; and

WHEREAS, the CDC expects that additional cases of COVID-19 will be identified in the coming days, including more cases in the United States, and that person-to-person spread is likely to continue to occur; and

WHEREAS, on March 16, 2020, the CDC advised that during the next fifteen (15) days, all events in the United States of ten (10) or more people should be cancelled or held virtually; and

WHEREAS, the current number of COVID-19 cases in Georgia is 1026 with 32 deaths and those numbers are increasing daily; and

WHEREAS, medical professionals have advised that if COVID-19 continues to spread in Georgia at a rate comparable to that rate of spread in other affected areas, it may greatly strain the resources and capabilities of county and municipal governments, including public health agencies, that provide essential services for containing and mitigating the spread of contagious diseases, such as COVID-19, and the situation may become too large in scope to be handled in its entirety by the normal county and municipal operating services in some parts of the State, and this situation may spread to other parts of this State; and

WHEREAS, it has been evidenced that some people within Putnam County continue to congregate in large numbers in enclosed spaces where social distancing cannot be effectuated; and

WHEREAS, to prevent or minimize injury to people resulting from this pandemic, we find that certain actions are required, including but not limited to, the social distancing measures set forth herein; and

WHEREAS, the Putnam County Board of Commissioners most stringently urges all citizens who are able to stay at home, to do so and comply with all of the directives and practices that have been disseminated by our healthcare providers.

#### NOW, THEREFORE, BE IT RESOLVED, as follows:

- That, all public or private community gatherings of more than ten (10) people anywhere within Putnam County, Georgia are prohibited for the duration of the declared state of local emergency. A community gathering is defined as any indoor or outdoor event or convening, subject to the exceptions below, that brings together or is likely to bring together ten (10) or more persons at the same time in a single room or other single confined or enclosed space, such as an auditorium, stadium (indoor or outdoor), tent arena or event center, music venue, meeting, hall, conference center, large cafeteria, or any other confined indoor and outdoor space. A community gathering does not include the following or similar uses, so long as persons attending the community gathering are generally not within six (6) feet of each other for extended periods: (1) office or manufacturing space, childcare facilities, residential buildings or any type of temporary sheltering or housing; (2) grocery stores or pharmacies; and (3) hospital or medical facilities.
- 2. Notwithstanding the previous paragraph, the following business-use categories will be regulated as follows: (1) restaurants open to the public shall close except to provide take out, drive-through, or curbside service to include alcoholic beverages in sealed containers which they are otherwise licensed to dispense; (2) all business locations with on-premises consumption of alcoholic beverage licenses which are not also restaurants shall be closed for business; (3) all establishments providing body care services which require close physical contact between the provider and client such as barbering, hair design, cosmetology, esthetics, massage therapy (except for medically licensed physical therapy), tattooing or nail care shall be closed for business; (4) all indoor recreation facilities, to include gyms, health studios, indoor amusement facilities, pool halls and theatres shall be closed for business; and (5) all other retail sales establishments (including grocery stores or pharmacies addressed above) will be permitted to remain open.
- 3. Cafeterias in hospitals, nursing homes, or similar facilities shall not be subject to these restrictions and may continue normal operations.

These emergency ordinances shall become effective beginning on March 25, 2020 at 12:00 p.m. and shall remain in effect until April 6, 2020 at 12:00 p.m. unless further extended by further action of the Board and is not intended to, and does not, create any right or benefit, substantive or procedural, enforceable at law or in equity by any party against Putnam County, Georgia, its departments, agencies, or entities, its officers, employees, or agents, or any other person.
