6. Request by W. David (Danny) Copelan to rezone 5.00 acres from AG to C-1 at 931 Pea Ridge Road [Map 092, Parcel 017001001, District 2] (staff-P&D)

(2) Additional right-of-way to accommodate the deceleration lane and a ten-foot shoulder shall be dedicated by the developer to the county.

10. Discussion and possible action concerning a one time lump sum payment to the Sinclair Water Authority (BW)

Chairman Webster explained that the BOC was asked to put up \$250K to match Baldwin County's \$250K for work on the Sinclair Water Authority plant and for the purchase of needed equipment. County Manager Van Haute has determined that State Rescue money can be used to cover this expense.

12. Request from Fire Chief for approval of the purchase of a fire boat (staff-CM & Fire) Chief McClain requested approval of funding for fire boats for Lakes Sinclair and Oconee and provided statistics regarding miles of shoreline on both lakes and the number of homes on each. He explained how fire boats can be used, such as: lake rescues, locating people under water, boat fires, shoreline fires, and as a water source for pumpers on the streets. He advised that funding for one can come from SPLOST 8 and for the other one from SPLOST 9. Chief McClain further advised that it will take approximately 277 days to receive the boats and the cost for each is \$326K boat.

Motion to approve the request from the Fire Chief to purchase two fire boats at \$326,000.00 each with funding from SPLOST 8 and SPLOST 9.

13. Request from Fire Chief for approval of purchase of fire apparatus (staff-CM & Fire) Fire Chief McClain explained that this firetruck purchase is part of his 10 year apparatus plan. The lead time is approximately 15-17 months which would mean it wouldn't arrive until 2023. The current price is \$701,500 but is expected to increase by 7% at the end of January. He further advised this could be funded with SPLOST 9 funds.
