Any person making personal, inverting at, profane or slanderous remarks or who becomes boisterous while addressing the Town Council or while attending the Town Council meeting shall be removed from the bom, if so directed by the Mayor or presiding officer, and the person shall be barred from further andience before the Town Council during that session of the Town Council. Disruption of a public meeting could constitute a violation of Section 42.05 of the Texas Penal Code.
