8.36.010 Purpose.

Except as otherwise provided herein, the purpose of this chapter is to implement and supplement Chapter 70.77 RCW and Chapter 212-17 WAC, hereafter referred to as the State Fireworks Law, as they now exist or may be hereafter amended. The provisions of this chapter shall be construed and applied in accordance with the definitions, requirements and prohibitions of the State Fireworks Law and all rules and regulations issued pursuant to the State Fireworks Law. [Ord. 1527 § 2 (Att. A), 2016.]

8.36.020 Local fire official.

The Leavenworth fire official is designated as the local fire chief for Chelan County fire district No. 3, Leavenworth, Washington, for the city of Leavenworth pursuant to the State Fireworks Law. [Ord. 1527 § 2 (Att. A), 2016.]

8.36.030 Fireworks unlawful – Permit required.

Unless permitted pursuant to this chapter, it shall be unlawful for any person, firm or corporation within the city of Leavenworth to manufacture, import, store, offer for sale, expose for sale, sell at wholesale or retail, use, explode, fire, or discharge any fireworks within the city limits of the city of Leavenworth. This prohibition is more restrictive than the prohibition imposed by state law and includes but is not limited to the Fourth of July holiday. [Ord. 1527 § 2 (Att. A), 2016.]

8.36.040 Consumer fireworks – When discharge permitted.

No person shall discharge or otherwise use any consumer fireworks within the city of Leavenworth, except between the hours of 6:00 p.m. on December 31st and 1:00 a.m. on January 1st of the subsequent year. [Ord. 1527 § 2 (Att. A), 2016.]

8.36.050 Permit application requirements for public permitted displays.

A. The applicant shall have a valid license issued by the state of Washington authorizing the holder to engage in the fireworks activities sought in the permit application.

B. Permit applications shall be submitted in such form and containing such detail as is reasonably required by the fire official. Such applications shall, at a minimum, include the applicable permit application fees, clean-up deposit, state license(s), site drawings depicting permanent and temporary structures and other material features on the site, insurance certificate(s), storage sites and arrangements, and the name, address and telephone number of each applicant and any other responsible party.

C. In addition to the other requirements of the State Fireworks Law, the applicant shall procure and maintain a policy or policies of public general liability, bodily injury and property damage insurance in <u>a</u>

company or companies approved by the fire chief in the minimum amount of \$1,000,000, single limit. The city of Leavenworth and Chelan County fire district No. 3 and any other fire protection district providing fire protection shall be named as additional insureds on such policy. Certificates of coverage shall be filed with the city of Leavenworth.

D. The applicant shall post a \$500.00 cash deposit with each permit application conditioned upon the prompt removal of all temporary structures and the cleaning of all debris from the site. If the applicant removes all temporary structures and cleans up all debris within two days after the end of the permitted fireworks activities, the applicant shall be entitled to the return of the deposit. If the display is not removed and debris is not cleaned prior to that time, the \$500.00 deposit shall be forfeited and placed in the city of Leavenworth general fund.

E. A fully complete application for a public display of fireworks shall be filed with the fire official no later than 14 calendar days prior to the intended display. [Ord. 1527 § 2 (Att. A), 2016.]

8.36.060 Permit fees.

The permit application fee in the amount of \$100.00 shall be paid to the city of Leavenworth at the time the permit application is filed, and is nonrefundable. [Ord. 1527 § 2 (Att. A), 2016.]

8.36.110 Approved storage facilities required.

Temporary fireworks storage locations and facilities shall be approved in conjunction with issuance of a permit authorizing the public display of fireworks. [Ord. 1527 § 2 (Att. A), 2016.]

8.36.120 Consumer fireworks – Where discharge prohibited.

The discharge of consumer fireworks is prohibited in the following locations:

A. In or upon any publicly owned property; provided, that the chief administrative officer of publicly owned property may issue written permits for discharge of consumer fireworks on such terms and conditions as shall be deemed necessary to protect the public, public property and private property;

B. Within 300 feet of any hotel, motel or other lodging facility, hospital, convalescent center, assistedliving center, public library, church, synagogue or other place of worship;

C. Within 500 feet of any automotive service station or other premises where flammable liquids or gases in excess of 500 gallons are stored; and

D. Within or from any structure, vehicle or vessel. [Ord. 1527 § 2 (Att. A), 2016.]

8.36.130 Public display of fireworks – Additional provisions.

In addition to the requirements of the State Fireworks Law, the following provisions shall apply to the public display of fireworks:

A. All minimum clearances, site dimensions, separation clearances and landing areas shall be subject to review by and approval of the fire official. In the sole discretion of the fire official, the minimum standards of the State Fireworks Law may be increased to protect the public and property.

B. The applicant shall provide fire protection for the display. The fire official shall determine the level of personnel and equipment necessary. Prior to the public display, the applicant shall pay the full cost of the required personnel and equipment to fire district No. 3.

C. The applicant shall provide crowd control for the display. The fire official shall determine the level of crowd control necessary, including the number and placement of crowd control monitors. If local law enforcement is providing crowd control, the applicant shall pay the full cost of the required personnel and equipment to the appropriate law enforcement agency prior to the display.

D. If, in the opinion of the fire official, the sheriff or the pyrotechnic operator, a lack of fire protection or crowd control poses a danger to the public or property, then the fire official, the sheriff or the pyrotechnic operator shall immediately suspend the display until the danger is corrected. [Ord. 1527 § 2 (Att. A), 2016.]

8.36.140 Permit coverage – Transfer of permit prohibited.

A separate permit shall be obtained for each activity requiring a permit and for each location at which fireworks activity is undertaken. A permit shall be used only by the designated permittee and shall not be assigned or otherwise transferred. Any transfer or purported transfer of a permit shall be deemed a violation of this chapter and shall void the permit. [Ord. 1527 § 2 (Att. A), 2016.]

8.36.150 Revocation of permit.

Any failure of or refusal by a permittee to comply with the requirement of a permit, to comply with the State Fireworks Law, to comply with this chapter, or to comply with any lawful requirement or order of the fire official concerning fireworks shall be grounds for revocation of a permit by the fire official. [Ord. 1527 § 2 (Att. A), 2016.]

8.36.160 Fireworks – Emergencies – Restrictions on use.

The fire official may prohibit the discharge of all fireworks during periods of extreme fire danger. [Ord. 1527 § 2 (Att. A), 2016.]

8.36.170 Special effects for entertainment productions.

This chapter does not prohibit the assembling, compounding, use, and display of special effects by any person engaged in the production of motion pictures, radio, television productions or live entertainment when such use and display is a necessary part of the production and such person possesses a valid permit issued by the fire official. [Ord. 1527 § 2 (Att. A), 2016.]

8.36.180 Excluded from chapter.

This chapter does not apply to the operation of railways, motor vehicles, vessels or other transportation means for signal purposes or illumination, the use of signals at athletic events, operations conducted by law enforcement and the military, and agricultural and wildlife fireworks. [Ord. 1527 § 2 (Att. A), 2016.]

8.36.190 Appeals.

Any person aggrieved by a decision of the fire official under this chapter may appeal the decision to the city of Leavenworth hearing examiner within 10 days after receipt of the fire official's decision. Any appeal of the hearing examiner's decision shall be to the Chelan County superior court within 10 days after receipt of the hearing examiner's decision. [Ord. 1527 § 2 (Att. A), 2016.]

8.36.200 Enforcement.

The fire official and the sheriff shall have the authority to enforce the provisions of this chapter. [Ord. 1527 § 2 (Att. A), 2016.]

8.36.210 Penalties.

Each violation of this chapter shall be punished as a civil infraction. The penalty for the first infraction shall be \$150.00 and the penalty for each subsequent infraction shall be \$250.00. [Ord. 1527 § 2 (Att. A), 2016.]

8.36.220 Effectiveness.

The ordinance codified in this chapter shall be effective one year after its date of passage by the city council and its summary publication. [Ord. 1527 § 2 (Att. A), 2016.]

ORDINANCE NO. 2016-005

ORDINANCE TO AMEND TITLE 9 OF THE KITTITAS COUNTY CODE TO ADD SECTION 9.09.035 FIRE MARSHAL'S AUTHORITY TO PROHIBIT DISCHARGE, AND TO ADOPT POLICY FM 01-10 IMPLEMENTING A FIREWORKS BAN

WHEREAS: Revised Code of Washington (RCW) 70.77.250 allows counties and cities to adopt code more restrictive than state law with an effective date one year after adoption; and

WHEREAS: RCW 70.77 also provides that local fireworks ordinances are not in effect until a year after their adoption; and

WHEREAS: In times of high fire danger a temporary ban on fireworks, as determined by the Fire Marshal may be necessary; and

WHEREAS: The Board finds that in order to protect the health, safety and welfare of the public, it is necessary to adopt certain fire safety requirements;

WHEREAS: The Fire Marshal has determined that a temporary ban on fireworks mitigates damage and risk to life and property and reduces the risk of fires due to fireworks; and

WHEREAS: Amendment to Title 9 to add language granting the Fire Marshal the authority to implement a ban when critical fire weather and data indicates a ban is necessary; and

WHEREAS: The Board received recommendations from the Fire Marshal to adopt the new code; and

WHEREAS: The Board held a public hearing regarding amending Title 9 and adopting policy FM 01-10;

NOW, THERFORE, BE IT ORDAINED That the Board of County Commissioners after due deliberation and in the best interest of the public, does hereby amend Kittitas County Code Title 9 to add a new section as follows:

KCC 9.30.035 Fire Marshal's Authority To Prohibit Discharge

The Kittitas County Fire Marshal is authorized to prohibit the ignition or discharge of fireworks within the unincorporated areas of Kittitas County whenever the fire danger components and indices have reached or exceeded those described in Standard Operating Procedure F01-10 as now existing or as hereafter amended.

BE IT FURTHER ORDAINED That such amendment shall be effective one year after execution of this document by the Board of County Commissioners.

BE IT FURTHER ORDAINED The Kittitas County Information Technology Department is to add the above new section to the county code on the Kittitas County website.

BE IT FURTHER ORDAINED The Prosecuting Attorney's Office is charged with correcting any scrivener's errors it notices and determines arose out of the amendment and enactment process. No further authorization will be required from the Board of County Commissioners for the Prosecuting Attorney's Office to effect correction of scrivener's errors relating to this Ordinance and the Prosecutor's Office shall direct Information Technology to make such needed corrections.

Standard Operating Procedures

IMPLEMENTING A FIREWORKS BAN

- **SCOPE:** This guideline shall outline criteria under which the Fire Marshal has the discretion to implement a fireworks ban.
- **PURPOSE:** To provide the Fire Marshal and the public with consistency by creating guidelines based on fire weather and danger observations from credible sources, which the Fire Marshal shall consider when deciding whether a ban on fireworks is necessary.
- **PROCEDURE:** The Fire Marshal shall be given the discretion to ban fireworks, by zone or fire district as described in Kittitas County Code 20.08.020, when the following fire danger components and indices have been reached in at least one of the three RAWs Stations:
 - 1. The Burning Index is at least 18; and
 - 2. The Fuel Moisture Content of the 10 hour fuels is below 8; and
 - 3. The Energy Release Component is in the 90th percentile (42 for upper county and 44 for lower county);

And/or one of the following conditions exist:

- 1. Predicted fire weather; and/or
- 2. Resource depletion.

5.20.130 Violation – Penalties.

5.20.010 Permit – Required.

It is unlawful to sell, transfer, contract to sell or transfer, or accept orders for the sale or transfer of any fireworks within the unincorporated areas of Whatcom County without a valid permit as provided in this chapter and under county code Chapter 15.16. (Ord. 93-027; prior code § 4.40.010).

5.20.020 Permit – License required.

No permit shall be granted unless the applicant has obtained, and has in force, a valid and subsisting license as required by chapter <u>70.77</u> RCW. (Ord. 93-027; prior code § 4.40.060).

5.20.030 Permit – Application.

Any adult person desiring to do any act provided in Section 5.20.010 may make written application for a permit to the Whatcom County fire marshal at least 10 days prior to the effective date of such permit. (Ord. 93-027; prior code § 4.40.020).

5.20.040 Permit – Application – Requirements.

The application for permit must be signed by the applicant. Each application must be accompanied by proof of a valid and existing license as required in Section 5.20.020. (Ord. 93-027; prior code § 4.40.030).

5.20.050 Permit – Application – Investigation – Power to restrict or deny.

A. Each application for permit shall be investigated and reviewed by the fire marshal.

B. The Whatcom County fire marshal expressly reserves the power, in his/her discretion, to deny such application, or to grant it subject to reasonable restrictions or conditions as he/she shall prescribe for public safety or welfare. (Ord. 93-027; prior code § 4.40.070).

5.20.060 Permit - Fee.

Each application for permit must be accompanied by an annual permit fee as set forth in Section 15.16.050 of this code. (Ord. 93-027; prior code § 4.40.040).

5.20.070 Permit - Termination.

Each permit granted under the provisions of this chapter is expressly issued subject to the condition that it shall automatically and forthwith cease and terminate coincidentally with the revocation or termination of the state license mentioned in Section 5.20.020. (Ord. 93-027; prior code § 4.40.080).

5.20.080 Permit - Location requirements.

A permit shall be required for each and every separate location or place of business, or delivery point at which fireworks are transferred, sold, or delivered to purchasers. (Ord. 93-027; prior code § 4.40.050).

5.20.090 Period of sale.

Fireworks may only be sold or offered for sale under this chapter from 12:00 noon on June 28th to 12:00 noon on July 6th during the year for which the permit has been issued. No sales will be made between the hours of 11:00 p.m. and 8:00 a.m. on any day. (Ord. 93-027; prior code § 4.40.090).

5.20.095 Period of use.

Consumer fireworks may be used or discharged as follows:

A. Between the hours of 6:00 p.m. and 11:00 p.m. on July 3rd;

B. Between the hours of 6:00 p.m. and 12:00 midnight on July 4th;

C. Between the hours of 6:00 p.m. and 11:00 p.m. on July 5th;

D. Between the hours of 6:00 p.m. on December 31st and 1:00 a.m. on January 1st of the subsequent year, and as provided in RCW <u>70.77.311</u>. (Ord. 2015-026 Exh. A).

5.20.100 Seizure.

Any fireworks which are illegally sold, offered for sale, used, discharged, or possessed in violation of this chapter shall be subject to seizure by the State Fire Marshal, his deputy, the sheriff, or his deputy. Any fireworks seized under the provisions of this section will be delivered to the State Fire Marshal or his deputy for disposition as provided under chapter <u>70.77</u> RCW. (Ord. 93-027; prior code § 4.40.100).

5.20.105 Special circumstances.

If/when Whatcom County issues a ban on outdoor burning or if/when other extenuating emergency conditions exist, all discharge of private fireworks may be prohibited until the ban is lifted or the

emergency condition(s) are mitigated or cease to exist, at the discretion of and by order of the county executive, in coordination with the county fire marshal and the county sheriff. (Ord. 2015-038 Exh. A).

5.20.110 Illegal sale.

No person shall sell or transfer any fireworks to a customer or user thereof other than at the fixed place of business for which a license and permit have been issued. (Ord. 93-027; prior code § 4.40.110).

5.20.120 Fire nuisance prohibited.

No person shall allow any rubbish to accumulate in any premises where any fireworks are stored or kept for sale or transfer, nor permit any other act at the licensed premises which constitutes a fire nuisance. (Ord. 93-027; prior code § 4.40.120).

5.20.130 Violation – Penalties.

Violations of this chapter shall be defined as in county code Section 15.16.070, and shall be subject to the same penalties as stipulated therein. (Ord. 93-027; prior code § 4.40.130).

ORDINANCE NO. 15-015

AN ORDINANCE amending Chapter 8.58 of the Camas Municipal Code, revising the dates and times for fireworks sales and discharge in the City of Camas and authorizing the Mayor to prohibit fireworks discharge during times of extreme fire danger.

WHEREAS, Chapter 70.77 RCW, the State Fireworks Law, governs the purchase, sale, and discharge of fireworks; and

WHEREAS, RCW 70.77.250(4) permits cities to adopt ordinances with stricter regulations of fireworks than state law, provided such ordinances may not have an effective date sooner than one year after their adoption; and

WHEREAS, the City has previously adopted Chapter 8.58 to the Camas Municipal, entitled

"Fireworks," and the City Council desires to adopt additional regulations revising the dates and times

for fireworks sales and discharge in the City of Camas and to further authorize the Mayor to prohibit

fireworks discharge during times of extreme fire danger; and

WHEREAS, a public hearing on the proposed revisions was held before the City Council on

September 8, 2015;

NOW, WHEREFORE, THE COUNCIL OF THE CITY OF CAMAS DO ORDAIN AS FOLLOWS:

Section I

Camas Municipal Code, Section 8.58.020 - Restriction on Times for Sale and Discharge

of Fireworks, is hereby amended to provide as follows:

CMC 8.58.020 – Restriction on Times for Sale and Discharge of Fireworks.

The sale, purchase and discharge of consumer fireworks shall not be permitted at any time except during the following times and dates:

A. Consumer fireworks may be purchased and sold within the City of Camas only between the hours of 9:00 a.m. and 11:00 p.m. on July 2^{nd} and 3^{rd} of any year; between the hours of 9:00 a.m. and 12:00 midnight on July 4^{th} of any year; between

the hours of 9:00 a.m. and 9:00 p.m. on July 5^{th} of any year; and only between the hours of 12:00 noon and 11:00 p.m. on December 29^{th} through December 31^{st} of any year; and

B. Consumer fireworks may be discharged within the City of Camas only between the hours of 9:00 a.m. and 11:00 p.m. on July 3rd of any year; between the hours of 9:00 a.m. and 12:00 midnight on July 4th of any year; and between the hours of 6:00 p.m. on December 31 and 1:00 a.m. on January 1 of the subsequent year.

Section II

A new Section 8.58.025 of the Camas Municipal Code, entitled Emergencies – Restrictions

on Use, is hereby added to the Camas Municipal Code to provide as follows:

CMC 8.58.025 – Emergencies - Restrictions on Use.

The Mayor, after consulting with the Fire Chief, Fire Marshal, and other officials as may be deemed appropriate, may prohibit the discharge of all fireworks during periods of extreme fire danger. For the purposes of this Chapter, the term "extreme fire danger" shall mean a period of hot, dry weather, accompanied by low fuel moistures. It is during this period that wild land fires can be expected, and fire growth will be accelerated.

Section III

This ordinance shall take force and be in effect one (1) year from and after its passage and

publication as provided by law.

Honorable Council and Mayor Anderson;

During the July 20, 2023 Council meeting, an ordinance restricting the use of fireworks inside city limits was discussed. Many members of the public commented regarding the use of fireworks within the City of Stevenson, and there were comments both for and against the proposed ordinance. It was advised that there was a petition circulating with an effort to (completely) restrict the use of fireworks inside the City, and within the Columbia River Gorge.

Without knowing the included language and context of the petition, we felt it would be constructive to obtain feedback about the use of consumer fireworks in Skamania County. Our hope was to obtain factual information, void of emotion so the Council could make an educated decision. To that end the results of our survey are attached for your review, and our summarizations are noted below.

Following our review of survey responses, it does show that resident users of fireworks in our county <u>do</u> consider the circumstances surrounding weather conditions, safe use locations and alternatives should the conditions not be appropriate.

When asked what safety measures people took when using fireworks 81 respondents indicated they had a hose nearby, while 54 persons indicated they had a hose and shovel at the ready. 52% responded that they only let adults light them, and 17% indicated they took other or additional safety measures. A sampling of those other measures included clearing away all fireworks scrap, wetting them down after lighting them, pre-watering the lawn and surrounding areas, using them on pavement or cement ground far away from trees and brush and fireworks safety conversations with kids present, making safety standards clear. To the question of purchasing fireworks but not using them due to a safety concern, 74% of respondents said "YES – I have purchased fireworks and <u>not used them</u> due to safety concerns." An equal amount of respondents indicated they saved them for use at a later time (e.g. for New Year's Eve).

In closing, we want the Council to know this survey was drafted with the intent to limit emotional responses and gauge the true efforts and intent of citizens who purchase and use fireworks. We are hopeful that should the council decide to move forward with any type of restriction, they remember that governing on emotion is unproductive and generally fails to serve the electorate.
