The city has been meeting with the Department of Ecology regarding the current moratorium on commercial sewer connections.

6. UNFINISHED BUSINESS:

a) Approve Type D Right of Way Permit for 725 NW Angel Heights Rd - Public Works Director Carolyn Sourek presented background information regarding the request for a Type D long-term use permit of the city right-of-way for a retaining wall at 725 NW Angel Heights Road for council consideration. MOTION to approve City of Stevenson Type D Right of Way Permit for 725 NW Angel Heights Rd. to build a retaining wall within City ROW, conditional upon the installation of a protective concrete collar around the sewer cleanout, replacement of the full sidewalk panel over the wall drain, and removable at parcel owner's expense if issues with any city infrastructure is observed was made by **Councilmember Cox**, seconded by **Councilmember Hendricks**.

The city will only pay its proportionate share of the cost.



CITY OF STEVENSON RESOLUTION 2023-408

ADOPTING FINDINGS OF FACTS SUPPORTING WASTEWATER MORATORIUM RENEWAL ORDINANCE

WHEREAS, the City Council for Stevenson, Washington approved Wastewater Moratorium Extension Ordinance No. 2022-1186 on September 15, 2022; and

WHEREAS, the City has not resolved the issues requiring the moratorium and has determined that a one-year extension is needed; and

WHEREAS, RCW 35.63.200 requires a City to conduct a public hearing and adopt Findings of Fact supporting the moratorium prior to renewal; and

WHEREAS, a public hearing was conducted on April 20, 2023, at a regular public meeting and the public and staff gave testimony concerning the wastewater moratorium.

NOW THEREFORE, the City Council of the City of Stevenson, Washington, does hereby resolve as follows:

The City Council of the City of Stevenson adopts the following findings of fact:

- 1. On April 7, 2017, the Washington State Department of Ecology issued a Notice of Violation for the City of Stevenson Wastewater Treatment Plant stating that the City has exceeded its design criteria for five (5)-Day Biochemical Oxygen Demand (BOD5) or Total Suspended Solids (TSS) on twenty-one (21) occasions, exceeded effluent limits for TSS or Fecal Coliform on five (5) occasions and has not submitted a plan for Maintaining Adequate Capacity (a copy of the notice is attached as Exhibit A);
- 2. On July 6, 2017, the City received an Administrative Order (attached as Exhibit B) from the Department of Ecology outlining actions for the City to take which include limiting new industrial connections;
- 3. On November 16, 2017, the City approved a wastewater moratorium which expired on May 15, 2018;
- 4. On May 17, 2018, the City approved a new wastewater moratorium which expired on November 17, 2018;
- 5. On November 15, 2018, the City approved a new wastewater moratorium which expired on November 15, 2019;
- 6. On November 14, 2019, the City approved an extension to the wastewater moratorium, which expired on November 14, 2020;
- 7. On November 14, 2019, the City adopted a work plan to address the wastewater deficiencies:
- 8. On October 15, 2020, the City approved an extension to the wastewater moratorium, which expired on October 15, 2021;
- 9. On September 16, 2021, the city approved an extension to the wastewater moratorium, which expired on September 16, 2022;

- 10. On September 15, 2022, the city approved an extension to the wastewater moratorium which will expire on September 15, 2023;
- 11. On January 5, 2023, Department of Ecology dissolved the Administrative Order (Exhibit C).
- 12. The City's treatment plant does not have adequate capacity to treat the wastewater for its existing connections due to excessive BOD5 and TSS loading;
- 13. Accepting additional non-domestic, significant industrial user connections would further stress the City's wastewater treatment plant BOD5 and TSS loading and further impair the City's ability to meet current customer's wastewater needs;
- 14. The City has worked with the Department of Ecology to enact ordinances to reduce loading and is working with current users on a path forward to reduce BOD5 loading at the plant;
- 15. The City has received funding through the Department of Ecology to construct facilities to increase the City's wastewater treatment capacity by improving the current wastewater treatment plant;
- 16. Construction of the facility improvements began on May 13, 2022 and were originally contracted to reach substantial completion on July 30, 2023;
- 17. Due to supply chain issues, substantial completion has been pushed out to August 28, 2024. Until this time, the City must continue its moratorium to minimize additional violations;
- 18. There is a significant demand for new wastewater connections to allow property development within the City and its wastewater service area;
- 19. The City may accept non-significant industrial user wastewater connections as long as they meet the requirements of non-significant industrial user, create effluent that is no stronger than 2,000 mg/L BOD5 or install pretreatment facilities to limit effluent strength to domestic levels since commercial development and job creation is in the public's best interests;
- 20. The Wastewater Moratorium Ordinance will provide the City time to complete construction of the wastewater treatment plant improvements;
- 21. Without a Moratorium, the City may be subject to moratorium imposed by the Washington State Department of Ecology that may be broader in scope, perhaps even including residential connections.

Notice of Violation

Dear Mayor Cox:

The Department of Ecology is issuing the enclosed Notice of Violation to you for violations of the city of Stevenson (City) National Pollutant Discharge Elimination System (NPDES) Permit:

- 1. Between January 2012 and December 2016, the City exceeded its design criteria for five (5)-Day Biochemical Oxygen Demand (BOD₅) or Total Suspended Solids (TSS) on twenty-one (21) occasions (violation of NPDES Permit Section S4.A).
- 2. Between September 2015 and September 2016, the City exceed effluent limits for TSS or Fecal Coliform on five (5) occasions (violation of NPDES Permit Section S1).

Section S4 of the permit addresses facility overloading. Section S4.A (Design Criteria) states:

- Influent BOD5 loading for maximum month: 612 lbs/day
- Influent TSS loading for maximum month: 612 lbs/day

Section S4.B. (Plans for Maintaining Adequate Capacity) states in part:

When the actual flow or wasteload reaches eighty-five (85) percent of the design capacity (paragraph A above) for three (3) consecutive months, ninety-five (95) percent capacity for any single month, or when the projected increases would reach design capacity within five years, whichever occurs first, the Permittee shall submit to Ecology, a plan and a schedule for continuing to maintain capacity at the facility sufficient to achieve the effluent limitations and other conditions of this permit.

- Answer "possibly" if environmental damage or impairment of beneficial uses can be inferred from evidence or knowledge of the effects of the violation.
- Answer "probably" if there is evidence to support a claim of environmental damage or impairment of beneficial uses and there is a plausible connection between the violation and the damage/impairment.
- Answer "definitely" if there is direct evidence linking demonstrable environmental damage or impairment of the beneficial uses with the violation.

- Answer "no" if the violator obviously did not know that the action or inaction constituted a violation.

- 7. Did anyone benefit economically from non-compliance?
- Answer "no" if it is clear that no one obtained an economic benefit.
- Answer "possibly" if someone might have benefited.
- Answer "probably" if anyone benefited, but the benefit is not quantifiable.
- Answer "definitely" if the economic benefit is quantifiable.



Ecology has the authority to issue this Order under RCW 90.48.120(1).

FACTS

The city of Stevenson (City) owns a wastewater treatment plant that discharges treated wastewater to the Columbia River under NPDES Permit No. WA002062 issued by Ecology. Since January 2012, influent wastewater at the wastewater treatment plant has at times exceeded the Plant's design capacity. In 2015, influent wastewater exceeded the Plant's design capacity every month over a five (5)-month period (July through November). The City again exceeded its design capacity in 2016, over a six (6)-month period (June through November). Permit effluent violations occurred several times during this period and are likely the result of facility overloading.

On April 2, 2017, Ecology issued the city of Stevenson a Notice of Violation #14032 (NOV) for the following permit violations:

- 1. Between January 2012 and December 2016, the City exceeded its design criteria for five (5)-Day Biochemical Oxygen Demand (BOD5) or Total Suspended Solids (TSS) on twenty-one (21) occasions.
- 2. Between September 2015 and September 2016, the City exceeded effluent limits for TSS or Fecal Coliform on five (5) occasions.
- 3. The City has not submitted a Plan for Maintaining Adequate Capacity, a requirement given exceedances of the design capacity.

On April 25, 2017, the City responded to the NOV, submitting a one (1) page schedule of actions the City will take to achieve compliance with its NPDES permit, including:

- Limit New Industrial Connections
- Promote Source Control
- Explore Funding Opportunities
- Require Industrial Pretreatment
- Modify Wastewater Treatment Plant Operations
- Update Wastewater Rates
- Complete General Sewer Plan Update
- Design Wastewater Treatment Plant Improvements
- Construct Wastewater Treatment Plant Improvements

ORDER TO COMPLY

For these reasons, and in accordance with RCW 90.48.120(1), it is ordered that the city of Stevenson take the following actions.

Immediately upon receipt of this Order, the city of Stevenson must:

- 1. Implement the actions described in the City's April 25, 2017, response to Notice of Violation #14032.
- 2. Develop a Plan for Maintaining Wastewater Treatment Capacity.
 - a. By July 31, 2017, the City must submit to Ecology a Draft Plan for Maintaining Capacity at its wastewater treatment plant, per NPDES Permit Section S4.b. If the City submits a Draft General Sewer Plan to meet this requirement, the Plan

- must be prepared under the direction of a qualified engineer licensed in the state of Washington; and the Plan must contain the elements outlined in Washington Administrative Code (WAC) 173-240-050 and -060, unless Ecology approves a more limited submittal.
- b. By November 31, 2017, or within 60 days of receiving the Ecology's comments on the Draft Plan, whichever date is later, the City must submit to Ecology, a Final Plan for Maintaining Capacity at its wastewater treatment plant.
- c. Within ninety (90) days of Ecology's approval of the City's Plan, the City must adopt it by resolution or ordinance as appropriate.
- 3. Update the City's Municipal Code as needed to implement Source Control.
 - a. By December 31, 2017, the City must submit to Ecology any proposed changes to its Municipal Code needed to implement the City's Plan for Maintaining Capacity or to Implement NPDES Permit Section S8.
 - b. By April 30, 2018, the City must adopt updates to the City's Municipal Code needed to implement the City's Plan for Maintaining Capacity or to implement NPDES Permit Section S8.
 - c. By June 30, 2018, the City must submit to Ecology an updated Industrial User Survey per NPDES Permit Section S8.2.
- 4. Continue to operate the plant based upon the existing Operations and Maintenance Manual, unless Ecology approves changes to that Manual. The City will submit any proposed changes to Operation and Maintenance practices to Ecology for review and approval as an Operations and Maintenance Plan Amendment, as required by the City's NPDES permit, sixty (60) days prior to proposed implementation.
- 5. Monitor final wastewater effluent for Ammonia weekly [twenty-four (24)-Hour Composite Sample] and submit sampling results to Ecology with the City's monthly Discharge Monitoring Report (DMR).
- 6. Submit to Ecology quarterly progress reports regarding the implementation of this Order on the following schedule:

Implementation Period	Report Due
January 1st to March 31st	April 15th
April 1st to June 30th	July 15th
July 1st to September 30th	October 15th
October 1st to December 31st	January 15th

The first progress report is due on July 15, 2017, for the period of April 1, to June 30, 2017.

ELIGIBILITY FOR PAPERWORK VIOLATION WAIVER AND OPPORTUNITY TO CORRECT

Under RCW 34.05.110, small businesses are eligible for a waiver of a first-time paperwork violation and an opportunity to correct other violations. We have made no determination as to whether you meet the definition of a "small business" under this section. However, we have determined that the requirements of RCW 34.05.110 do not apply to the violation(s) due to a conflict with federal law or program requirements, including federal requirements that are a prescribed condition to the allocation of federal funds to the state.

FAILURE TO COMPLY WITH THIS ORDER

Failure to comply with this Order may result in the issuance of civil penalties or other actions, whether administrative or judicial, to enforce the terms of this Order.

YOUR RIGHT TO APPEAL

You have a right to appeal this Order to the Pollution Control Hearing Board (PCHB) within thirty (30) days of the date of receipt of this Order. The appeal process is governed by Chapter 43.21B RCW and Chapter 371-08 WAC. "Date of receipt" is defined in RCW 43.21B.001(2).

To appeal you must do both of the following within thirty (30) days of the date of receipt of this Order:

- File your appeal and a copy of this Order with the PCHB (see addresses below). Filing means actual receipt by the PCHB during regular business hours.
- Serve a copy of your appeal and this Order on Ecology in paper form by mail or in person. (See addresses below.) E-mail is not accepted.

You must also comply with other applicable requirements in Chapter 43.21B RCW and Chapter 371-08 WAC.

Your appeal alone will not stay the effectiveness of this Order. Stay requests must be submitted in accordance with RCW 43.21B.320.

Administrative Order Docket #14221 was issued to the City of Stevenson on June 30, 2017, requiring compliance with certain conditions imposed in accordance with chapter 90.48 of the Revised Code of Washington (RCW).

The Department of Ecology has determined that the City of Stevenson has substantially satisfied the conditions in Administrative Order Docket #14221.

City of Stevenson Ordinance No. 2023-1194

AN ORDINANCE RELATED TO WASTEWATER CONNECTIONS IN THE CITY OF STEVENSON'S SERVICE AREA, AND PURSUANT TO RCW 35A.63.220 AND OTHER APPROPRIATE AUTHORITY AUTHORIZING A MORATORIUM EXTENSION ON FURTHER COMMERCIAL WASTEWATER CONNECTIONS AND APPLICATIONS FOR COMMERCIAL WASTEWATER CONNECTIONS AS MORE PARTICULARLY SET FORTH HEREIN.

WHEREAS, the City of Stevenson ("City") received an Administrative Order #14221 letter in July of 2017 from the Washington State Department of Ecology ("DOH"), stating that the City is in violation of its NPDES permit as it has exceeded the Wastewater Treatment Plant design criteria for five (5)-Day Biochemical Oxygen Demand (BOD5) or Total Suspended Solids (TSS) on twenty-one (21) occasions between January 2012 and December 2106 and exceeded effluent limits for TSS or Fecal Coliform on five (5) occasions between September 2015 and September 2016; and

WHEREAS, the City has a work plan to address the wastewater treatment deficiencies and is presently constructing wastewater treatment plant improvements that have the capacity to solve the City's wastewater treatment problems, which will take time and requires multiple funding streams; and

WHEREAS, a moratorium on further filing and processing of commercial applications for wastewater connections that will impact the BOD5 or TSS load on the wastewater treatment plant is necessary while the City completes the construction of the treatment plant improvements and increases the plant's capacity, or otherwise mitigates the current plant limitations; and

WHEREAS, the Stevenson City Council finds that the City's ability to plan for utility service and urban growth will be jeopardized unless this moratorium is authorized; and

WHEREAS, the Stevenson City Council finds that the authorization of this moratorium is necessary to protect the health, welfare, safety and future economic viability of the City; and

WHEREAS, RCW 35A.63.220 provides that, "A council or board that adopts a moratorium or interim zoning control, without holding a public hearing on the proposed moratorium or interim zoning control, shall hold a public hearing on the adopted moratorium or interim zoning control within at least sixty days of its adoption, whether or not the council or board received a recommendation on the matter from the commission. If the council or board does not adopt findings of fact justifying its action before this hearing, then the council or board shall do so immediately after this public hearing. A moratorium or interim zoning control adopted under this section may be effective for not longer than six months, but may be effective for up to one year if a work plan is developed for related studies providing for such a longer period. A moratorium or interim zoning control may be renewed for one or more six-month periods if a subsequent public hearing is held and findings of fact are made prior to each renewal"; and

WHEREAS, RCW 36.70A.390 provides that, "A county or city governing body that adopts a moratorium, interim zoning map, interim zoning ordinance, or interim official control without holding a public hearing on the proposed moratorium, RCW 35A.63.220 or RCW 36.70A.390, shall hold a public hearing on the adopted moratorium, interim zoning map, interim zoning ordinance, or interim official control within at least sixty days of its adoption, whether or not the governing body received a recommendation on the matter from the planning commission or department. If the governing body does not adopt findings of fact justifying its action before this hearing, then the governing body shall do so immediately after this public hearing. A moratorium, interim zoning map, interim zoning ordinance, or interim official control adopted under this section may be effective for not longer than six months, but may be effective for up to one year if a work plan is developed for related studies providing for such a longer period. A moratorium, interim zoning map, interim zoning ordinance, or interim official control may be renewed for one or more six-month periods if a subsequent public hearing is held and findings of fact are made prior to each renewal"; and

WHEREAS, moratoria and interim zoning control enacted under RCW 35.99.050, RCW 35A.63.220 or RCW 36.70A.390 are methods by which local governments may preserve the status quo so that new plans and regulations will not be rendered moot or frustrated by intervening development; and

WHEREAS, the Stevenson City Council previously adopted a moratorium extension on September 15, 2022 which will expire on September 15, 2023; and

WHEREAS, a work plan has been developed for the design, funding and construction necessary to upgrade the city's wastewater system and that work plan is attached to this ordinance as Exhibit A; and

WHEREAS, due to supply chain issues substantial completion of the wastewater treatment plant upgrades project has been delayed by one (1) year; and

WHEREAS, the City has hired additional staff to operate the wastewater treatment plant and worked with known significant industrial users to mitigate the risk of additional plant discharge permit violations allowing a change to the moratorium; and

WHEREAS, the Stevenson City Council held a duly advertised public hearing on April 20, 2023, to consider public comment concerning the authorization of such moratorium; and

WHEREAS, the Stevenson City Council adopted Findings of Fact as stated in Resolution No. 2023-408 after the public and staff gave testimony at the public hearing; and

WHEREAS, the Stevenson City Council finds that the best interests of the City would be served if such a moratorium extension was authorized.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF STEVENSON, STATE OF WASHINGTON DO ORDAIN AS FOLLOWS:

WASTEWATER MORATORIUM ORDINANCE – Page 2

Section 1. A one (1) year renewal of the moratorium is hereby imposed on accepting non-domestic, significant industrial user applications for wastewater connections with discharge character above a very high strength classification (BOD5 greater than 2,000 mg/L) or loading rate greater than 5 percent of the wastewater treatment plant design loading rate, that will impact the BOD5 or TSS load on the wastewater treatment plant, for wastewater service inside and outside its corporate boundaries that otherwise would have been authorized under said section. This moratorium does not apply to domestic, standard user wastewater connections.


<u>Section 2</u>. The moratorium imposed pursuant to Section 1 above may be extended for one or more additional six (6) month periods or up to one year if a work plan is implemented, and the City's work plan determines that such extension is necessary to avoid further violations and to implement a permanent fix to the City's wastewater system.

<u>Section 3. Severability</u>. If any section, subsection, sentence, clause, phrase, or other portion of this Ordinance, or its application to any person, is, for any reason, declared invalid, in whole or in part by any court or agency of competent jurisdiction, said decision shall not affect the validity of the remaining portions hereof.

<u>Section 4.</u> <u>Effective date</u>. This ordinance shall become effective following passage and publication as provided by law.

Executive Summary:

This is an overview of items staff has been working on over the past month in line with the direction council gave to staff.

Devon Groom was promoted to Wastewater Treatment Plant Operator II.

Overview of Items:

The plant continues to operate within its permit limits for total suspended solids (TSS), biochemical oxygen demand (BOD), and bacteria for its effluent.

The WWTP Plant Upgrade project has completed their anoxic basin pours and are working through some necessary repairs prior to backfilling. Portions of the UV chamber have also been poured. The City has received the proposal costs for the vac truck dump station and is reviewing options for bringing that price down. The proposal was approximately \$250,000.

On the agenda is a resolution to extend the moratorium for new commercial service connections. The language has been refined to remove commercial users producing standard strength waste and retain prohibition of connections for significant industrial users.

Only punchlist items remain for the contractor to complete the 2021 Collection System Improvements Project.


The 90% design plans for the Kanaka, Cascade, and Fairgrounds pump stations have been received, reviewed, and returned to the consultant engineers. They are working towards a final package for submission to City and funding agencies in May, with an advertisement the end of June. The City hopes to procure some equipment in advance of the contract award to reduce potential lead time impacts.

The sewer mainline under Cascade Ave was identified as being undersized in the General Sewer Plan. Consultant engineer, Greyling Engineers, has prepared a draft Preliminary Engineering Report (PERS) outlining known issues and propose costs for repair and replacement of sewer mainline, as well as deficient, adjacent water line, and street improvements (streetlights and stormwater collection). The initial project cost estimate is \$2M for all proposed improvements. The City is seeking funding for this project and hopes to construct in 2024.

We believe the clarifier fish did not make it through the winter but, this innovative practice is something other plants are investing time and energy in pursuing. Our WWTPO plans to continue pursuing this practice at our plant as well.

Plant Operations:





The current permit limit for Influent is 612 lbs/day and the current upgrades in the adopted General Sewer Plan call for a design max monthly BOD loading of 1,611 lbs/day.

Funding:

The \$2.5M in direct federal appropriations requested spring of 2021 is moving forward. The application has been submitted and we are waiting for EPA review and a contract. As soon as the process is completed, we can be reimbursed for the work. Due to the increased cost for the WWTP project, the \$2.5M in funds will allow us to hold off on requesting additional loan funds as long as possible.

SUBJECT: Parking – Programmatic Updates, Especially Downtown

Introduction

Parking in downtown Stevenson is a complex dynamic involving, among other factors, the vehicle user base, the inventory of private/off-street parking, the City's requirements to increase off-street parking when new downtown development occurs, and the on-street parking inventory and the City's regulation thereof. These factors have conspired to a) protect the on-street parking assets from over-usage, b) confuse and frustrate those involved in on-street parking overnight, and c) hinder the feasibility of new downtown development.

In 2022, the City Council set out a strategic priority to reevaluate downtown parking dynamics. This memo introduces preliminary draft updates to Stevenson Municipal Code Title 10--the first of 4 potential actions the City Council could take as part of this reevaluation. City Council guidance is requested on the goals and objectives to be achieved through an amendment if one is made. No final action is expected until this draft is further evaluated by the public.

Potential Actions Involved in the Reevaluation of Downtown Parking Dynamics

Staff evaluation of downtown parking dynamics results in 5 potential actions for the City Council to consider:

- 1. Amend SMC Title 10 Vehicles & Traffic
- 2. Adopt a Parking Master Plan
- 3. Adopt an optional Payment In-Lieu of providing off-street parking
- 4. Amend SMC Section 17.42.090 Table of Minimum Standards—Off-Street Parking

These potential actions interrelate but can be taken independently.

Guidance Sought

At tonight's meeting, staff will verbally discuss the potential amendment to SMC Title 10, the solutions, introduce our rationale in selecting the preliminary solutions therein, and demonstrate some effects of the solutions if enacted. After discussion, staff will seek the following guidance:

Decision Point #1: Does the City Council support the goals and objectives staff used in its development of solutions?

Decision Point #2: Does the City Council see any preliminary solution as untenable to the point where it should not be included as part of the public's evaluation of the change?

Amend Title 10 - Vehicles & Traffic

Existing Elements: Title 10 of the Stevenson Municipal Code includes 8 chapters regulating various activities and adopted over a long time span:

- Traffic (Chapter .02; adopted 1994),
- Loading Zones (.08; adopted 1974, 1976),

- Parking (.12; adopted 1971, 1973, 1975, 1976, 1994),
- Animals & Sleds on Sidewalks (.16; adopted 1994),
- Watercraft (.20; adopted 1998),
- Compression Brakes (.24; adopted 2005),
- Wheeled ATVs (.40; adopted 2014),
- Unmanned Aircraft (.42; adopted 2020).

Problems: Staff from various City departments collaborated to identify the following problems presented by the existing elements, which broaden beyond parking:

- The statewide framework for regulating vehicles and traffic was established in the mid-1990's. Our embrace of that framework has been incomplete and inconsistent, and difficult to implement.
- The 25-MPH state- and citywide speed limit is unsafe for many city streets.
- Our on-street parking and loading regulations were adopted in the mid-1970s. They overlap and conflict with the 1990s-era framework. They overlap and conflict with the 2010s-era City Right-of-Way Use Code. They have not been implemented by the City. Their implementation would make downtown living a hassle. Their implementation would make it a hassle to stay downtown as an overnight visitor. Such hassles threaten the economic sustainability of our downtown (i.e., our 2022 Downtown Plan for SUCCESS!).

Goals & Objectives: The attached preliminary draft amendment to SMC Title 10 strives to advance these goals and objectives:

- Modernize our code, removing redundancies and conflicts.
- Create frameworks for decision-making.
- Increase the City's ability to respond to issues related to vehicles and traffic.
- Expand options for overnight vehicle parking downtown.
- Protect the City's ability to maintain public assets (plowing, street sweeping, catch basin clearing, tree trimming, light bulb replacement, etc.)

Preliminary Staff Solutions: The solutions recommended by Staff based on the project goals and objectives involve:

- Aligning the City's grant of Public Works Director powers and duties with those granted or otherwise made available by the state (e.g., the position of Traffic Engineer).
- Removing redundancies within Title 10 and conflicts between Title 10 and Title 12 (Streets, Sidewalks, and Public Places).
- Increasing the maximum fine for traffic infractions.
- Adopting a procedural framework to modify speed limits on all City streets.
- Reducing speed limits for alleys, school zones, gravel streets, and dead-ends/culs-de-sac.
- Clarifying how we will remove junk and unauthorized vehicles in public parking spots.
- Reformatting our parking regulations into a table with numerals instead of blocks of text.
- Relaxing on-street parking prohibitions in areas where they currently exist.
- Expanding the "relaxed" on-street parking prohibitions to areas where they don't currently exist.

Next Steps

Staff will take any guidance offered by the Council and build it into the public release draft of the potential change and conducted targeted and general outreach. Once complete, an updated draft of the amendment will be presented to the City Council, either before or along with the other potential actions related to downtown parking.

Next steps for those actions involve:

- Parking Master Plan: Planning Commission and Parking Advisory Committee evaluation, prioritization and recommendation of projects for inclusion
- Alternative Parking Contribution: City Council evaluation of feasibility
- SMC 17.42.090 Amendment: Parking Advisory Committee collection of summertime data and Planning Commission evaluation of standards

Title 10 VEHICLES AND TRAFFIC

Chapter 10.02 TRAFFIC ORDINANCE

10.02.010 Model Traffic Ordinance and other state statutes adopted by reference.

- A. The "Washington Model Traffic Ordinance," Chapter 308-330 WAC, as now constituted and as hereafter amended, is adopted by reference as the traffic ordinance of the city as if set forth in full in this chapter.
- B. Sections 4, 5, 6, 7, 10, 11, 12 and 23 of Chapter 275, Laws of 1994, the "1994 Omnibus Drunk Driving Act," and RCW 46.20.730, as amended by Section 23 of Chapter 275, as now constituted and as hereafter amended, are adopted by reference.

Chapter 10.04 GENERAL REGULATIONS

10.04.005 Purpose—Policy.

- A. This Title is an exercise of the police power of the City of Stevenson and is necessary for the protection of the public health, safety, and welfare through the regulation and control of vehicles and other devices operating within the corporate limits of the City and the standing, parking and loading on public highways and City parking lots.
- B. It is the policy of the City of Stevenson to:
 - 1. Prioritize the safety of non-motorized users of public highways within the corporate limits of the
 - 2. Facilitate and support safety at railroad crossings.
 - Facilitate efficient short-term parking and manage on-street parking to permit the safe and efficient operation of the transportation system.
 - 4. Protect the natural and scenic qualities of the area.
 - 5. Protect, facilitate and encourage enhancement of Rock Cove's habitat, water quality, and ambiance.

10.04.010 Definitions.

The following definitions shall apply to this Title, unless the context of the Title indicates otherwise:

- A. All definitions contained in Chapter 46.04 RCW, Definitions, as now existing and all future amendments, additions, and new sections, are hereby adopted by reference.
- B. All definitions contained in Chapter 308-330 WAC, Washington Model Traffic Ordinance, as now existing and all future amendments, additions, and new sections, are hereby adopted by reference.
- C. "Load" or "Loading" means the standing of a commercial vehicle, whether occupied or not, temporarily for the purpose of and while actually engaged in loading or unloading property or passengers.

10.04.020 Office of Traffic Engineer.

A. The office of traffic engineer, as provided in the Washington Model Traffic Ordinance, shall be performed by the public works director of the City of Stevenson. Any references to the traffic engineer in the Model Traffic Ordinance or this Title shall be construed to mean the city public works director.

B. In addition to the duties listed in the Model Traffic Ordinance, it shall be the duty of the traffic engineer to install and maintain traffic control devices implementing this Title. Such devices shall give appropriate notice of the regulation, warning, or guidance contained herein. Such devices include, without limitation, signs, marks or lines upon the surface of the roadway, and painting or stenciling upon the surface of the roadway or curbs.

10.04.030 Violations - Penalty.

- A. Unless otherwise provided, violation of this Title shall be deemed a traffic infraction. Traffic infractions shall be punishable by a maximum penalty of \$250 per violation, exclusive of statutory assessments; provided, that conduct which constitutes a criminal traffic offense may be charged as such and is subject to the maximum penalties allowed for such offenses.
- 3. Violation of Chapter 10.10 shall be deemed a traffic infraction. Traffic infractions for parking shall be punishable by a maximum penalty of \$35 for each offense plus any applicable statutory assessments imposed by the state of Washington. In addition to the monetary penalty, when any police officer finds a vehicle parked in violation of Chapter 10.10, such officer is authorized to provide for the removal of such vehicle to a place of safety or require the driver or other person in charge of the vehicle to move the same, to a position off of the restricted area as indicated by Chapter 10.10. A place of safety may include the business location of a towing service, and the registered owner of the vehicle in violation will be responsible for all costs involved in the towing service.

(RESERVED)

Chapter 10.06 SPEED LIMITS

10.06.010 Default Speed Limit, and Modification Procedures.

- A. Unless otherwise provided by local or state law, the maximum lawful speed for all public highways within the corporate limits of the City shall be 25 miles per hour.
- B. Whenever the City Council determines a need to advance the policy of this Title, it may, by ordinance, decrease the default speed limit of any nonarterial highway to 20 miles per hour.
- C. In all other cases, the City Council may, by ordinance, modify the default speed limit pursuant to RCW 46.61.415, as now existing or hereinafter amended.

10.06.020 Decreased Speed Limits.

To promote the safety of non-motorized users, the maximum lawful speed on the following public highways within the corporate limits of the City shall be 20 miles per hour:

- A. On any alleys designated as such by the Traffic Engineer pursuant to RCW 46.04.020, as now or hereafter amended.
- B. Within any School or playground speed zone established by the Traffic Engineer pursuant to RCW 46.61.440, as now or hereafter amended.
- C. On any street designated by the Traffic Engineer as having a driving surface of crushed rock or gravel.
- D. On any street designated by the Traffic Engineer as being a dead-end or cul-de-sac.

10.06.030 Increased Speed Limits.

On the basis of an engineering and traffic investigation into the reasonable and safe condition of travel thereon, the maximum lawful speed on the following public highways shall be as listed below:

A. [Reserved].

Chapter 10.08 LOADING ZONES

10.08.010 Established Purpose.

There shall be and are established loading zones along the curbs of any street for the purpose of facilitating the loading and unloading of merchandise and persons, preventing double parking and climinating other hazards and impediments to traffic.

10.08.020 Establishment considerations-Hours and regulations-Signing required.

The city is authorized and directed to establish such loading zones by reason of consideration to volume and nature of business within the blocks of the city, the volume of normal traffic and normal parking, the width and surface of the streets, the relation between the needs for parking space for the general public and parking space for the loading and unloading of merchandise and relevant factors related thereto. The city, through its duly authorized council, is further authorized to establish the hours of usage and other regulations in relation to such loading zones and the city shall, by appropriate notices and signs, post notice of such loading zones and hours thereof.

10.08.030 Signing requirements.

The city shall, upon passage of the ordinance codified in this chapter, cause to be erected by appropriate signs as provided in Section 10.08.020, the designation of such loading zones and hours thereof.

10.08.040 Use restricted during certain hours.

Loading zones, other than those adjacent to hotel entrances and exits, shall be reserved primarily for use by commercial vehicles in loading and unloading persons and commodities between the hours of eight a.m. and six p.m. on all days except Sundays and holidays, and no person shall stop, stand or park any vehicle other than a commercial vehicle therein between such hours; provided, however, that noncommercial vehicles may use such zones while actually engaged in the loading and unloading of persons or commodities only, but noncommercial vehicles shall upon demand give way to commercial vehicles whose drivers desire to use the zone for loading or unloading purposes. At all other times such zones shall be for general use under the parking regulations applicable to the district in which they are located.

10.08.050 Use by commercial vehicles restricted during certain hours-

Commercial vehicles using the loading zones established by this chapter may not stop, stand or park for any purpose other than for the purpose of using such zones for the loading and unloading of persons or commodities during the hours of eight a.m. and six p.m. on all days except Sundays and holidays. At all other times such commercial vehicles may use such loading zones for general use under the parking regulations applicable to the district in which they are located.

Chapter 10.10 PARKING AND LOADING

10.10.010 Parking and Loading Limitations - Adopted by Reference.

RCW 46.61.560 through 46.61.590, inclusive, Motor Vehicles; Rules of the Road; Stopping, Standing, and Parking, as now existing or hereafter amended, are adopted by reference as provided in RCW 35A.12.140.

10.10.020 Parking Limitations - Generally.

A. No person shall park a vehicle on a public highway or City parking lot within the corporate limits of the City after said vehicle has been designated a junk vehicle or unauthorized vehicle pursuant to SMC 8.22 **Commented [BS4]:** RCW 46.55.010 & 230: a high bar to clear. The vehicle needs to meet 3 of 4 specific criteria and removal involves several steps, including mailed notice and 15 days waiting period from the date of the notice.

Commented [BS5]: RCW 46.55.010: a far, far lower bar. Any vehicle parked where it shouldn't be. Also includes 11 other specific instances justifying removal. Process is either immediate or after 24 hours with notice sticker/attempt to contact via phone.

OR

in any of the circumstances listed below:

- . If the vehicle registration is expired;
- If the vehicle is apparently inoperable and/or under repair; however, vehicles that have broken down while in normal use are allowed to remain for a period not to exceed 48 hours for emergency repairs if not on the traveled portion of the roadway; or
- If the vehicle is parked for an unreasonable period of time, which for the purposes of this subsection, shall be more than 14 consecutive days.

10.10.030 Parking Limitations – Traffic Engineer Authority.

The traffic engineer may:

- A. Pursuant to WAC 308-330-265, limit parking along any highway in the corporate limits of the city when the width of the roadway is less than 28 feet.
- B. Limit usage of parking by excluding persons other than those with a disability.
- C. To promote safety at crosswalks, intersection areas, and driveways, limit the height of a vehicle allowed to stop, stand, or park upon a public highway.
- D. Establish temporary limits on parking to prevent interference with a procession or parade.

10.10.040 Parking Limitations – Specific Location Prohibitions and Time Restrictions.

A. In addition to the foregoing limitations, no person shall stop, stand, or park a vehicle within the City in violation of Table 10.10.040 – 1: Specific Parking Restrictions.

- B. Exceptions. The following exceptions are permitted to the limitations of Table 10.10.040-1.
 - When necessary to avoid conflict with other traffic, or in compliance with law or the directions of a
 police officer or official traffic control device.
 - 2. When authorized pursuant according to the City of Stevenson Right-of-Way Use Code.

10.10.050 Loading - Traffic Engineer Authority.

The traffic engineer, pursuant to WAC 308-330-265, may grant special loading privileges and determine the location, hours of usage, and other regulations of loading zones, passenger loading zones, and tow-away zones, and the hours of usage thereof, according to City of Stevenson Right-of-Way Use Code. Factors involved in the determination include but are not limited to:

- A. Volume and nature of business within the blocks of the city,
- B. Volume of normal traffic and normal parking,
- C. Width and surface of the streets,
- D. Relation between the needs for parking space for the general public and parking space for the loading and unloading of passengers and/or merchandise.

Chapter 10.12 PARKING PROHIBITED IN CERTAIN AREAS¹

10.12.010 Definitions.

As used in this chapter, the following words shall be defined as follows:

- A. "Parking" means the standing of a vehicle upon a street, whether such vehicle is occupied or not, and whether or not such vehicle is accompanied by an operator for a period of time in excess of two minutes.
- B. "Vehicle" means any device in, upon, or by which any person or persons, or property is or may be transported upon a public highway.

10.12.020 Parking near mail deposit receptacle restricted -- Exception -- Signing required-

- A. It is unlawful for any person to cause or permit to be caused a vehicle of any nature, kind or description to be parked within a linear proximity distance of ten feet from the location of any mail depository receptacle within the corporate limits of the city for any period of time exceeding five minutes; and
- B. U.S. mail couriers are excepted from the provisions of this section; and

¹-For statutory provisions on powers of local authorities regarding parking, see RCW 46.61.575.

C. Such mail depositories¹ areas as governed by this section shall be properly posted with appropriate signs relating to such limitations in accordance with this section.

10.12.030 Parking time on certain alleys and streets restricted.

No person, firm, company or corporation shall park any vehicles as described and defined in Section 10.0 8-.010, from the hours of two-thirty a.m. to five-thirty a.m. in any alley designated as such within the corporate limits of the city, nor within such hours on Second Street between the east and west corporate limits of the city, and on Russell Street from Vancouver Avenue to Cascade Avenue and on Vancouver Avenue from School Street to Strawberry Road.

10.12.040 Parking prohibited on certain streets-Signing required.

- A. From and after February 15, 1973, it is unlawful to park any vehicle whatsoever without regard to limitation as to time along the north side of the street commencing from the intersection of Vancouver Avenue and Columbia Street on the east boundary to the intersection of Vancouver Avenue and School Street on the west boundary.
- 8. Such prohibition of parking as ordained in this section shall be continuous in nature and no exception thereto shall be permitted during any time of a twenty-four-hour period of any day.
- C. Motor vehicles shall be defined as including every device capable of being moved on a highway and in, upon, or by which any persons or property is or may be transported or drawn upon a public highway.
- D. The city shall post in conspicuous places along such street within the boundaries as aforementioned, proper street signs effecting notice of prohibition of parking as set forth in this section.

10.12.050 Parking limitations and enforcement authorized.

The city, through its duly authorized council, is authorized and directed from time to time henceforth from the date of enactment of the ordinance codified in this section, to be empowered to designate by posting all proper parking limitation sites upon such streets, alleys and thoroughfares therein the city, parking limitations as to time limitations and area limitations within such corporate limits, and the city is further empowered and directed to designate such areas and times and places as to parking limitations and authorize its enforcement agencies to enforce same by penalties prescribed in Section 10.12.070.

10.12.060 Provisions deemed exercise of police power.

This chapter is enacted as an exercise of police power for the protection of persons and property and to relieve the congestion of traffic in the city.

10.12.070 Violation Penalty.

Each conviction for violation of any provision of this chapter shall constitute a traffic infraction and shall be punished by a fine in the amount of thirty five dollars for each offense plus any applicable statutory assessments imposed by the state of Washington.

Chapter 10.16 RIDING OF ANIMALS AND SLEDS ON SIDEWALKS

10.16.010 Riding and sledding unlawful.

It is unlawful for any person to accompany, to lead, to drive, or to ride any domesticated animal other than cats or dogs, upon any public pathway or public sidewalk within the corporate limits of the city; it shall also be unlawful for any person to sled upon any public pathway or public sidewalk within the corporate limits of the city.

10.16.020 Violation-Penalty.

Each violation of this chapter shall constitute a Class 4 civil infraction and shall be punishable by a fine of not more than twenty-five dollars, plus statutory assessments, for each offense and upon conviction thereof.

Chapter 10.20 WATERCRAFT REGULATIONS

10.20.010 Definitions.

For the purposes of this chapter the following terms shall have the following meanings:

"Buoy" means a waterway marker designed to float on water while anchored in fixed position and used to convey an official message.

"No wake zone" means an area within which no person shall operate a vessel in other than a careful and prudent manner or at a speed that will produce a visible wake.

"Sign" means a device designed to carry on official message which is attached to another object, such as piling, buoy, pier, or the land itself.

"Vessel" means every watercraft used or capable of being used as a means of transportation on the water.

10.20.020 No wake zones designated.

It is unlawful for any person to operate a motorized vessel across the waters of Rock Cove within the hereinafter defined no wake zones in such a manner as to create a visible wake. No wake zones are defined to be:

- A. All of the area described as Rock Cove lying to the north of the State Route 14 Bridge;
- B. All of the area described as Rock Creek lying to the north of the State Route 14 Bridge.

10.20.030 Exemptions.

This provision shall not apply to watercraft operated for emergency or rescue purposes by the Skamania County sheriff's office, state of Washington, or city of Stevenson.

10.20.040 Sign and regulatory markings installation.

The public works director will be authorized to install signs and buoys with regulatory markings identifying the "no wake zone"; the marking system will conform to chapter 352-66 WAC, Uniform Waterway Marking System.

10.20.050 Violation—Penalty.

Violation of this chapter shall constitute a Class 2 civil infraction punishable by a fine of one hundred twenty-five dollars, plus applicable state statutory assessments for a first violation. Any subsequent violations of this chapter is punishable as a misdemeanor.

Chapter 10.24 COMPRESSION BRAKES

10.24.010 Unmuffled compression brakes prohibited.

A. As used in this section, the term "compression brakes" means the use of an add-on engine brake or diesel exhaust brake to retard the forward motion of a motor vehicle by the compression of the engine. "Compression brakes" are sometimes referred to as "jake brakes."

B. Except as provided in this section, no person shall use compression brakes within the city limits of the city of Stevenson unless the brakes are muffled by means of a mechanical muffling device.

- C. This section shall not apply to vehicles of any municipal fire department, whether or not responding to an emergency.
- D. It shall be an affirmative defense that such unmuffled compression brakes were applied in an emergency to protect persons and/or property.

10.24.020 Signing.

The public works department is authorized and directed to post at reasonable locations within the city signs indicating, "Unmuffled compression brakes prohibited" or substantially similar wording.

10.24.030 Penalty.

Any person violating the provisions of this chapter shall have committed a traffic infraction; violations of this section shall be punishable by a maximum penalty of two hundred fifty dollars per violation.

Chapter 10.40 WHEELED ALL-TERRAIN VEHICLES

10.40.010 Definitions.

When used in this chapter, the city defines the words and phrases listed below as follows:

- A. "City" means the city of Stevenson, its elected officials, its employees, and its agents.
- B. "City street" means every way, lane, road, street, boulevard, and every way or place in the city open as a matter of right to public vehicular traffic inside the city limits.
- C. "Motorcycle helmet" has the same meaning as provided in RCW 46.37.530.
- D. "Rules of the road" means all the rules that apply to vehicle or pedestrian traffic as set forth in state statute, rule or regulation.
- E. "Sidewalk" means that property between the curb lines or the lateral lines of a city street and the adjacent property, set aside and intended for the use of pedestrians or such portion of private property parallel and in proximity to a city street and dedicated to use by pedestrians.
- F. "Wheeled all-terrain vehicle" means:
 - Any motorized nonhighway vehicle with handlebars that are fifty inches or less in width, has a set height of at least twenty inches, weighs less than one thousand five hundred pounds, and has four tires having a diameter of thirty inches or less; or
 - 2. A utility-type vehicle designed for and capable of travel over designed roads which travels on four or more low-pressure tires of twenty psi or less, has a maximum width less than seventy-four inches, has a maximum weight less than two thousand pounds, has a wheelbase of one hundred ten inches or less, and satisfies at least one of the following:
 - a. Has a minimum width of fifty inches;
 - b. Has a minimum weight of at least nine hundred pounds; or
 - c. Has a wheelbase of over sixty-one inches.

A wheeled all-terrain vehicle is an off-road vehicle for purposes of Chapter 4.24 RCW.

10.40.020 Use of wheeled all-terrain vehicle on city streets.

Subject to the restrictions and requirements set forth in this chapter, a person with a valid driver's license issued by the state of the person's residence may operate a wheeled all-terrain vehicle upon a city street having a speed limit of thirty-five miles per hour or less including State Route 14.

10.40.030 Restrictions on use of wheeled all-terrain vehicle on city streets.

- A. A person who operates a wheeled all-terrain vehicle must wear a securely fastened motorcycle helmet while the vehicle is in motion, including any passengers;
- B. A person may not operate a wheeled all-terrain vehicle upon a city street with a speed limit in excess of thiryt-five miles per hour; however, a person may cross a city street with a speed limit in excess of thirty-five miles per hour at a controlled intersection if the crossing begins and ends on a city street with a speed limit of thirty-five miles per hour or less and occurs at an intersection of approximately ninety degrees;
- C. A person may operate a wheeled all-terrain vehicle upon any city street while being used under the authority or direction of an appropriate agency that engages in emergency management, as defined in RCW 46.09.310, or search and rescue, as defined in RCW 38.52.010, or a law enforcement agency as defined in RCW 16.52.011, within the scope of the agency's official duties;
- A person may only operate a wheeled all-terrain vehicle on city streets with the appropriate current and proper on-road vehicle registration affixed to the rear of the wheeled all-terrain vehicle in compliance with RCW Ch. 46.09;
- E. A person may only operate a wheeled all-terrain vehicle on city streets with the equipment required for wheeled all-terrain vehicle in compliance with SMC 10.40.040 and RCW Ch. 46.09; and
- F. Wheeled all-terrain vehicles are subject to Chapter 46.55 RCW.

10.40.040 Equipment requirements of a wheeled all-terrain vehicle.

A wheeled all-terrain vehicle operated on a city street must comply with all equipment requirements of RCW Ch. 46 including, but not limited to, headlights, tail lamps, stop lamps, reflectors, turn signals, mirrors, windshields, horns, brakes, spark arresters, and muffling devices. An adequate and operating muffling device must be installed and must comply at all times with RCW 46.09.470.

10.40.050 Registration requirements of a wheeled all-terrain vehicle.

A wheeled all-terrain vehicle operated on a city street must comply with the registration requirements of Chapter 46.09 RCW.

10.40.060 Duty to obey traffic-control devices and rules of the road.

Unless a law enforcement officer directs otherwise, a person operating a wheeled all-terrain vehicle must obey all rules of the road applicable to vehicle or pedestrian traffic and must obey the instructions of official traffic-control signals, signs and other control devices applicable to vehicles. A person operating a wheeled all-terrain vehicle upon a city street is subject to all of the duties Chapter 46.61 RCW et seq. imposes on a operator of a vehicle, except those provisions which by their nature have no application.

10.40.070 Prohibited uses.

- A. No person may operate or ride a wheeled all-terrain vehicle in a negligent or unsafe manner, but must operate it with reasonable regard for his or her own safety and for the safety of others.
- B. Passengers are only allowed in wheeled all-terrain vehicle designed for two or more passengers. No passengers under the age of five are allowed. No wheeled all-terrain vehicle operator may tow other devices or persons behind a wheeled all-terrain vehicle. All passengers must wear a securely fastened motorcycle helmet while the vehicle is in motion.
- No operator may operate a wheeled all-terrain vehicle parallel to another wheeled all-terrain vehicle in a single lane of traffic.

10.40.080 Prohibited areas.

- A. It is unlawful to operate a wheeled all-terrain vehicle on a sidewalk.
- B. It is unlawful to operate a wheeled all-terrain vehicle in a park, except on a park drive or in a designated parking lot.

10.40.090 Violation-Penalty.

A person who violates a provision of this chapter is guilty of a traffic infraction and will be punished by the imposition of a monetary penalty not to exceed two hundred fifty dollars, exclusive of statutory assessments; provided, that conduct which constitutes a criminal traffic offense may be charged as such and is subject to the maximum penalties allowed for such offenses.

10.40.100 Severability.

Each separate provision of this chapter is independent of all other provisions. If any provision of the chapter, or any part thereof, is declared invalid, all other provisions, or parts thereof, remain valid and enforceable.

Chapter 10.42 UNMANNED AIRCRAFT SYSTEMS

10.42.010 Definitions.

For the purposes of this chapter:

"Unmanned Aircraft" shall mean an aircraft, including, but not limited to, an aircraft commonly known as a drone, that is operated without the possibility of direct human intervention from within or on the aircraft.

"Unmanned Aircraft Systems" shall mean an unmanned aircraft and associated elements, including, but not limited to, any communication links and components that control the unmanned aircraft.

"Person" shall mean any individual, firm, trust, partnership, public or private association or corporation.

"Model Aircraft" shall mean an unmanned aircraft or unmanned aircraft system operated by any person strictly for hobby or recreational purposes.


10.42.020 Use of unmanned aircraft prohibited.

- A. No person shall use an unmanned aircraft to record or transmit any visual image or audio recording of any person or private real property located in the city under circumstances in which the subject person or owner of the subject real property has a reasonable expectation of privacy (including, but not limited to, inside a private residence or office, and inside an enclosed yard).
- B. This section shall not prohibit the use of any model aircraft, which is flown in compliance with section 336 of the FAA Modernization and Reform Act of 2012 and which does not transmit or record visual images or audio recordings of any person or real property located in the city.
- C. This section shall not prohibit the use of any unmanned aircraft by law enforcement or public safety agencies:
 - 1. If a warrant is issued authorizing the use of an unmanned aircraft; or
 - For the purpose of providing emergency management, fire, or police protection services in response to a life-threatening emergency, or for surveying the condition of person or property during a duly declared state of emergency;
 - 3. Under circumstances where a warrant would not otherwise be required by law.

10.42.030 Violation.

ENVIRONMENTAL MITIGATION AGREEMENT (NE Fir Street Laterals)

This Agreement ("Agreement") is made and entered into this _____ day of April, 2023 by and between the City of Stevenson, a municipal corporation duly organized and validly existing under the laws of the State of Washington ("City"),

and

Sheri Terjeson and James Stringfellow ("Terjeson/Stringfellow"), who own fee title to 421 NE Fir Street (Lot 5) and 441 NE Fir Street (Lot 4), Stevenson, Washington 98648, and Teresa Daugherty, who owns fee title to 451 NE Fir Street, Stevenson, Washington 98648 (collectively "Property Owners") and Van Pelt & Van Pelt Construction, Inc., WA UBI No. 601713827 ("Contractor").

RECITALS

WHEREAS, the Property Owners have submitted a building permit application for the relocation of sewer lateral from 451 NE Fir Street ("Daugherty Property") which will cross the properties located at 441 NE Fir Street and 421 NE Fir Street ("Terjeson/Stringfellow Properties") (collectively the Daugherty Property and the Terjeson/Stringfellow Properties may be referred to as "the Properties").

WHEREAS, an application for improvement has been submitted to allow the Property Owners to reroute the sewer service lateral from 451 NE Fir Street along the western property line of the Terjeson/Stringfellow Properties for connection to the main sewer line on NE Fir Street ("the Work"). The cost of the Work is set forth in the March 23, 2023 quote from Contractor attached hereto as **Exhibit 1**. The Work is further detailed in plans prepared by Van Pelt Inc, dated March 6, 2023 ("the Plans"). The Work does not include any connection of a lateral from the Terjeson/Stringfellow Properties to the main sewer line ("Excluded Work") – all such costs shall be the sole responsibility of Terjeson/Stringfellow.

WHEREAS, the portion of the Work located in the City Right of Way will be conveyed to the City upon completion of construction. The portion of the Work on private property will remain owned and maintained by the Property Owners. The City will not participate in ownership, maintenance, repair, or replacement of any part of the Work located on the Properties.

WHEREAS, the Property Owners will draft, sign, and record a utility easement of sufficient width to allow maintenance, repair, and replacement, as needed, between the Property Owners; which shall be recorded with the Skamania County public records.

WHEREAS, the Property Owners have agreed to engage Contractor to perform the Work according to the Plans. The Work shall be done at the cost and expense of Terjeson/Stringfellow based on the terms of this Agreement and any agreement between the Terjeson/Stringfellow and Contractor. Upon completion and acceptance of the Work by the City, the City will reimburse Terjeson/Stringfellow the amounts recited in **Exhibit 1** for the Work.

WHEREAS, the City finds the Work as being necessary to mitigate environmental impacts related to maintaining the sewer service line in an area that poses a future risk to public health and safety.

WHEREAS, this Agreement is entered pursuant to chapter 43.21C RCW, the State Environmental Policy Act ("SEPA") and SMC Title 18, Environment. This Agreement provides for the mitigation of existing, known and anticipated environmental impacts. This Agreement is not, and shall not be construed as, a voluntary agreement pursuant to RCW 82.02.020.

WHEREAS, the City and Property Owners have determined it is in their interest to work together to eliminate potential public health and safety issues.

WHEREAS, Property Owners and Contractor hereby agree to comply with all requirements of the City's construction standards and any other City resolutions, ordinances, policy or master plan applicable to the Work.

NOW THEREFORE, in consideration of the mutual promises, covenants and agreements contained herein, the City, Property Owners and Contractor mutually undertake, promise and agree for themselves, their successors and assigns as follows:

ARTICLE I INCORPORATION INTO AGREEMENT

1.01. The foregoing recitals are hereby ratified and conformed as being true and correct and are hereby made a specific part of this Agreement.

ARTICLE II CONSTRUCTION OF UTILITY IMPROVEMENT

2.01. CITY'S OBLIGATIONS.

- (A) Inspection, General: The City, at its sole cost and expense, shall retain or use the services of a Washington State registered professional engineer for the purposes of inspecting and supervising the construction and installation of the Work to insure compliance with accepted civil engineering practices and the approved Plans. Prior to Property Owners and Contractor conveying that portion of the Work in the City's Right of Way to the City, the engineer shall certify in writing the construction and installation of the Work complies with accepted civil engineering practices and is in substantial conformance with the approved Plans. The City is obligated to make inspections of all the construction work performed by the Contractor and permitted by the City under the terms of this Agreement. Such inspections shall not be construed to constitute any guarantee on the part of the City as to materials or workmanship, nor shall any inspection relieve the Contractor of the responsibility for the proper construction of the Work in accordance with the requirements of the approved Plans nor shall any inspections, if undertaken, abrogate or void the Contractor's one (1) year warranty to the City as to the quality and condition of the materials and workmanship as set forth below.
- (B) Inspection, Special: When required, the Contractor shall retain the services of licensed inspectors for any special inspections, including but not limited to testing of materials and compaction, as required in the City of Stevenson Engineering Standards.
- (C) Reimbursement. Upon completion and acceptance of the Work, the City shall reimburse Terjeson/Stringfellow for the amounts recited in **Exhibit 1**. Reimbursement shall be made within thirty (30) days of approval of the Work by the City of Stevenson.

2.02 PROPERTY OWNERS' AND CONTRACTOR'S OBLIGATIONS

- (A) Design: Terjeson/Stringfellow, at their sole cost and expense, shall be responsible for designing and preparing the Plans and any specifications associated with the Work. All plans, specifications, and calculations shall be submitted for review. No work shall commence until the Plans and any specifications are approved in writing by the City and a construction permit issued.
- (B) Construction and Installation: The Property Owners and the Contractor, at their sole cost and expense, shall construct and install the Work in accordance with the approved Plans and specifications.
- (C) Compliance with Applicable Laws: The Work shall be performed in accordance with all requirements of the regulatory agencies which have jurisdiction over the subject matter of this Agreement as well as all applicable Federal laws, State statutes, County and City ordinances. The requirements of this paragraph shall govern, regardless of any errors or omissions in the approved Plans and specifications.

- (D) Approvals and Permits: Terjeson/Stringfellow, at their sole cost and expense, shall be fully responsible for obtaining all required approvals from all governmental agencies and for obtaining all necessary construction permits for the Work contemplated in the approved Plans and specifications.
- (E) Accuracy of Information: Terjeson/Stringfellow and Contractor shall furnish to the City accurate information with regard to all matters under this Agreement, including, without limitation, information contained in the Plans and specifications.

 Terjeson/Stringfellow and the Contractor shall be jointly and severally responsible for errors or changes in the information furnished to the City under this Agreement.
- (F) Compliance with City Code: Property Owners and Contractor acknowledge they have reviewed and agree to be bound by all applicable requirements of the City codes and standards.
- (G) Warranty. Terjeson/Stringfellow and Contractor jointly and severally warranty the Work shall be performed in a good and workmanlike manner and in accordance with all recognized industry standards. The warranty shall be for labor and materials for a period of one (1) year from the date the City accepts the Work as completed.
- 2.03 INSURANCE. Contractor shall provide evidence to the City of the following insurance:
 - (A) General liability insurance shall be provided on an "occurrence" basis, in the following limits of liability as a minimum: (1) bodily injury, \$1,000,000 each occurrence and \$2,000,000 each aggregate, and (2) property damage, \$1,000,000 each occurrence and \$2,000,000 each aggregate.
 - (B) All policies shall provide the Policy cannot be canceled or materially altered except after 30 days advance written notice to the City.
 - (C) Contractor shall provide a Certificate of Insurance evidencing the City is a named Additional Insured on the general liability policy.
- 2.04 CONVEYANCE OF THE WORK TO THE CITY. Upon completion and approval of the Work, the Contractor shall convey that specific portion of the Work in the City Right of Way to the City. This Agreement does not address the installation of a sewer lateral connecting 441 NE Fir Street and/or 421 NE Fir Street to the sewer main in the City Right of Way. Delivery to and acceptance by the City Council of all documents and related materials required for the Work shall constitute final acceptance by the City of these improvements.

ARTICLE III GENERAL PROVISIONS

- 3.01. Nothing contained herein shall be deemed to waive or modify any other lawful code provision, ordinance, resolution or regulation of the City nor shall this Agreement be applied in a manner which causes the City to violate any bond covenant or obligation.
- 3.02. ASSIGNMENT, CONVEYANCES OR TRANSFERS OF THIS AGREEMENT. The partial or full assignment, conveyance or transfer of Property Owners and Contractor's rights and/or obligations under this Agreement shall be prohibited unless and until all of the following conditions are met:
 - (A) It is in writing in a form approved by the City Council;
 - (B) The City consents in writing, which consent shall not be unreasonably withheld and is a party to said assignment, to the conveyance or transfer and the assignee, conveyee or transferee agrees to abide by all the terms and provisions of this Agreement;
 - (C) The Property Owners and Contractor are not in default under this Agreement; and
 - (D) Such rights and/or obligations are assumed in writing by an assignee or transferee in a form acceptable to the City.

3.03. NOTICES. All notices hereunder must be in writing and shall be mailed as follows;

Any notice so addressed and sent by prepaid certified mail, with return receipt requested, shall be deemed validly given when deposited in the United States mail.

3.04. DEFAULT. The occurrence of any of the following during this Agreement shall constitute a default:

- (A) Property Owners or Contractor's failure in the performance or observance of any of the terms and conditions of this Agreement; or
- (B) There shall be filed by or against Property Owners and/or Contractor in any court or other tribunal pursuant to any governmental requirement, a petition in bankruptcy or insolvency proceedings or for reorganization or for the appointment of a receiver or trustee of all or substantially all of Property Owners or Contractor's assets.

In the event of Property Owners or Contractor's default under this Agreement, the City's obligations under this Agreement shall be voidable at the option of the City.

- 3.05. REMEDIES. Should the Property Owners or Contractor be in default of this Agreement, it is agreed the City shall be entitled to any and all remedies under Washington State law, and in addition thereto, the City shall be entitled to any or all of the following remedies, which are cumulative:
 - (A) Refusal to provide a final inspection or acceptance of the Work.
- 3.06 INDEMNIFICATION AND HOLD HARMLESS. The Property Owners and Contractor, collectively and jointly, agree to indemnify and hold harmless the City and its officials, elected or otherwise, employees, agents and successors from and against any and all claims, losses, damages, liabilities and the like, including reasonable counsel fees which either the Property Owners or Contractor may incur, suffer, sustain or be required to pay by reason of the Work resulting in injury, property damage, or death of any person or to any property whatsoever, caused or alleged to have been caused due to the Work described herein. In the event the City is named as a party or subject to any proceeding, including arbitration, arising from or related to the Work, the Property Owners and Contractor shall immediately defend the City and its officials, elected or otherwise, employees, agents and successors from and against any and all allegations, losses, costs, claims (even if such claims prove to be false, groundless or without merit), including demands, damages, expenses, attorney fees/costs, expert fees/costs or any liability of any nature.

3.07. MISCELLANEOUS PROVISIONS.

(A) This Agreement constitutes the entire agreement between the Parties for all matters contained herein and shall supersede all previous agreements or representations either oral or written (including electronic communications) with respect to all matters

contained herein. All prior agreements between the City and the Property Owners pertaining to any matters specifically covered by this Agreement are hereby canceled and declared of no force and effect to the extent they are in conflict herewith.

- (B) If any section, subsection, sentence, clause, phrase or portion of this Agreement is for any reason held invalid or unconstitutional by any court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision and such holding shall not affect the validity of the remaining portions hereof.
- (C) The headings and subheadings use throughout this Agreement are for convenience only and have no significance in the interpretation of the body of this Agreement, and the Parties hereto agree that they be disregarded in construing the provisions of this Agreement.
- (D) The recitals to this Agreement are true and correct and are hereby incorporated as an integral and material part of this Agreement.
- (E) The signature of any person to this Agreement shall be deemed a personal warranty by that person he or she has the power and authority to bind any corporation, partnership or any other business entity for which he or she purports to acts.
- (F) In the event of any disputes and/or litigation arising from this Agreement, the prevailing party shall be awarded reasonable attorney's fees and costs (including paralegal and experts) at arbitration or trial and through and including appeals.
- (G) No waiver by City of any breach of any term or condition of this Agreement, and no failure by City to exercise any right or remedy with respect of any such breach, shall constitute a waiver or relinquishment for the future, or bar any right or remedy of City with respect to any other breach of such term or condition or any breach of any other term of this Agreement. The receipt by City of any waiver of payment, any payment or any portion of payment required under this Agreement shall not operate as a waiver or an accord and satisfaction of the rights of City to enforce the payment or portion of a payment then or subsequently due, to terminate this Agreement or to invoke any other appropriate remedy which City may select as provided by this Agreement or by law.

Professional Services Agreement Hearing Examiner Services

THIS AGREEMENT is entered into between the City of Stevenson, a municipal corporation, hereinafter referred to as the "City", and Joe Turner, P.C., Municipal Hearings Official hereinafter referred to as the "Consultant", in consideration of the mutual benefits, terms, conditions hereinafter specified.

1) Project Designation:

The Consultant is retained by the City to perform Hearing Examiner services for the City.

2) Scope of Services:

Consultant agrees to perform Hearing Examiner services in connection with Stevenson Municipal Code 2.15.010 *et seq* and pursuant to RCW 58.17.330 and RCW 35A.63.170, including the provision of all labor, materials, equipment, supplies, and expenses.

3) Time of Performance:

Consultant shall provide all services and work product required pursuant to this Agreement through December 31, 2025, unless an extension of such time is granted in writing by the City, or the Agreement is terminated by the City in accordance with Section 13 of this Agreement.

4) Payment:

The City shall pay the Consultant for completed work and for services rendered under this Agreement as follows:

- The City shall pay the Consultant direct compensation at the rate of \$215 per hour for the time he spends in review, investigation, travel, sitting as the Hearing Examiner and the rendering of decision.
- All work performed shall be inclusive of labor, materials, equipment, supplies, and expenses.
- The City shall compensate the Consultant for certain expenses consisting of mileage at the current IRS mileage reimbursement rate in effect at the time the mileage is incurred, copies at \$.10 per copy and postage pursuant to standard postage rates.
- The Consultant may submit vouchers to the City once per month during the progress of the work for payment for project completed to date. Payment shall follow the Council meeting (third Thursday) of each month following receipt of Consultant's invoice.
- The Consultant's records and accounts pertaining to this Agreement are to be kept available for inspection by representatives of the City and of the State of Washington for a period of three [3] years after final payment. Copies shall be made available upon request.

5) Ownership and Use of Documents:

Except for the record of any final decision filed with the City, all documents, electronic copies and other materials produced by the Consultant in connection with the services rendered under this Agreement shall be Consultant's adjudicative work product and shall not be considered public records unless held to be so by a court of competent jurisdiction. In the event a court so rules after notice to the Consultant pursuant to RCW 42.56.520, Consultant agrees to cooperate with the City to deliver materials to the Court for *in camera* inspection and/or production to the requestor.

6) Compliance with Laws:

Consultant shall in performing the services contemplated by this Agreement, faithfully observe and comply with all federal, state, and local laws, ordinances and regulations applicable to the services to be rendered under this Agreement.

7) Indemnification/Hold Harmless:

The Consultant shall defend, indemnify, and hold the City, its officers, officials, employers and volunteers harmless from any and all claims, injuries, damages, losses or suits including attorney fees, arising out of or resulting from the acts, errors, or omissions of the Consultant in performance of this Agreement, except for injuries and damages caused by the negligence of the City.

It is further specifically and expressly understood that the indemnification provided herein constitutes the Consultant's waiver of immunity under Industrial Insurance, Title 51 RCW, solely for the purposes of this indemnification. This waiver has been mutually negotiated by the parties. The provisions of this Section shall survive the expiration or termination of this Agreement.

8) Consultant's Liability Insurance:

The Consultant shall procure and maintain for the duration of this Agreement, insurance against claims for injuries to persons or damage to property which may arise from or in connection with the performance of the work hereunder by the Consultant.

Consultant shall maintain Professional Liability insurance appropriate to the Consultant's profession in the amount of no less than \$1,000,000 per claim and \$1,000,000 policy aggregate limit.

Consultant shall furnish the City with original certificates evidencing the Professional Liability of the Consultant before commencement of the work.

9) Independent Consultant:

The Consultant and the City agree that the Consultant is an independent Consultant with respect to the services provided pursuant to this Agreement. Nothing in this Agreement shall be considered to create the relationship of employer and employee between the parties hereto.

Neither Consultant nor any employee of the Consultant shall be entitled to any benefits accorded City employees by virtue of the services provided under this Agreement. The City shall not be responsible for withholding or otherwise deducting federal income tax or social security or for contributing to the state industrial insurance program, otherwise assuming the duties of an employer with respect to Consultant, or any employee of Consultant.

10) Discrimination Prohibited:

The Consultant in his performance of this Agreement will not discriminate on the grounds of race, color, national origin, religion, creed, age, sex, or the presence of any physical or sensory handicap in the selection and retention of employees or procurement of materials or supplies.

11) Assignment:

The Consultant shall not sublet or assign any of the services covered by this Agreement to anyone other than its employee, Joe Turner, without the express written consent of the City.

12) Non-Waiver:

Waiver by the City of any provision of this Agreement or any time limitation provided for in this Agreement shall not constitute a waiver of any other provision.

13) City's Right to Terminate Agreement:

The City shall have the right at its discretion and determination to terminate the Agreement following thirty [30] calendar days' written notice.

This Agreement represents the entire Agreement between the parties and supersedes all previous Agreements or understandings between them. This Agreement may be modified only in writing, provided both parties have signed the amended document.

In the event any provision of this Agreement is deemed invalid or contains an irresolvable ambiguity, the remaining provisions shall nevertheless continue to be valid and enforceable.

No changes or modifications to this Agreement shall be valid or binding upon either party unless such changes or modifications be in writing and executed by both parties.

INTERLOCAL AGREEMENT

BETWEEN

Skamania County, the City of Stevenson, and the City of North Bonneville

For

The preparation of a comprehensive Solid Waste Management Plan and a Moderate Risk Waste Plan

THIS AGREEMENT, made pursuant to the Inter-Local Cooperation Act of the State of Washington, between the City of Stevenson and City of North Bonneville, and the County of Skamania, WITNESSETH:

I. <u>AUTHORITY</u>

RCW 70.95 and RCW 39.34 provide for the Cities and the County to enter into this Inter-Local Agreement. The Cities and the County have adopted their respective ordinances or resolutions authorizing their participation in this agreement.

II. DURATION

This agreement shall remain in full force and effect for six (6) years from its inception unless revoked as provided elsewhere herein.

III. PURPOSES

Under the laws of the State of Washington each of the participants to this agreement have the responsibility to prepare a comprehensive Solid Waste Management Plan and a Moderate Risk Waste Plan. In the alternative, they are allowed to do so in concert with the County by designating the County as the responsible party to prepare a Comprehensive Solid Waste Management Plan and Moderate Risk Waste Plan to be effective within the jurisdiction of the County. The Cities and the County have elected to proceed in accordance with such alternative and it is the purpose of this agreement to accomplish said comprehensive planning.

IV. CONTENTS OF PLAN

- A. The County agrees to cause a Comprehensive Solid Waste Plan and Moderate Risk Waste Plan to be prepared and to include in it the areas within the corporate limits of the Cities of Stevenson and North Bonneville. The plans shall include all of the elements specifically set out and required by RCW 70.95.090 and RCW 70.105.220.
- B. The Cities agree to authorize the County to prepare plans for the Cities Solid Waste Management and Moderate Waste Management and to cooperate with the County, doing all things necessary or expedient that are within the authority of the Cities to do, to implement the plans, including deferring to the County any financial aid which is available from the State of Washington and the extension of any municipal facilities that the parties mutually agree is necessary for the operation of any services implemented as a result of said plan on such reasonable terms as are mutually agreed to at the time by the parties.

V. <u>TERMINATION</u>

This agreement shall automatically terminate unless revoked, in writing, by the parties at the expiration of the contract period or, it may be terminated sooner in any manner now or hereafter provided by state law.

VI. <u>ADMINISTRATION</u>

The County shall be administer of this agreement.

I want to apologize to this group – it was our intention to invite agencies from Washington to the listening sessions Adam mentioned and it didn't happen because of an admin error. I'm sorry. The good news is that, after hearing more from EPA about how this program is going to work, I genuinely don't think that anyone in this group missed out on any changes to participate in the grant or provide feedback that will help to shape our work program. Below is the email that I just sent out to all of the folks who were invited to the listening sessions. Please let me know if you have any questions or responses to the bulleted items below. Thank you, Eliot Hello all:

Thank you for attending the listening sessions Metro held a few weeks ago regarding the EPA Climate Pollution Reduction (CPRG) grants. We heard general support for Metro leading this planning grant with a focus on positioning agency partners in the region to pursue the implementation grants that EPA is planning to make available next year. We also heard specific ideas about how grant funds could best be used to support climate work in different communities and emissions sectors. And most importantly, we heard many great suggestions about how we can work together to accomplish this work on the tight timeline that EPA has laid out. We have a great path forward. Below is a summary of what we have since learned from EPA, Metro's next steps and how you can support the process.

We followed up with EPA and DEQ, which is leading Oregon's CPRG grant, and relayed the feedback we heard at the listening sessions. EPA acknowledged the tight timeline, especially for start-up and completion of the first deliverable - the Priority Climate Action Plan - by March 2024. They encouraged our region to build on existing climate plans and focus on the sectors where agency partners in the region have the most potential leverage to reduce GHGs in order to complete that plan as efficiently as possible. EPA is also expediting the process by taking steps to allow grantees to begin spending grant funds as soon as possible and allowing grantees to use grant funds to finalize the scope of the deliverables and engagement plan, rather than figuring everything out before submitting a work plan.

Given that direction, Metro is planning to submit a Notice of Intent to Participate as the lead agency by April 28, which is the next step in the application process. We will then work with the EPA program officer assigned to us to develop and submit a work plan by May 31. Through this process we will clarify with EPA when and how we can work with our agency partners to develop a more detailed approach to this work that addresses the many ideas that we heard at the listening sessions – including reviewing existing climate plans and initiatives, developing scopes for the deliverables in this project, and recommend a plan for engaging the public and other stakeholders in development of these plans – and we will be in touch with more details about how our partners can provide their ideas and feedback on this approach.

In the meantime, there are several ways in which you can help support this process:

- Submit a letter of support using the attached template. Please email me any letters of support by April 26th. Letters of support are optional, but EPA is encouraging us to submit them.
- Email me if your agency is interested in directly participating in the development of the detailed Work Plan, the Priority Climate Action Plan and the Comprehensive Climate Action Plan. Please let me know a primary staff contact with whom I can share updates and coordinate with as we kick off the work.
- You are also welcome to email me with further thoughts about what activities the plans developed under this grant should cover or about key stakeholders that need to be engaged along the way. I will compile this feedback for consideration as we develop the work plan and engagement plan discussed above.

Hi Folks,

I wanted to provide an update on the EPA grant that I've had the opportunity to discuss with this group.

Yesterday I met with Metro staff to discuss EPA's Climate Pollution Reduction Grants Program (CPRG). While I've had the chance to discuss this grant with many of you, this was our first meeting with Metro on it. With the Notice of Intent to Participate (NOIP) deadline approaching (April 28) we are beginning to have more clarity and wanted to touch base.

I learned that Metro has held two workshops with Oregon agencies about this grant. Interest among attendees was to use this program to unlock future funding opportunities across the region, among different sectors. Coming out of those workshops was the appointment of Metro as lead organization for the CPRG planning grant. I've CC'd Eliot Rose, who is leading that effort at Metro, on this email.

In my conversation with Eliot we spoke about developing a stakeholder table with all interested counties represented and tapping a consultant to lead personnel components and further develop workplan. We also explored the possibility of a set-aside for Clark and Skamania agencies, with the understanding that set-aside stipulations will not extend beyond Round 1 grant funding.

In the coming days and weeks we can expect to hear more from Metro on this grant.



Current Expense revenues and expenses are trending in line with budget.




Street revenues and expenses are trending the same (revenue line is under the expenses line in the chart below) with both revenue and expenses currently coming in under budget.

Tourism fund revenues are exceeding budget expectations and expenses are trending below budget. Most events take place over the summer and are invoiced by the end of the year.




Equipment Services revenues are trending as expected. The jump in expenses is due to the purchase of a vehicle in January and are expected to level off throughout the year.

5. Parking Determination

Unstaffed Utility or Communication Facility

Shumaker requested the Stevenson Planning Commission determine the number of parking spaces required for a "Utility or Communication Facility". This request is made by Planning Department staff in anticipation of several permit requests from the Stevenson Public Works Department for this type of use.

Issue: In SMC 17.42.090, the Zoning Code currently lists a number of use classifications and the corresponding parking requirement for each use. Requirements for the Utility or Communication Facility use are not listed. The Planning Commission is given the authority to determine the parking requirement for uses that are not specified.

Following a brief discussion, the Planning Commission concluded the following:

Findings

- 1. The Planning Commission supports the Comprehensive Plan's objectives related to minimizing the impacts of development and to facilitating efficient short-term parking and minimizing off-street parking requirements.
- 2. When impacts of parking at Unstaffed Utility or Communication Facilities occur, they are minimal, intermittent and short in duration.

Determination

For the purpose of SMC 17.42.090, "Table of Minimum Standards—Off-Street Parking", the Planning Commission determined Utility or Communication Facilities (Unstaffed) do not require any spaces in any district.

6. Subcommittee Reports

Shoreline Access, Downtown Parking, Annexation Policy

Shoreline Access. Ray reported he is reviewing the current plan and will be attending meetings on Wednesday and Thursday. Shumaker shared the consultants have been busy analyzing the current shoreline environment to determine where gaps are occurring. He added a stakeholder open house would be held on Wednesday, February 15th, 2023 at the Stevenson Community Library from 5-7 p.m. The following morning (Thursday) there will be a focus group at 10 a.m. to review the meeting results. Outreach to the public has taken place via mailers, social media, newspaper announcements and postings at City Hall. Stakeholders include shoreline property

owners, recreationalists and others with an interest in accessing the local shorelines.

Shumaker has been meeting with Shoreline property owners and has been sharing feedback with the consultants. The shorelines under evaluation are along Rock Creek, Rock Cove and the Columbia River. He confirmed trails are still a part of the discussion, and Skamania County and Port of Skamania County are both involved. He offered a brief explanation of the state's requirements for a Shoreline Access Plan as well as what it will provide to Stevenson regarding identification of access points and budgeting guidance for capital improvements.

Downtown Parking. Keesee was unable to attend a recent City Council workshop that addressed parking. She asked **Shumaker** to provide information. He noted the pending approach to parking regulations will likely be more comprehensive, with more of an effort to develop solutions. Finding a way to balance the impact less onsite parking will have on overnight street parking will involve working with Public Works.

Costing out a parking improvement plan would provide a way to determine the value of a parking space. An in-lieu parking fund paid via developers is under consideration, as is re-striping to capture additional space, relocating fire hydrants, and development of a municipal lot. **Shumaker** provided an example of switching the parking lane to the north side of Vancouver Avenue. This is possible, but the expected increase in traffic along Russell and Second Street would need to be evaluated.

Zettler and **Breckel** both commented acquiring a lot would add substantial expense and time to any project. **Hales** spoke to his experience in various sized cities and suggested a reasonable inventory of parking sites leads to people figuring it out.

>Repar stated home driveways need to be sized appropriately to prevent vehicles from encroaching onto sidewalks or streets.

Shumaker noted the parking study performed last September did not identify a significant demand for parking. Commissioners suggested July may be a better time for a survey to gain additional data.

Annexation Policy. Hales reported he is not sure where the collaboration the County stands currently but that City Councilmember Michael Johnson is interested in participating.

Shumaker advised the county Planning Department is experiencing staffing changes which may be affecting communication. He went on to say the sub-committee is looking to better understand what densities are permitted inside and outside City limits. He stated work is being done with the city's GIS consultants to get the base mapping in place and develop some draft material for use in comparisons. **Hales** and **Breckel** suggested a working group be formed to connect with Skamania County to lay out the steps for working together.

Breckel agreed with the need for basic information. He stated it is also important to get an understanding of the physical characteristics of the land and how it is being currently used. He shared the importance of being aware of the cost annexation of low-density parcels can bring to a city. (Hales' internet connection was then lost.)

Discussion

7. Staff & Commission Reports

Planning & Public Works Assistant. Tiffany Anderson was welcomed as the new Planning and Public Works Assistant. She introduced herself and provided details on her background and experience.

Broadband. Shumaker reported broadband is on the City Council's priority list. A number of opportunities have come up, including technical assistance grants from Washington state; large increases in federal funding through the recent Bipartisan Infrastructure Law, and programs and tech assistance from WSU Extension to determine the existing infrastructure in place for broadband delivery and how/if residents can access it.

Breckel spoke of rural communities and their need for broadband service. He likened it to a necessary utility much like electricity because of its use in shopping, medical care, education, services and other daily activities.

>Repar commented on the need for a public utility that provides reliable, affordable and consistent internet connectivity.

Permit Applications & Systems. Fully updated planning permit applications are on the city's website in advance of changing to more online options to increase efficiency. The city is in a partnership with Skamania County for building official services. Getting the intake protocols aligned will reduce Andersen's workload as the applications can only be submitted when complete. **Breckel** pointed out it will help clarify what information the public needs to complete a permit.

East Loop Road Water & Street Project. State gas tax grant funds have been awarded to address several road projects, including East Loop Road where a water line replacement will also be completed.

As an introduction to the monthly report we routinely submit, I'm including this narrative to provide additional insight. Data reported is for the month of March.

Rental Assistance:

First-time requests for rental assistance are given priority.

In addition to the rental assistance for all programs that is reported for March, assistance has been provided to pay rents that were in arrears for months other than the reporting month. In the month of March, twelve (12) households comprising a total of thirty-one (22) individuals were served providing an additional 1680 bed-nights of assistance.

Denial of Services:

Four (4) households requesting rent assistance in March were denied. Three (3) household had previously received significant rental assistance in prior months and reached the maximum benefit. One (1) household did not qualify for rental assistance.

Warming Shelter Services:

The Warming Shelter Program was terminated as scheduled on March 15. Continued mild weather was predicted and did not warrant program extension. The following items were dispensed to those in need:






