APPROVAL OF CHANGE ORDER NO 1 - Tangipahoa Parish Jail Lift Station & Force Main Improvements – Mr. Miller made it known this is the final change order to add 2 steel plates for the lid on the lift station. Motion made by Mr. Vial, seconded by Mr. Forrest to approve change order no 1 in the amount of \$3,600.00 for the Tangipahoa Parish Jail Lift Station & Force Main Improvements. Roll call as follows:

- \*\*Mr. Miller gave an update on the lighting repairs in the lighting districts by Entergy stating of the 681 lights out, 439 have been repaired (64.46%).
- \*\*Mr. Vial asked the clerk to get another update from Entergy in a couple weeks.
- \*\*Mr. Miller made it known there is still wire debris on the ground even after numerous calls by the parish to the utility companies.
- \*\*Mr. Mayeaux asked if DEMCO had been contacted. Mr. Miller could not confirm at the time but would check on the status.
- \*\*Mrs. Coates asked if stumps were still being picked up...Mr. Miller confirmed debris contractors were in fact still working on stump removal.

### **REGULAR BUSINESS**

- 6. UPDATE ON ESTABLISHING A VETERAN'S COURT Mr. Joseph introduced Judge Ricks to come forward to expound on the establishment of a Veteran's Court.
  - \*\*Judge Ricks addressed the council, the 21<sup>st</sup> Judicial District Court now has a Veteran's Court. Judge Ricks discussed working since 2014 to get a Mental Health and Veteran's Court in the district. Judge Rick's made it known Bo Coxen was responsible for finding the grant, only 10 were awarded in the entire country, Mr. Coxen wrote the grant that was awarded to the 21<sup>st</sup> Judicial Court for a Veteran's Court. Anyone wanting to apply to be a Case Manager or a Mentor can go to 21stjdc.org to download the forms. Judge Ricks made it known they now have a component for Mental Health with the Veteran's Court from a second grant that was also awarded to the district.
  - \*\*Judge Abels spoke on the Veteran's Court being long over due to help Veteran's that have lost their way to help get them back on track.
  - \*\*Judge Dykes commended Bo Coxen on his hard work of writing the grant. Judge Dykes discussed needing Mentors to move forward with the requirements of the Mentors being, served before and having an Honorable discharge.
  - \*\*Judge Ricks thanked Ryan Jenkins and Angel Major for going through over 20 hours of federal training that helped with getting the grant.
  - \*\*Bo Coxen discussed the Veteran's treatment page on the website, 21stjdc.org. An email address has also been setup, veterans@21stjdc.org, that goes directly to the Veteran's team. The mental health is a separate component that will have a case manager working in all 3 jails with mental patients to get early intervention and treatment.
  - \*\*Ryan Jenkins discussed the Veteran's Court modeling after the Drug Court which has been very effective. Go to the 21stjdc.org, Veteran's Treatment Court, at the bottom of the page is a printable or fillable form for anyone wishing to apply for case managers or mentors.
