AN ORDINANCE TO GRANT A VARIANCE TO TANGIPAHOA PARISH CODE OF ORDINANCES- CHAPTER 17-4.2-4a MINI PARTITIONS, FOR MR. EDUARDO GATO AT 41066 BYERS ROAD, IN PONCHATOULA, LOUISIANA IN DISTRICT NO. 2 WHEREAS, Tangipahoa Parish Code of Ordinances Chapter 17, Sec. 17-4.2 A. (4.) (a) states Mini Partitions – for a new 60-foot ROW or private road to be allowed to be created, the original parcel (parent tract) to be divided must be a minimum of three (3) acres or more as per T.P. Ord. No. 20-56.

WHEREAS, Mr. Eduardo Gato, the property owner of 2.83 acres located at 41066 Byers Road, Ponchatoula, La 70454 is requesting a variance to Chapter 17, Sec 17-4.2 A. (4.) (a); and be allowed to create a Mini Partition with a 60-foot Right-of-Way.

### T.P. RESOLUTION NO. R21-05

A Resolution stating the Parish Council's approval and endorsement of the Tangipahoa Parish Convention and Visitors Bureau proceeding with the issuance, sale and delivery of its not to exceed \$150,000 Revenue Note, in one or more series, and its application for a loan under the Paycheck Protection Program.

WHEREAS, the Tangipahoa Parish Convention and Visitors Bureau is a body politic and corporate and a political subdivision of the State of Louisiana (the "Bureau") created pursuant to Article VI, Sections 19 and 30 of the Louisiana Constitution of 1974, as amended, and Sections 4574 et. seq of Title 33 of the Louisiana Revised Statutes of 1950, as amended (the "Tourist Commission Act");

WHEREAS, the Bureau was established for the purpose of, directly or indirectly, developing and/or carrying out programs and activities designed to attract and promote travel and tourism in and to the Parish of Tangipahoa, State of Louisiana (the "Parish");

WHEREAS, in response to the budgetary challenges created by the COVID-19 pandemic and to continue the Bureau's economic development mission to promote and encourage the travel and tourism industry in the Parish at current levels, the Board of Directors of the Bureau (the "Board"), pursuant to the Tourist Commission Act and Section 1430 of Title 39 of the Louisiana Revised Statutes of 1950, as amended, desires to issue its not to exceed \$150,000 Revenue Notes, in one or more series (the "Notes"), for the purpose of funding the Bureau's operations and expenses in the Commission's current and upcoming fiscal years;

WHEREAS, the Bureau desires to also undertake such loan as may be made available under the Paycheck Protection Program administered by the Small Business Administration (the "PPP") pursuant to the Coronavirus Aid, Relief and Economic Security Act, Public Law 116-136 of the 116th Congress of the United States of America (the "CARES Act"); WHEREAS, Section 318 of the Economic Aid to Hard-Hit Small Businesses, Nonprofits, and Venues Act, Public Law 116-136 of the 116th Congress of the United States of America (the "Economic Aid Act") provides that destination marketing organizations such as the Bureau are now eligible entities to apply for loans by utilizing the PPP; and WHEREAS, this Parish Council of the Parish of Tangipahoa, State of Louisiana (this "Parish Council") approves and endorses the Bureau's issuance of the Notes and its application for a loan by utilization of the PPP, as shall be more fully set forth in a later-adopted Resolution of the Bureau describing the terms and features of the Notes, and desires that this Resolution be construed to meet the requirements of Article VI, Section 15 of the Louisiana Constitution of 1974, as amended, and Section 1415 of Title 33 of the Louisiana Revised Statutes of 1950, as amended, to the extent such laws are applicable. NOW THEREFORE, BE IT RESOLVED by this Parish Council, as the governing authority of the Parish:

SECTION 1. This Parish Council hereby approves and endorses the issuance and delivery of not to exceed \$150,000 Revenue Notes of the Tangipahoa Parish Convention and Visitors Bureau, in one or more series, and shall be issued under the authority of the Tourist Commission Act and Section 1430 of Title 39 of the Louisiana Revised Statutes of 1950, as amended, and other constitutional and statutory authority, or such other authority as may be determined by resolution of the Bureau at the time of the issuance of the Notes.

SECTION 2. This approval is granted in compliance with the provisions of Article VI, Section 15 of the Louisiana Constitution of 1974, as amended, and Section 1415 of Title 33 of the Louisiana Revised Statutes of 1950, as amended, to the extent such laws are applicable.

SECTION 3. The Parish President, the Council Chairman and the Council Clerk are hereby authorized and directed to do any and all things necessary and incidental to carry out the provisions of this resolution and to assist the Bureau in carrying out its functions in connection with the financing.
