10. ADOPTION of TPRFP District No. 2 Resolution 24-02 - A Resolution of support for the Central Tangipahoa LWIN Tower Project

WHEREAS, Tangipahoa Parish is committed to enhancing the ability and effectiveness of our first responders; and

WHEREAS, the ability to communicate is essential to enable our first responders to adequately protect the citizens of Tangipahoa Parish; and

WHEREAS, in 2018 Tangipahoa Parish Fire District No. 2 caused a study to be conducted which identified a 15-mile radius gap in communication; and

WHEREAS, further investigation revealed the proper location for an additional tower to fill this gap; and

WHEREAS, the additional proposed tower will cause lasting beneficial effects for all our first responders, schools, Homeland Security, and hospitals, not only in Tangipahoa Parish, but in the surrounding areas as well; and

WHEREAS, Tangipahoa Parish Emergency Management was able to secure \$570,000.00 which is allocated solely for this project, though it falls short of the total proposed costs; and

WHEREAS, Tangipahoa Parish has a successful history of working with our State Legislature to accomplish projects which benefit our community; and

WHEREAS, Tangipahoa Parish believes with the assistance of our State Legislature, evidenced by our proven track record of successful projects, we can work together to complete the Central Tangipahoa LWIN Tower Project for the better protection of our residents; therefore BE IT RESOLVED the Board of Commissioners of the Tangipahoa Parish Fire District No. 2 are in support of and respectfully request our State Legislature to assist Tangipahoa Parish in acquiring additional funding to fully complete the Central Tangipahoa LWIN Tower Project.
