UPDATE TO ADDRESS ADDITION OF VENDORS AND WHO IS ALLOWED/PROHIBITED -Item I(b) & I0 (To be added to Purchasing, Cash Disbursements and Bank Reconciliation Policy – Purchasing Section)

New Vendor Approval – Only the Fire Administrator or outside accountant shall have the authority to add a new vendor to the Approved Vendor List in QuickBooks. The Fire Administrator approves adding a new vendor to the Approved Vendor List in QuickBooks at the time the Fire Administrator approves a purchase requisition submitted by a Fire Chief and enters the Purchase Order into QuickBooks.

Once a Vendor is added to the Approved Vendor List, a properly completed, signed and dated Form W-9 must be submitted to the outside accountant, who then completes the vendor billing information when they process the vendor payments. Only the outside accountant may process vendor payments.

UPDATE TO ADDRESS ACTIONS TO BE TAKEN IF AN ETHICS VIOLATION TAKES PLACE / SYSTEM TO MONITOR POSSIBLE ETHICS VIOLATIONS – Item I(i) (to replace Procedures Section of Public Ethics Policy)

If the Fire Administrator or the outside accountant believes that a violation of the Code of Ethics may have occurred the following actions will be taken:

- The Fire Administrator will immediately notify the Board of Commissioners who in their sole discretion will decide if an investigation is needed and what action, if any, will be taken.
- Annually, the Board of Commissioners of Tangipahoa Parish Rural Fire Protection District No.2 will engage an independent auditor to perform a financial and compliance audit of the District's finances. In connection with that audit, the independent auditor will test the District's compliance with the provisions of the Code of Ethics.

UPDATE TO ADDRESS ELECTRONIC TRANSFER - Item 7 (to be added to Receipts Policy)

Generally incoming Electronic Fund Transfers (EFT) are NOT accepted by Tangipahoa Parish Rural Fire Protection District No.2. In the rare instances in which funds are received by EFT (i.e. FEMA payments, State of Louisiana payments, etc.), the notification of the incoming EFT received from the bank will be reviewed by both the Fire Administrator and the outside accountant to determine the source of the incoming EFT, the amount of the incoming EFT, the purpose of the incoming EFT and the appropriate general ledger account coding for the incoming EFT. The outside accountant will immediately notify the bank if an incoming EFT is determined by either the Fire Administrator or the outside accountant to be incorrect so that the bank can make the necessary corrections.
