AN ORDINANCE PLACING A 3-WAY STOP SIGN AT THE INTERSECTION OF W. SAM ARNOLD LOOP, S. SAM ARNOLD LOOP AND ARNOLD ROAD IN DISTRICT NO. 9 IN TANGIPAOA PARISH IN ACCORDANCE WITH CHAPTER 20, STREETS, ROADS, SIDEWALKS AND DRAINAGE - ARTICLE I, IN GENERAL - SECTION 20-16

BE IT ORDAINED by the Tangipahoa Parish Council, governing authority of Tangipahoa Parish, State of Louisiana, as follows:
