A Resolution ordering and calling a special election to be held in Rural Fire Protection District No. 2 of the Parish of Tangipahoa, State of Louisiana (the "District") on Saturday, March 26, 2022, for the purpose of authorizing the renewal of a ten (10) mill ad valorem tax on assessed valuation of all property subject to taxation in the District, for a period of ten (10) years for the purpose of improving, maintaining and operating the District's fire protection facilities, for purchasing fire trucks and other fire-fighting equipment, paying the cost of obtaining water for fire protection purposes, including charges for fire hydrant rentals and service.

WHEREAS, the Board of Commissioners of Rural Fire Protection District No. 2 of the Parish of Tangipahoa, State of Louisiana (the "Governing Authority"), acting as the governing authority of Rural Fire Protection District No. 2 of the Parish of Tangipahoa, State of Louisiana (the "District"), desires to order and call a special election to be held in the District on SATURDAY, MARCH 26, 2022, to authorize the renewal of the levy and collection of a ten (10) mill ad valorem tax on assessed valuation of all property subject to taxation in the District, for a period of ten (10) years, beginning with the year 2024 and ending with the year 2033, for the purpose of improving, maintaining and operating the District's fire protection facilities, for purchasing fire trucks and other fire-fighting equipment, paying the cost of obtaining water for fire protection purposes, including charges for fire hydrant rentals and service (the "Tax"); and

BE IT RESOLVED by the Governing Authority, that:

SECTION 1. Election Call. Subject to the approval of the State Bond Commission and under the authority conferred by La. R.S. 40:1501, Article VI, Section 30 of the Constitution of the State of Louisiana of 1974, as amended (the "Constitution") and the applicable provisions of Chapters 6 and 6-A of Title 18 of the Louisiana Revised Statutes of 1950, as amended (the "Election Code"), particularly Chapters 5 and 6-A thereof, and other constitutional and statutory authority supplemental thereto, a special election (the "Election") is hereby called and ordered to be held in the District on SATURDAY, MARCH 26, 2022, between the hours of 7:00 a.m. and 8:00 p.m. in compliance with the provisions of Section 541 of Title 18 of the Louisiana Revised Statutes of 1950, as amended (La. R.S. 18:541), and that at the Election there will be submitted to all registered voters residing in the District, qualified and entitled to vote at the Election under the Constitution and laws of the State of Louisiana and the Constitution of the United States, the following proposition, to-wit:

PROPOSITION (TAX RENEWAL)

Shall Rural Fire Protection District No. 2 of the Parish of Tangipahoa, State of Louisiana (the "District") be authorized to renew the levy and collection of a ten (10) mill ad valorem tax on assessed valuation of all property subject to taxation in the District (an estimated \$3,200,000.00 reasonably expected at this time to be collected from the levy of the tax for an entire year) ("the Tax"), for a period of ten (10) years, beginning with the year 2024 and ending with the year 2033 for the purpose of improving, maintaining and operating the District's fire protection facilities, for purchasing fire trucks and other fire-fighting equipment, paying the cost of obtaining water for fire protection purposes, including charges for fire hydrant rentals and service?

SECTION 2. <u>Publication of Notice of Special Election</u>. Pursuant to La. R.S. 18:1285, a Notice of Special Election concerning the Election will be published in the *Daily Star* (the "*Official Journal*"), a newspaper of general circulation within the District, and is the official journal of the District, once a week for four (4) consecutive weeks, with the first publication to be made not less than forty-five (45) days nor more than ninety (90) days prior to the date fixed for the Election, which notice will be substantially in accordance with the Notice of Special Election annexed hereto as <u>Exhibit A</u> and incorporated herein by reference, to the same extent as if it were set forth in full.

SECTION 3. <u>Canvass of Election Returns</u>. This Governing Authority will meet on Monday, April 25, 2022 at 5:30 p.m. at the Tangipahoa Parish Courthouse Annex, 206 East Mulberry Street, Amite, Louisiana, and will then and there in open and public session proceed to examine and canvass the official election returns and declare the results of the said Election, pursuant to Section 1292 of Title 18 of the Louisiana Revised Statutes of 1950, as amended.

SECTION 4. Polling Places; Commissioners. The polling places set forth in the attached Notice of Special Election, and situated within the corporate limits of the District, be and the same are hereby designated as the polling places at which the Election will be held. Pursuant to the provisions of La. R.S. 18:1286(B), the Commissioners-in-Charge and the Commissioners authorized to be selected by the Board of Election Supervisors to serve at the Election on SATURDAY, MARCH 26, 2022, are hereby designated as the Commissioners-in-Charge and Commissioners to serve at the polling places designated for this Election.

SECTION 5. <u>Designation of Commissioners and Commissioners-in-Charge</u>. As required in La. R.S. 18:1286(B), the officers designated to serve as Commissioners-in-Charge and Commissioners pursuant to Section 4 hereof, will hold the Election as herein provided solely in compliance with the provisions of Parts II and V of the Election Code, as amended, and will make due returns of said Election in accordance with the aforesaid provisions of the Election Code. The compensation of said officers be and the same is hereby fixed at the sum prescribed by law. All registered voters in each precinct and residing in the District are entitled to vote at the Election.

SECTION 6. <u>Authorization of the President</u>. The President of the Governing Authority be and he is hereby empowered, authorized and directed to arrange for and to furnish the election officers, in ample time for the holding of said Election, all equipment, forms and other items which may be required in order to hold said Election. The President of the Governing Authority is further authorized, empowered and directed to take any and all further action required by State and/or Federal law to arrange for the Election.

SECTION 7. Furnishing Election Call. In accordance with La. R.S. 18:1285(B)(1)(a), certified copies of this Resolution will be forwarded promptly to the Secretary of State, the Clerk of Court and Ex-Officio Custodian of Voting Machines in and for the Parish of Tangipahoa, and the Registrar of Voters in and for said Parish, as notification of the call for the Election in order that each may prepare for said Election and perform their respective functions as required by law.

SECTION 8. <u>Estimated Collections</u>. Pursuant to La. R.S. 18:1284(c), an estimated \$3,200,000.00 is reasonably anticipated at this time to be collected from the levy of the Tax for an entire year.

SECTION 9. <u>Application to State Bond Commission</u>. Application be and the same is hereby formally made to the State Bond Commission for consent and authorization to hold a special proposition election in the District, as previously specified herein, said Election to be held within the District on SATURDAY, MARCH 26, 2022, and in the event the aforesaid proposition is carried for consent and authorization to levy and collect the Tax provided for by said proposition in the amount, for the purpose and for the number of years herein specified; and that a certified copy of this Resolution will be forwarded to the State Bond Commission on behalf of the Governing Authority, together with a letter requesting the prompt consideration and approval of such application.

SECTION 10. <u>Additional Notice Requirement</u>. This Governing Authority made the announcement with respect to this Resolution required by La. R.S. 42:19.1, at its public meeting on Monday, October 25, 2021 and published said announcement in the Official Journal on Thursday, October 26, 2021. Such announcement was also transmitted via email to State Senators and Representatives on Tuesday, October 26, 2021.

INFORMATION TECHNOLOGY DISASTER RECOVERY AND BUSINESS CONTINUATION

It is the policy of the Fire Board to have an IT Disaster Recovery and Business Continuation Plan if/when facing a disaster. A disaster can be defined as any event that causes a disruption to the normal operations of the Fire District. This includes, but is not limited to, a natural disaster, major technology hack, government shutdown, etc. that greatly affects the human, economic and/or environmental aspects of the area that the Fire District serves. The goals of this Plan are to:

- Minimize interruptions to the normal operations of the Fire District;
- Establish alternative means of operation in advance of a disaster;
- Train personnel with emergency procedures in advance of a disaster; and
- Provide for smooth and rapid restoration of normal operations post disaster.

The Fire District's accounting system is set up on a virtual server outsourced to a vendor, Cloud 9, that provides daily server backups occurring overnight. The virtual server is accessible for use on two computers located in the offices of the Fire Administrator, the Assistant, the outside accountant and one Fire Chief. All computers used to access the virtual server have antiviral software supported by Cloud 9. The virtual server and all software used inside the virtual server require authentication unique to the user. The backups that Cloud 9 performs may be restored if requested by the Fire District.

PROCEDURES

To accomplish the objectives of the IT Disaster Recovery and Business Continuation Plan, the Fire District will perform the following:

- 1. The Fire Administrator and the Assistant must always have an up-to-date contact list accessible outside of their offices, i.e. secure portable electronic device, hardcopy, etc. This list should include:
 - All Department Fire Chief names, cell phone numbers and email addresses;
 - All Department Asst. Fire Chief and/or Bookkeeper names, cell phone numbers and email addresses, if applicable;
 - All Department mailing addresses, station addresses, phone numbers and email addresses, if applicable;
 - All Fire District Board Members' names, cell phone numbers and email addresses:

- Tangipahoa Parish office personnel names, cell phone numbers and email addresses; and
- Outside accountant(s) name(s) and email address(es).
- 2. The Fire District will provide its IT disaster recovery and business continuation plan to all fire chiefs and board members. This must be redistributed, at least semi-annually, when contact information is updated.
- 3. Modify the Fire District's Accounts Payable and Payroll Reimbursement activities to ensure necessary transactions are timely. This function is under the discretion of the Fire Administrator during emergency situations. Proper documentation for all transactions are still required. These transactions include, but are not limited to:
 - The Fire Administrator may approve and pay certain bills via electronic transfer so that vendors are paid timely.
 - The Fire Administrator may submit Advance Payroll Reimbursements to Departments so that firefighters' payroll is not delayed due to lack of funding.
- 4. Authentication passwords for each user on the virtual server be changed every six weeks.
- 5. Remove access to the virtual server immediately for any user terminated.
- 6. Upload and download all confidential information, i.e. monthly financial reporting, via a Secure Portal requiring unique user authentication.

SEXUAL HARASSMENT

At the present time, the Fire District has no employees. The Fire Administrator and the Assistant are employees of the Tangipahoa Parish Government, therefore, they follow the Policies and Procedures of the Tangipahoa Parish Government.

The Tangipahoa Parish Government Sexual Harassment Policies and Procedures state the following:

- If an employee experiences any job-related harassment based on sex, race, national origin, disability, or any other factor prohibited by federal, state, or local statute, or if he believes that he has been treated in an unlawful, discriminatory manner, he/she should immediately report the matter to the head of the department or to the Director of Human Resources who will undertake a prompt and thorough investigation. All complaints of harassment will be kept confidential to the maximum extent possible.
- Violation of this policy will not be tolerated. If it is determined that inappropriate conduct has occurred, Tangipahoa Parish will provide an appropriate remedy, including, but not limited to, the discipline and/or termination of the offending employee. All employees are expected to cooperate with an investigation of any type of harassment. Failure to do so may lead to discipline, including termination. Information provided by an individual will be treated as confidential and only provided to those who have the need for the information, or when it is required in the course of investigating the complaint. False information provided in the course of an investigation may lead to discipline, including discharge. Employees accused of harassment may be suspended (with or without pay) pending the outcome of the investigation. Employees who claim to have been harassed may be given time off under the leave policy.
- Tangipahoa Parish's employees are prohibited from harassing suppliers, vendors, clients, or visitors. An employee who violates this policy will be subject to discipline, up to and including termination of employment.
- Tangipahoa Parish prohibits any form of retaliation against any employee for filing a bona fide complaint under this policy or for assisting in a complaint investigation. An employee who submits a complaint in good faith, even where the complaint cannot be proven, has not violated this policy. Any employee found to have falsified a complaint of harassment or knowingly provided false information regarding a compliant will be subject to discipline, up to and including termination.
- This policy applies to all conduct by any supervisor, manager, coworker, subordinate, vendor, client, or customer that affects an employee's work environment. Each member of management is responsible for creating an atmosphere free of discrimination and harassment, sexual or otherwise. Furthermore, employees are responsible for respecting the rights of their co-workers.

(Reference: Policy and Procedure Manual – Civil Rights Act)

PROCEDURES

To accomplish the objectives of the sexual harassment policy and complaint procedures, the Fire District will perform the following:

- 1. The Fire Administrator and the Assistant will complete at least one hour of sexual harassment training during the calendar year. The Fire Administrator will obtain documentation showing this training was completed.
- 2. The Fire District will post its sexual harassment policy and complaint procedures within the Tangipahoa Parish Emergency Operations Center, 114 N. Laurel St., Amite, LA, 70422, where the offices of the Fire Administrator and the Assistant.
- 3. The Fire District will compile an annual report by February first of each year containing information from the previous calendar year regarding The Fire District's compliance to sexual harassment policies. The Louisiana Revised Statute 44:344 requires this report to include:
 - Number and percentage of public servants in the agency who have completed the training requirements;
 - Number of sexual harassment complaints received by the agency;
 - Number of complaints which resulted in a finding that sexual harassment occurred;
 - Number of complaints in which the finding of sexual harassment resulted in discipline or corrective action; and
 - Amount of time it took to resolve each complaint.
