BE IT ORDAINED by the Tangipahoa Parish Council-President Government, governing authority of Tangipahoa Parish, State of Louisiana that the Tangipahoa Parish Code of Ordinance hereby recognizes the following Chapter 16 Article II are to be revoked, then revised, and amended to read as follows in Chapter 17 Planning and Development:

Repeal Sec. 16-36. - Hunting or discharge of firearms near public highways and residences

and amend Chapter 17 as follows:

Add the following under -

ARTICLE IX – Developments with Special Provisions –

Sec. 17-9.1 Shooting Ranges

A These types of developments are recognized as General Commercial Developments and shall follow those procedures for approval with the additional requirements found herein.

(1) Public Shooting Ranges shall have a minimum parcel acreage of ten (10) acres or greater.

(2) Private Shooting Ranges shall have a minimum parcel acreage of two (2) acres or greater.

B The hours of operation for shooting ranges shall be from seven a.m. to ten p.m. daily, except for indoor or archery ranges.

C Private and public shooting ranges should substantially be constructed to comply with safety guidelines generally recognized and accepted by the National Rifle Association (NRA) and the National Shooting Sports Foundation (NSSF).

D Private and public shooting ranges shall have an implemented safety plan that substantially includes, but is not limited to, the following items:

(1) A description of the range that stipulates how, when, why, and by whom the facility will be used.

(2) The safety plan should divide rules and regulations into the categories of gun handling rules, general range rules, specific range rules, and administrative rules and regulations. Each category should substantially contain, but not be limited to, the following items:

(a) Gun handling rules

(i) Always keep the firearm pointed in a safe direction.

(ii) Always keep your finger off the trigger until ready to shoot.

(iii) Always keep the action open and firearm unloaded until ready to use.

(iv) Know your target and what is beyond the target area.

(v) Be sure the gun is safe to operate.

(vi) Know how to use your gun safely.

(vii) Wear ear and eye protection.

(viii) Never use alcohol or drugs before or while shooting.

(ix) Store guns so that they are not accessible to unauthorized persons or children.

(b) General range rules

(i) Know and obey the common range commands.

(ii) Know where others are at all times.

(iii) Shoot only at proper and authorized targets.

(iv) When two or more shooters are present, shooters should consult each other before moving down range from the firing line.

(v) Unload, open the action, ground or bench all firearms during a cease-fire or when someone moves down range to the target area.

(vi) Make sure bystanders and observers that are close to the range are wearing ear protection.(c) Specific range rules

(i) Hours of operation for shooting activities.

- (ii) Type of firearms allowed or restricted.
- (iii) Caliber or shotgun gauges allowed or restricted.
- (iv) Bullet or shot types allowed or restricted.
- (v) Target placement, type of targets, and target holders allowed or restricted.
- (vi) Type of shooting activities allowed or prohibited.

(d) Administrative rules and regulations

(i) Rules and regulations that govern the normal operation of the range and facilities such as parking, maintenance, schedules, guest policies, fees, security, supervision, sign-in procedures, and etc.

(ii) Procedure to spot-check range users for compliance to range rules.

(iii) Penalties, sanctions, or consequences for violations of the range rules and regulations.

(3) This safety plan shall be posted in a prominent location on the range and range members or users shall be made aware of the safety plan before firing on the range.

E. Any completely enclosed or indoor firing range shall be exempt from the special regulations of this subsection provided that the facility is fully enclosed and constructed in such a manner as to prevent bullets and/or shots from exiting the structure through the side walls and/or the roof and/or rear areas adjacent to the targets.

F. Any structures constructed on a firing range in the parish shall be subject to the applicable building codes of the parish as well as these regulations.

G. Any person violating the provisions of this section, unless that person is a law enforcement officer or policeman acting within the scope and course of his or her duties and employment, shall be guilty of a violation of the criminal law and shall be subject to punishment, as provided in section 1-13 of this Code.

(1) The discharge of any firearm or gun within 250 feet of any inhabited dwelling or any other building or structure, where a person or persons can reasonably be expected to be present, without the express permission of the owner of the said dwelling, building or structure is prohibited.

(2) The discharge of a firearm or gun within 100 feet of any public street, highway, road or thoroughfare is prohibited.

(3) Furthermore, members of the public damaged by a violation of this section are entitled to bring an action against the violator for any damages that occur as a result of the violation.

Add the following under –

ARTICLE XI - DEFINITIONS

Public shooting range means a place that is designed or intended for the safe discharge, on a regular and structured basis, of firearms for the purpose of target practice or recreational target shooting. This is a shooting range where a daily user fee or annual membership fee is charged.

Private shooting range means a place that is designed or intended for the safe discharge of firearms for the purpose of private use by the property owner or lessee or educational purposes associated with a business who offers instructional classes.

Shooting club means a organization whose activities include target practice or target shooting competitions using restricted firearms or prohibited handguns at an identified approved private shooting range. This is a private shooting range where a person must be a member of a group to be allowed to use the facility and membership requires the payment of dues or fees.

Shooting range also known as "firing range" or "range" means an area designed and operated primarily for: persons using or discharging rifles, shotguns, pistols, revolvers, or black powder weapons; archery; air rifles; silhouettes; skeet ranges; trap ranges; or any other similar sport shooting, if such area is designed and constructed in accordance with the then current publication of the National Rifle Association of America, or its successor, entitled "The Range Manual".

Tangipahoa Parish Council Clerk Job Description

Summary:

Under direction of the Parish Council, the Council Clerk works with minimal supervision or direction to accomplish tasks. Works independently in the planning, organization and supervision of daily operations of the Council Office. Responsible for the efficient and effective performance of the administrative and technical operations of the Council Office. Exercises judgment in resolution of various day-to-day problems/issues. Participates in appropriate training and educational opportunities, including attendance at conferences and seminars.

Work involves creating, coordinating, and maintaining a permanent record of Council actions including historical and current official records; researching, interpreting and analyzing various reports and activities; The position requires the use of considerable judgment and independent action. The Clerk to the is responsible for responding to requests from the general public, the news media and Parish employees for information and/or services.

Essential Duties and Responsibilities:

Serves as Clerk of the Parish Council, including preparing agendas for Council meetings, gathering information for meeting agenda packets, and notifying Council members, appropriate Parish staff, news media, and other interested parties of dates and times of Council meetings; attends Council meetings, committee meetings, workshops, etc., and composes a full and accurate account of all actions taken at meetings of the Council. Prepares minutes as historical account for public inspection; prepares follow-up correspondence to notify departments and/or individuals of actions required by the Council; informs news media and/or general public of Council actions in response to inquiries or as otherwise deemed appropriate. Works in coordination with financial advisor and any appropriate Districts for upcoming bond, election, or tax issues. Performs general clerical support for Council members and operation of Council office. Serves as a link between Council members and citizens or other Parish staff as needed.

The Clerk is responsible for the maintenance of official records including minutes, ordinance books, resolution books, and MuniCode (online code of ordinances). Prepares certified copies of documents including ordinances, resolutions and minutes, and provides public access to Parish records if requested by public records request as required by state public records laws. The Clerk is responsible for the legal advertisement and/or posting of notices, agendas, minutes, etc. as required by state law.

The Clerk must keep up to date information on all Parish-appointed board and commission appointments, bringing to the Council's attention the appointments that need to be made.

The Clerk answers inquiries, providing information based on considerable knowledge of Parish programs and activities. The Clerk must be able to answer questions intelligently, and/or direct the public to information about the functions of all other levels of government--municipal, state and federal. Refers issues requiring other resources to the correct department or agency and coordinates third party involvement in complaint resolution. Keeps track of all requests for road name changes and presents collected requests at appropriate meeting.

Schedules, coordinates, and calendars meetings for Council members as necessary, ensuring availability of rooms, equipment, materials, refreshments, etc., as requested or otherwise deemed necessary. Notification of Council members of all community event/ meeting invitations. Coordinates

scheduling, travel arrangements, reimbursements, etc. for attendance at meetings, conferences, or workshops as necessary. The Clerk coordinates state required training, including, but not limited to ethics and sexual harassment training annually for all council members, and forwards training certificates to appropriate parties. Plans Council hosted special events as needed.

Serves as Council liaison during a declared state of emergency.
