Please look over the Deductible Options:

The previous premium BEFORE the renewal was at \$287,473.00

The Board approved at the last meeting the premium renewal at \$323,557.11

If we raise the deductible on both the Property and Auto to \$3000.00 the premium will be \$302,929.80. That is an increase of \$15456.80.

If we raise the deductible on both the Property and Auto to \$5000.00 the premium will be \$286,770.62. That is a decrease in the premium of \$702.38.

I would recommend that we increase the deductible to \$5000.00. I believe that would cut down on claims made to the insurance company and produce a savings of \$702.38.
