## **COOPERATIVE ENDEAVOR AGREEMENT**

This Cooperative Endeavor Agreement is entered into by and between the: **CITY OF HAMMOND** ("City"), whose address whose address for purpose of notice under this Agreement is 310 East Charles Street, Hammond, Louisiana 70401, represented through its Mayor, duly authorized; **TANGIPAHOA PARISH GOVERNMENT** ("Parish"), whose address for purpose of notice under this Agreement is PO Box 215, Amite, Louisiana 70422, represented by its Parish President, duly authorized; and **THE HEIGHTS APARTMENTS, LLC**, ("Heights") whose address for purpose of notice under this Agreement is 1250 Southwest Railroad Avenue, Suite 100A-2, Hammond, Louisiana 70403, represented through its authorized representative, Toby Easterly, who each declare and agree as follows:

**WHEREAS**, Article VII, Section 14(c) of the Constitution of the State of Louisiana provides that "for a public purpose, the state and its political subdivisions ... may engage in cooperative endeavors with each other ... or with any public or private association, corporation, or individual"; and

**WHEREAS**, the City is a home rule charter government, having all powers not denied by its charter or by general law or inconsistent with the constitution, including but not limited to the specific authority to enter into joint service agreements or cooperative efforts with other governmental agencies and political subdivisions and private entities for a public purpose, as well as to pass ordinances to promote, protect and preserve the general welfare, safety, health, peace and good order of the citizens of the City; and

**WHEREAS**, the City, Parish, and Heights desire to enter into this agreement for the design, bid and construction of road improvements on John Lambert Drive in the City of Hammond (the "Project"); and

**WHEREAS**, the Project will enhance the quality of life and improve the community of the City of Hammond and Tangipahoa Parish through economic development; and

**WHEREAS**, Heights intend to place and improve property along John Lambert Drive into commerce through construction and development and thereby providing attractive commercial space for businesses in Hammond; and

**WHEREAS**, the City and Parish believe the Project is of benefit to the region; and

**WHEREAS**, the Project and the terms of this Agreement are consistent with the mission and purpose of the City and Parish.

**NOW THEREFORE**, in consideration of the covenants and agreements hereinafter set forth to be kept and performed by the parties hereto, it is agreed by and between the parties as follows:

## **SCOPE OF AGREEMENT**

The Parish shall have sole responsibility for the design, bid and contract for the construction of the Project. The Project shall be in accordance with the Public Bid law as applicable.

The City, Parish, and Heights shall share the total costs of the Project. The City and Parish shall each contribute one-fourth of the total cost, and Heights shall contribute one-half of the total cost. The total cost, including engineering design and construction, is estimated at one hundred and twenty-five thousand dollars (\$125,000.00).

The Parish shall provide written notice to the City, and Heights of competition of the Project with documentation of the total cost of the Project. The City, and Heights shall pay the Parish their respective share of the Project costs within Thirty (30) days after receipt of the notice of completion.

The long term maintenance of John Lambert Drive will be the responsibility of the City.

## **ASSIGNMENT**

The Parties shall not assign any interest in this Agreement, except the Parish is expected to engage a third party contractor to construct the Project. This Agreement shall be binding on the successors and permitted assigns of the parties hereto.

## **AUDITING AND FINANCIAL RESPONSIBILITY**

The Parish shall maintain accurate books and records of the Project expenses and shall deliver such records to the City, and Heights upon request.

This Agreement does not impose any financial obligation on the Parties other than those included in this Agreement, and the Parties shall be responsible for expenses of the project as specifically set forth herein.

## **DISCRIMINATION CLAUSE**

The Parties shall not discriminate in its practices, and will operate under this agreement without regard to race, color, religion, or national origin.

## **ENTIRE AGREEMENT; MODIFICATION; MULTIPLE COUNTERPARTS**

This Agreement, including any attachments that are expressly referred to in this Agreement, contains the entire agreement between the Parties and supersedes any and all agreements or contracts previously entered into between the parties. No representations were made or relied upon by either party, other than those that are expressly set forth. This Agreement may be modified or amended at any time by mutual consent of the Parties, provided that, before any modification or amendment shall be operative and valid, it shall be reduced to writing and signed by authorized representatives of all Parties. This Agreement may be executed in multiple counterparts.

**CONTROLLING LAW**

The validity, interpretation and performance of this Agreement shall be controlled by and construed in accordance with the laws of the State of Louisiana.

**LEGAL COMPLIANCE**

The Parties shall comply with all federal, state, and local laws and regulations in compliance with the obligations of this Agreement.

WHEREAS, **JOHN PATE** has offered to donate to the Tangipahoa Parish Council-President Government a parcel of property being 60' strip of land in Section 28, Township 6 South-Range East

THEREFORE BE IT ORDAINED by the Tangipahoa Parish Council, the legislative branch of parish government, which along with the Parish President of Tangipahoa Parish, Louisiana constitute the parish government, the said Tangipahoa Parish Council-President Government having a Home Rule form of government and acting pursuant to the authority of that Home Rule Charter which became effective on October 27, 1986 as follows:

That the Tangipahoa Parish President or his authorized designee as the representative of and for and on behalf of the Tangipahoa Parish Council-President Government, be and is hereby authorized, empowered and directed to accept from the donor, John Pate the following described parcel of property described as certain tract of land designated tract number 18 containing 2.026 acres on a boundary survey on the John Pate mini partition of Lot 1 of the Albert Torres lot line revision in Section 28, Township 6 South-Range East, as shown on the survey by Andrew N. Faller, P.L.S. dated July 1, 2020 being approximate 60' in width beginning at the edge of Old Covington Highway and traversing the property of John Pate as shown on said survey of south boundary of the tract is the Section line between Section 28 and section 33 6 South Range 8 East.

BE IT FURTHER OBTAINED that upon the acceptance of the donation of the hereinabove described property from the donor, John Pate, this property shall thereafter belong to and be owned in full fee simple ownership by the Tangipahoa Parish Council-President Government.

The polling places set forth in the attached Notice of Special Election, and situated within the corporate limits of the District, be and the same are hereby designated as the polling places at which the Election will be held. Pursuant to the provisions of La. R.S. 18:1286(B), the Commissioners-in-Charge and the Commissioners authorized to be selected by the Board of Election Supervisors to serve at the Election on SATURDAY, DECEMBER 5, 2020, are hereby designated as the Commissioners-in-Charge and Commissioners to serve at the polling places designated for the Election.

Shall the Parish of Tangipahoa, State of Louisiana (the “Parish”) be authorized to renew the levy and collection of a tax of one percent (1%) (the “Tax”) (an estimated \$23,500,000.00 is reasonably expected at this time to be collected from the levy of the Tax for an entire year), upon the sale at retail, the use, the lease or rental, the consumption, and the storage for use or consumption, of tangible personal property and on sales of services in the Parish for a period of four (4) years, beginning December 31, 2021, with the net proceeds of the Tax (after deducting the reasonable and necessary cost of collecting and administering the Tax) to be dedicated and used exclusively as follows: twenty-five percent (25%) of the proceeds of the Tax to be used to pay the cost of operation of local government and seventy-five percent (75%) of the proceeds of the Tax to be used to fund the Parish Road and Bridge Fund in order to pay the cost of road and bridge maintenance and improvements within the Parish?

R.S. 18:1287), will make due returns thereof to the Parish Council, as governing authority of the Parish, and NOTICE IS HEREBY FURTHER GIVEN that said Parish Council, acting as governing authority of the Parish, will meet

at its regular meeting place, the Tangipahoa Parish Courthouse Annex, 206 East Mulberry Street, Amite, Louisiana, on MONDAY, JANUARY 11, 2021 at 5:30 p.m., and will then and there in open and public session proceed to examine and canvass the returns and declare the result of the special election. All registered voters residing in the Parish are entitled to vote at said special election and voting machines will be used in connection therewith.
