EXPLANATION OF CHANGE ORDER: Item Nos. A-RW-4 thru A-RW-14, A-RW-18 thru A-RW-20: Quantity adjustment to reflect actual quantities installed or anticipated to be needed due to changes requested by the Parish to the pavement section in Reach 3.

Item Nos. A-SD-2 thru A-SD-7 and A-SD-9: Quantity adjustment to reflect actual quantities installed as required for subsurface drainage elements necessitated by conflicts with existing utilities.

Item Nos. A-SD-8 and X-001: Add two CB-01 (Item A-SD-8) and additional item (X-001) to provide additional drainage requested by the Parish to enhance drainage in front of the Second Rose Hill Church.

Item Nos. X-002 thru X-008: Add items to provide the new pavement section in Reach 3 as requested by the Parish.

Item No. X-009: Add item for the additional costs incurred to provide mast arms required by the Louisiana Department of Transportation and Development (LADOTD). These are different mast arms than had been approved by LADOTD prior to construction.

Item No. X-010: Add item to provide riprap armoring at pipe outfalls as requested by the Parish.

Item No. X-011: Add item to provide for the construction of two additional drain manholes required at North Oaks Drive. During construction it was found that there are existing live drains running along each side of North Oaks Drive near the intersection with Club Deluxe Road. So that these stub-outs remain live, they were connected to the drainage system along Club Deluxe Road. Two additional drainage structures were required to tie-in these drain lines.

Item No. X-012: Add item to provide for the construction of two conflict structures at an existing gravity sewer line and an existing sewage force main. During construction it was found that the actual depths of a crossing gravity sewer and a crossing sewage force main conflicted with the proposed subsurface drain line along Club Deluxe Road. Conflict structures were necessary at these locations.

Add 10 calendar days for the additional time required to install the additional embankment in Reach 3 per Item A-RW-7.

Add 3 calendar days for the additional time required to procure materials and perform the work required for Item X-001.

Add 4 calendar days for the additional time required to procure materials and perform the work required for Item X-010.

Add 6 calendar days for the additional time required to procure materials and perform the work required for Items X-011 and X-012.

Add 31 calendar days for delays due to conflicts with private utilities.

Add 32 calendar days for delays caused by inclement weather beyond reasonably anticipated days.

This Change Order includes not only all direct costs of the Contractor such as labor, material, job overhead and profit mark-up but also includes any costs, modifications or changes in the sequence of the Work to be performed, delays, rescheduling, disruptions, extended direct or general overhead, acceleration, any escalation including but not limited to escalation in material or wages, and any other impact costs and any extensions of time to the Contract Times related to the changes herein. It is further understood and agreed that the amounts and any additional time included in this Change Order are hereby accepted on behalf of the Contractor, its subcontractors and suppliers as full and final compensation from the Owner for all extended field and home office overhead costs for those items, and that neither the Contractor nor its subcontractors or suppliers shall seek any additional compensation of any kind or any additional extensions of the Contract Time from the Owner for the changes included herein, for the additional work specifically added by this Change Order.

T.P. Ordinance No. 19-01

AN ORDINANCE PLACING 15 MPH SPEED LIMIT SIGNS AND SLOW WATCH FOR CHILDREN SIGNS ON THE EAST END OF E. FENDALSON ROAD IN DISTRICT NO. 7 IN TANGIPAHOA PARISH IN ACCORDANCE WITH CHAPTER 20, STREETS, ROADS, SIDEWALKS AND DRAINAGE - ARTICLE I, IN GENERAL - SECTION 20-16

BE IT ORDAINED by the Tangipahoa Parish Council, governing authority of Tangipahoa Parish, State of Louisiana, as follows:

- 1) 15 MPH Speed Limit Signs on the East end of E. Fendalson Road in District No. 7
- 2) Slow Watch for Children Signs on the East end of E. Fendalson Road in District No. 7

in Accordance With Chapter 20, Streets, Roads, Sidewalks And Drainage - Article I, in General - Section 20-16.
