SUMMARY:	The City has received notice from the Municipal Health Benefit Fund of a premium rate increase. Due to the City's loss ratio, the rate class will move from class 5 to class 6. The health insurance premium for employee only coverage will increase from \$492.08 to \$532.08 (\$40.00) and employee + family coverage will increase from \$1,084.20 to \$1,184.20 (\$100.00). The City's current contribution towards the employee only coverage is \$456.08. We are asking the City to assume the increase which will bring the City's contribution to \$496.08 (\$40 increase) for employee only coverage and \$556.08 (\$100 increase) for employee + family coverage. This increase will go into effect January 2022 and will be reflected in the 2022 budget.

Resolution

RESOLUTION NO. _____

WHEREAS, the City has received notice from Municipal Health Benefit Fund (MHBF) of a premium rate increase which will begin January 1, 2022, due to MHBF rate class change; and

WHEREAS, as a result of the rate class change, the premium for single employee coverage will increase from \$492.08 per month to \$532.08 per month (an increase of \$40.00 per month) and the premium for employee and family coverage will increase from \$1,084.20 to \$1,184.20 (an increase of \$100.00 per month); and

WHEREAS, the City currently contributes \$456.08 per month for participating employee coverage (single participants and family participants), with the remainder being contributed by the employee; and

WHEREAS, the MHBF's open enrollment period will soon occur and likely be completed prior to adoption of the City FY2022 Budget; and

WHEREAS, while the City's FY2022 Budget is currently being prepared, but to assist employees in making participation decisions, it is anticipated that said budget will provide for the premium increase by increasing the City's contribution for single participating employees to \$496.08 (a like \$40.00 per month increase) and \$556.08 (a like \$100.00 per month increase) for employee and family coverage, with the remaining differences being contributed by the employee;

NOW, THEREFORE, BE IT RESOLVED; that MHBF's anticipated premium increase described above is hereby recognized and that, notwithstanding said increase, the City does not anticipate any additional employee contribution toward satisfaction of the same.
