The police department is actively working to update our aging fleet to avoid continued increases in maintenance and fuel experienced in the past. In 2019 we were budgeting \$150,000 this figure has continued to decrease with the purchase of new hybrid patrol vehicles. We are projected to finish our current 2021 budget at \$93,000.</p> <p>The hybrid vehicles have also allowed us to see decreases in fuel expenses over the same time frame in 2020 we were down approximately \$17,000 from the 2019 year and in 2021 we are projected to be under budget by \$12,000, all while experiencing significant increases in cost per gallon in motor fuel.</p>
