### ORDINANCE NO. 2-2023

# AN ORDINANCE RENAMING THE POSITION OF VICE MAYOR AS ASSISTANT MAYOR AS CONTEMPLATED BY STATUTE AND ESTABLISHING A ROTATION ORDER FOR SAID POSITION; AND FOR OTHER PURPOSES

WHEREAS, traditionally, every two years the Board of Directors elects from among their membership a "vice mayor" (being the same position as the position of "assistant mayor" contemplated by Ark. Code Ann. Section 14-47-117); and

WHEREAS, said statutory provision allows for the establishment of a rotation structure for such position; and

WHEREAS, the Board desires to establish a rotation order for such position as contemplated herein;

**NOW, BE IT ORDAINED** by the Board of Directors of the City of Texarkana, Arkansas, that:

<u>Section 1.</u> Section 2-52 of the Code, being a provision likely contrary to applicable law (including, without limitation, Ark. Code Ann. 14-47-119) is deleted, and the following is substituted therefore:

Sec. 2-52. – Assistant Mayor and Rotation of Assistant Mayor Position.

- a) The position traditionally known as "vice-mayor" is now formally designated and shall be hereafter known as "assistant mayor" and carry with it the powers and duties contemplated by Ark. Code. Ann. Section 14-47-117, or any successor thereto.
- b) The position of assistant mayor shall be rotated among the membership of the board of directors as follows:
  - 1) Term. The assistant mayor's term shall be for one year commencing on the first day of January of each year.
  - 2) Rotation order. The assistant mayor's position shall be rotated among the directors in the following order: Ward 1, Ward 6, Ward 2, Ward 4, Ward 5, Ward 3. At the first regular board meeting in January of each year, the mayor shall announce the director who will be serving as assistant mayor for that term.

- 3) Succession. Should a director not desire or otherwise be unable to serve a term as assistant mayor, the next willing director in the rotation order shall serve. A director is not prohibited from serving two terms as assistant mayor but shall not serve two consecutive terms unless there is no other director willing to serve.
- 4) Acting mayor. In the event that both the mayor and the assistant mayor should be absent or disabled from performing their duties, the next willing director in the rotation order shall serve as acting mayor during such absence or disability and no longer. This paragraph (4) shall have no effect on the provisions of (1), (2), or (3) above.
- c) The first term under the rotation structure (Ward 1) contemplated hereby shall commence January 1, 2023.

### ORDINANCE NO. K-598

#### AN ORDINANCE PROVIDING FOR THE LEVY OF A ONE-FOURTH OF ONE PERCENT (1/4%) SALES AND USE TAX WITHIN THE CITY OF TEXARKANA, ARKANSAS; AND PRESCRIBING OTHER MATTERS PERTAINING THERETO

WHEREAS, electors of the City of Texarkana, Arkansas, pursuant to the provisions of *Arkansas Code Annotated* §26-75-213, have filed petitions requesting the levy of a one-fourth of one percent (¼%) sales and use tax within the City of Texarkana, Arkansas, for the purpose of Texarkana, Arkansas, Fire Department salary increases and maintaining base pay parity between the fire departments of Texarkana, Arkansas, and Texarkana, Texas; any excess funds generated by such tax shall fund, equally, each year (a) the Texarkana, Arkansas, Fire Department Pension Fund and (b) a Public fire Prevention Education Program within the public schools and low income families to be operated and maintained by an independent board of the Texarkana, Arkansas Firefighters Association;

WHEREAS, said petitions have been filed with and verified by the City Clerk as containing the signatures of at least fifteen percent (15%) of the electors of the City as determined by the total number of votes cast for all candidates for Mayor of the City at the last preceding general election;

WHEREAS, under the circumstances described above, Arkansas Code Annotated §26-75-213 obligates the governing body of the City to levy the sales and use tax sought in said petitions and to call a special election to approve such levy;

NOW, THEREFORE, BE IT ORDAINED by the Board of Directors of the City of Texarkana, Arkansas:

Section 1: Under the authority of *Arkansas Code Annotated* §26-75-213, there is hereby levied a one-fourth of one percent (¼%) tax on the gross receipts from the sale at retail within the City of all items which are subject to the Arkansas Gross Receipts Tax Act of 1941, as amended (*A.C.A.* §26-52-101, et seq.), and the imposition of an excise (or use) tax on the storage, use or other consumption within the City of tangible personal property subject to the Arkansas Compensating Tax Act of 1949, as amended (*A.C.A.* §26-53-101, et seq.), at a rate of one-fourth of one percent (¼%) of the sale price of the property or, in the case of leases or rentals, of the lease or rental price (collectively, the "Sales and Use Tax"). The Sales and Use Tax shall be levied and collected only on the first \$2,500 for each single transaction.

Section 2: "Single transaction" is defined according to the nature of the goods purchased as follows:

A. When two or more devices in which, upon which, or by which any person or property is, or may be, transported or drawn, including but not limited to, on-road vehicles, whether required to be licensed or not, off-road vehicles, farm vehicles, airplanes, water vessels, motor vehicles, or non-motorized vehicles and mobile homes, are sold to a person by a seller, each individual unit, whether part of a "fleet" sale or not, shall be treated as a single transaction for the purpose of the Sales and Use Tax.

B. The charges for utility services, which are subject to the Sales and Use Tax, and which are furnished on a continuous service basis, whether such services are paid daily, weekly, monthly, or annually, for the purposes of the Sales and Use Tax, shall be computed in daily increments, and each such daily

charge increment shall be considered to be a single transaction for the purposes of the Sales and Use Tax.

C. For sales of building materials and supplies to contractors, builders, or other persons, a single transaction, for the purposes of the Sales and Use Tax, shall be deemed to be any single sale which is reflected on a single invoice, receipt or statement, on which an aggregate sales (or use) tax figure has been reported and remitted to the State of Arkansas.

D. When two or more items of major household appliances, commercial appliances, major equipment, and machinery are sold, each individual unit shall be treated as a single transaction for the purposes of the Sales and Use Tax.

E. For drug items, dry goods, and other tangible personal property and/or services not otherwise expressly covered in this Section, a single transaction shall be deemed to be any single sale which is reflected on a single invoice, receipt, or statement, on which an aggregate sales tax figure has been reported and remitted to the State of Arkansas.

Section 3: That all ordinances and parts thereof in conflict herewith are hereby repealed to the extent of such conflict.

Section 4 That this Ordinance shall not take effect until an election is held on the question of levying the Sales and Use Tax at which a majority of the electors voting on the question shall have approved the levy of the Sales and Use Tax.

## ORDINANCE NO. K-601

AN ORDINANCE CALLING SPECIAL ELECTION IN THE CITY OF TEXARKANA, ARKANSAS, ON THE QUESTION OF LEVYING A ONE-FOURTH OF ONE PERCENT (1/4%) SALES THE CITY USE TAX WITHIN TEXARKANA, **ARKANSAS:** PRESCRIBING OTHER MATTERS PERTAINING THERETO; AND DECLARING AN EMERGENCY

WHEREAS, electors of the City of Texarkana, Arkansas, pursuant to the provisions of *Arkansas Code Annotated* §26-75-213, have filed petitions requesting the levy of a one-fourth of one percent (¼%) sales and use tax within the City of Texarkana, Arkansas, for the purpose of Texarkana, Arkansas, Fire Department salary increases and maintaining base pay parity between the fire departments of Texarkana, Arkansas, and Texarkana, Texas; any excess funds generated by such tax shall fund, equally, each year (a) the Texarkana, Arkansas, Fire Department Pension Fund and (b) a Public fire Prevention Education Program within the public schools and low income families to be operated and maintained by an independent board of the Texarkana, Arkansas, Firefighters Association;

WHEREAS, said petitions have been filed with and verified by the City Clerk as containing the signatures of at least fifteen percent (15%) of the electors of the City as determined by the total number of votes cast for all candidates for Mayor of the City at the last preceding general election;

WHEREAS, under the circumstances described above, Arkansas Code
Annotated §26-75-213 obligates the governing body of the City to levy the sales

and use tax sought in said petitions and to call a special election to approve such levy;

NOW, THEREFORE, BE IT ORDAINED by the Board of Directors of the City of Texarkana, Arkansas:

Section 1: That there be, and there is hereby called, a special election to be held on Movember 5, 1996, at which election there shall be submitted to the electors of the City the question of the levy of said Sales and Use Tax.

<u>Section 2</u>: That the question of levying the Sales and Use Tax shall be placed on the ballot for the election in substantially the following form:

Vote on measure by placing and "X" in the square opposite the measure either for or against: FOR adoption of a 14% local sales and use tax within the City of Texarkana, Arkansas, for the purpose of Texarkana, Arkansas, Fire Department salary increases, and maintaining base pay parity between the fire departments of Texarkana, Arkansas, and Texarkana, Texas. Any excess funds generated by such tax shall fund, equally, each year (a) the Texarkana, Arkansas, Fire Department Pension Fund; and (b) a Public Fire Prevention Education Program within the public schools and low income families to be operated and maintained by an independent board of the Texarkana, Arkansas, Firefighters Association AGAINST adoption of a 1/4% local sales and use tax within the City of Texarkana, Arkansas, for the purpose of Texarkana, Arkansas, Fire Department salary increases, and maintaining base pay parity between the fire departments of Texarkana, Arkansas, and Texarkana, Texas. Any excess fund generated by such tax shall fund, equally, each year (a) the Texarkana, Arkansas, Fire Department Pension Fund; and (b) a Public Fire Prevention Education Program within the public schools and low income families to be operated and maintained by an independent board of the Texarkana, Arkansas, Firefighters

Section 3: That the election shall be held and conducted and the vote canvassed and the results declared under the law and in the manner now provided for municipal elections unless otherwise provided in Title 26, Chapter 75, Subchapter 2 of the Arkansas Code of 1987 Annotated (the "Authorizing

Association

•

Legislation") and only qualified voters of the City shall have the right to vote at the election.

Section 4: That the results of the election shall be proclaimed by the Mayor, and his Proclamation shall be published one time in a newspaper published in the City and having a general circulation therein, which. Proclamation shall advise that the results as proclaimed shall be conclusive unless attached in the courts within thirty days after the date of publication.

Section 5: That a copy of this Ordinance shall be given to the Miller County Board of Election Commissioners so that the necessary election officials and supplies may be provided. A certified copy of this Ordinance shall also be provided to the Commissioner of Revenues of the State of Arkansas as soon as practical.

Section 6: That the Mayor and City Board of Directors, for and on behalf of the City be, and they are hereby authorized and directed to do any and all things necessary to call and hold the special election as herein provided and, if the levy of the Sales and Use Tax is approved by the electors, to cause the Sales and Use Tax to be collected in accordance with the Authorizing Legislation, and to perform all acts of whatever nature necessary to carry out the authority conferred by this Ordinance.

<u>Section 7</u>: That all ordinances and parts thereof in conflict herewith are hereby repealed to the extent of such conflict.

Section 8: It is hereby ascertained and declared that there is a great need to establish a stable source of revenue to finance vital municipal services in order to promote and protect the health, safety, and welfare of the City and its inhabitants. It is, therefore, declared that an emergency exists, and this Ordinance being necessary for the immediate preservation of public peace,

health, and safety shall be in force and take effect immediately from and after its passage.

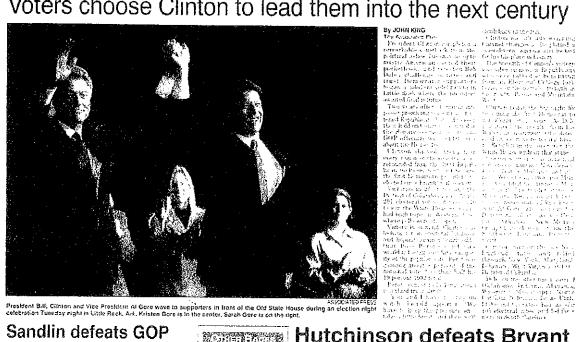

### ORDINANCE NO. 2-236

AN ORDINANCE TO AMEND ORDINANCE L-234 TO ESTABLISH REVISED PARITY PAY RULES AND TO REGAIN AND MAINTAIN PARITY PAY FOR THE TEXARKANA, ARKANSAS FIRE DEPARTMENT; FOR DECLARING AN EMERGENCY; AND FOR OTHER PURPOSES.

WHEREAS, the Board of Directors of the City of Texarkana, Arkansas, desire to establish parity pay rules and to regain and maintain parity pay for the Texarkana, Arkansas Fire Department to better effectuate the ¼-cent sales and use tax increase for the purpose of Texarkana, Arkansas Fire Department salary increases, and maintaining base pay parity between the fire departments of Texarkana, Arkansas, and Texarkana, Texas, approved by the voters of Texarkana, Arkansas, at the special election held on November 5, 1996; and

WHEREAS, the Board of Directors has consulted with the Fire Department and a mutually satisfactory agreement has been reached in this connection;

NOW, THEREFORE, BE IT ORDAINED by the Board of Directors of the City of Texarkana, Arkansas, that ordinance L-234 is amended, and that the following revised definitions and rules are enacted to carry out the purpose stated above:

#### Section 1. Definitions:

- A. Parity--the yearly base pay for each member of the Texarkana. Arkansas Fire Department is equal to the yearly base pay of their Texarkana, Texas Fire Department counterparts.
- B. Cost of Parity—The amount of money it takes to pay for the increase in base pay, and the incremental increases in benefits, that causes increases in employer contributions related to such base pay increases, i.e., Workers Compensation. Holiday Pay, Medicare, and retirement.

#### Section 2. Rules:

- A. The City shall fund parity raises for the members of the Texarkana. Arkansas Fire Department from the Texarkana, Arkansas Fire Department parity tax revenues, general revenues, or both.
- B. For a new employee of the Texarkana, Arkansas Fire Department no cost of the employee's base pay shall apply to the cost of parity pay during their first year of employment.
- C. Any years that the Texarkana, Arkansas Fire Department Parity Pay
   Tax collects enough money to pay for parity, parity will be met.
- D. Any years that the Texarkana, Arkansas Fire Department Parity Pay Tax does not collect enough money to pay for parity, and the City's unappropriated fund balance is less than 15%, and parity is not being met, the members of the Texarkana, Arkansas Fire Department will receive an increase of at least 3% towards the parity.
- E. Any years that the City of Texarkana, Arkansas's unapropriated fund balance is more than 15%, and parity is not being met, the members of the Texarkana. Arkansas Fire Department will receive the greater of a 4% increase, or 1% higher than the increase given to the Texarkana, Texas Fire Department members, each year until parity is met.

F. If any department is given parity with their Texarkana, Texas counter part, the Texarkana, Arkansas Fire Department will also receive an increase to meet parity.

G. This agreement is conditioned on adoption of financial policies by the Board of Director's. These policies would begin the process of rebuilding the City's General Fund unappropriated balance to a minimum of 15 percent of the budgeted expenses. For example, the City should consider a policy that would limit the rate of growth in expenditures to 4-5%.

H. If at the end of a five year period, if the City has not achieved an unrestricted general fund balance of 15%, then the City agrees to meet with Fire Department to discuss how to achieve parity.

#### Section 3. Emergency Clause:

This Ordinance being necessary for the preservation of the public peace, health and safety, an emergency is therefore declared to exist; and, this Ordinance shall be in full force and effect from and after its passage and approval.

## PETITION FOR DECLARATORY RELIEF AND WRIT OF MANDAMUS

The Plaintiffs. John Warmack, et al, by and through undersigned counsel, state the following in support of their *Petition for Declaratory Relief and Writ of Mandamus*:

#### I. Introduction

- This is an action for declaratory relief brought by citizens and residents of Miller County and the State of Arkansas pursuant to the Arkansas Declaratory Judgment Act, Arkansas Code Annotated §§ 16-111-102. -103, and -104, challenging the City of Texarkana, Arkansas implementation of Ordinance No. K-553 and K-554 that provide for the collection of a special sales and use tax for the purpose of Texarkana, Arkansas Police Department ("TAPD") salary increases and for the maintenance of base pay salary parity between the police departments of Texarkana, Arkansas, and Texarkana, Texas.
- 2. The Defendants named herein are named only in their official capacities and are named as the city officials responsible for the implementation and enforcement of Ordinance No. K-554.

- 3. On November 20, 1995, the Board of Directors of the City of Texarkana. Arkansas (also referred to herein as "the City"), passed Ordinance No. K-553, providing for the levy of a one-fourth of one percent (.25%) sales and use tax within the City for the purpose of TAPD salary increases, and maintaining base pay salary parity between the police departments of Texarkana. Arkansas, and Texarkana, Texas.
- 4. On December 6, 1995, the Board of Directors of the City of Texarkana, Arkansas passed Ordinance No. K-554, calling a special election to submit the question of the levy of the special sales and use to the electors.
- 5. On January 9, 1996, 2,903 citizens of Texarkana, Arkansas, voted FOR adoption of a .25% local sales and use tax within the City for the purpose of TAPD salary increases and maintenance of base pay salary parity between the police departments of Texarkana, Arkansas, and Texarkana. Texas.
- 6. While the City has continued to collect the proceeds from special sales and use tax, the City has not maintained salary parity.

#### II. Jurisdiction and Venue

- 7. This Court has subject matter jurisdiction pursuant to Arkansas Code Annotated §§ 16-111-102, -103.
- 8. Proper venue lies in Miller County because the Plaintiffs reside here, the cause of action arose in Miller County, and the Defendants are city officials of the City of Texarkana. Arkansas located in Miller County, Arkansas.

#### III. Parties

- 9. Plaintiffs, John Warmack et al (listed on Exhibit "A") are residents of the City of Texarkana. Arkansas. Each named person on Exhibit "A" has reviewed this Pleading and has agreed to be a named pares Plaintiffs.
- 12. Separate Defendant Ruth Penney Bell is the Mayor of the City of Texarkana. Arkansas.
- 13. Separate Defendant Dr. Kenny Haskin is the City Manager of the City of Texarkana. Arkansas. As the top appointed official in the City, Dr. Kenny Haskin is responsible for all the day-to-day administrative operations of the municipality.

#### IV. Ordinance K-554

- 14. The City of Texarkana. Arkansas competes with the City of Texarkana, Texas for services of civil service employees, and has lost both prospective and existing employees to the City of Texarkana. Texas.
- 15. In an effort to attract and retain police officers, the City of Texarkana, Arkansas passed an ordinance providing for the levy of a one-fourth of one percent (.25%) sales and use tax within the City.
- 16. The stated purpose of the Ordinance was for "salary increases, and maintaining salary parity between the Police Departments of Texarkana, Arkansas, and Texarkana, Texas,"
- 17. Ordinance K-554 ended with the acknowledgement "that there is a great need to establish a stable source of revenue to finance vital municipal services in order to promote and protect the health, safety, and welfare of the City and its inhabitants."
- 18. Ordinance K-554 established the framework for collection of funds to be used by the City to subsidize the police department's payroll related increases over time.

19. The funds collected from the 0.25% sales and use tax were not intended to bolster the City's overall finances.

20. As currently administered, there is no mechanism in place to accurately account for the funds use.

21. Upon information and belief, Plaintiffs believe that the City has used the parity funds for purposes other than those explicitly passed by the electors.

22. The City appears to take the position that parity means any payroll related increase since the Special Election held January 9, 1996.

23. Merriam-Webster defines parity as the quality or state of being equal or equivalent.

24. Had the funds collected from the special sales and use tax been set aside and used only to fund the salary increases and associated expenses, the amount set aside would have increased and decreased over time. Since the passage of Ordinance K-544. Plaintiffs believe the increases would have exceeded the decreases such that a surplus should exist.<sup>2</sup>

25. Based on the City's numbers as presented by Ms. Henderson at the December 19, 2016, Board of Directors Meeting, the special sales and use tax collections for 2017 totaled \$2.26 million. The amount of salary increases required to maintain parity as calculated by the City totaled only \$650,000. This results in an approximate \$1.61 million surplus to be set aside for the future increases. Yet, the City contends that it cannot afford "parity" or salary increases for 2017.

<sup>&</sup>lt;sup>1</sup> The minutes reflect that in a response to a question from Mayor Bell, City Finance Director, TyRhonda Henderson stated that the special sales and use tax collected was \$2.26 million. In addition, Ms. Henderson indicated that in order to meet parity for 2017, it would require \$3.1 million. According to the City's most recent Comprehensive Annual Financial Report, this represents 48.8% of the entire amount expended for the police department.

 $<sup>^{7}</sup>$  Ms. Henderson also indicated that the "cost of the increase alone was \$650,000."

26. The City's position appears to shift the payroll related expenses associated with the police department and ignores the City's portion of the responsibility of maintaining a police

department.

V. Annual Adjustments

27. Beginning in 1998, the City began adopting an annual resolution to adjust salaries

to a revised salary schedule effective October of each year. Resolution 4208 was adopted

September 21, 1998. Resolution 4385 was adopted September 20, 1999. Resolution 4561 was

adopted September 18, 2000. Resolution 4707 was adopted September 17, 2001. Resolution 4979.

was adopted October 9, 2003.

28. On April 17, 2006, Resolution 5304, which contained a written proposal for

submission to the Police Association was passed. The proposal appears to have attempted to define

parity and base pay.

29. The City passed Resolution No. 2016-82 on December 19, 2016. The purpose of

the resolution was to amend the year end 2017 budget. The resolution indicated that an agreement

had been reached that provided for a 4% increase towards parity beginning January 2017 for all

civil service positions receiving an increase of 4% or more. For those civil service positions

receiving less than a 4% increase, full parity would be met in January 2017.

30. As of the date of the filing of this Petition, parity, even according to the definition

used by the City, has not been met.

Unintended Consequences

31. In addition to not receiving timely adjustments to their compensation, police

officers have also been damaged in other, not so obvious ways.

32. Social security benefits are a function of gross wages.

33. The police officers' gross wages have been understated, which directly affects the

amount of social security benefits retiring officers can draw.

Relief Sought

32. Plaintiff's request that this Court enter an Order declaring that parity is the periodic

increase of salaries to be reset on an annual basis.

33. Plaintiffs request that this Court enter an Order declaring that funds collected from

the special sales and use tax be set aside and accounted for separately by the City.

34. In turn, Plaintiffs request that this Court issue a writ of mandamus to Dr. Kenny

Haskin directing him to pay all amounts due to current and prior police officers as required in

Ordinance K-554 and as defined by the Court.

35. Plaintiffs request that this Court retain jurisdiction over this matter for the purposes

of receiving reports and information concerning the administration of the collection of the tax and

payment of the funds or resolving disputes between the parties of this action.

36. In the alternative, in the event this Court determines the Ordinance is

unconstitutional or otherwise invalid, for whatever reason, Plaintiffs request that this Court enter

an Order prohibiting the collection of the additional sales tax and initiating the creation of a

framework to establish a process for the refunding of the tax previously collected.

WHEREFORE, Plaintiffs respectfully request that this Court:

1. Enter judgment in their favor on their Petition in its entirety and against Defendants:

2. Declare that the Ordinance, as passed by the electors, means the special sales and

use tax set aside is for the periodic incremental salary increases of the TAPD;

- 3. Award Plaintiffs all relief allowed by law and equity, including but not limited to declaratory, preliminary and permanent injunctive relief;
- 4. Retain jurisdiction over this matter for the purposes of receiving reports and information concerning the administration of the collection of the tax and payment of the funds and resolving disputes between the parties of this action
  - 5 Award Plaintiffs' attorncys' fees and costs; and,
  - 6. Award any other relief the Court deems proper.

This can only be completed if utility bills and other necessary information are made available per the Owner's responsibilities outlined in this Agreement. Services will include:

- 1. Delivery of a Post-Installation Report to be reviewed with the project team.
- 2. Conduct an M&V Kick-Off meeting.
- 3. Provide <u>annual</u> site visits and reports to review current M&V results and energy performance as needed (**years 1-3 only**).
- 4. Provide an annual M&V Report within 60 days of the end of the performance period.
- 5. Hold an annual M&V site visit and meeting to review current M&V results and project energy performance.

Changes to the project contact list can be made at any time. Owner will need to contact ESCO with the new contact list and changes will be made before sending the next email update.

If utility bills and any other requested information are not provided, per the terms of the Agreement, ESCO shall not be responsible for providing the Energy Savings and Performance report for that time period.

#### Minimum Site Visit and Report Frequency:

#### **Clarifications:**

ESCO may provide additional data on a monthly basis to the Owner depending on any deviations from expected performance. Owner will be required to make necessary changes based on the results of the M&V data.

After the end of Initial Term and each subsequent term thereafter, Owner may either:

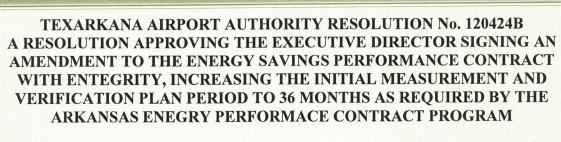

WHEREAS, Entegrity has provided an amendment to the contract to meet the requirements of the State of Arkansas,

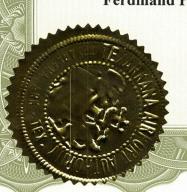

#### **WORK ORDER NO. 1**

### ENGINEERING SERVICES FOR

#### RUNWAY 4-22 STRENGTHENING – DESIGN ONLY TEXARKANA REGIONAL AIRPORT (TXK) TEXARKANA, ARKANSAS

This Work Order amends Articles 1, 2, and 5 of the Basic Agreement executed the 1st day of August, 2024, between McClelland Consulting Engineers, Inc., hereinafter referred to as the ENGINEER or MCE and the Texarkana Regional Airport Authority, hereinafter referred to as the AUTHORITY.

#### **ARTICLE 1**

The AUTHORITY intends to strengthen Runway 4-22 at the Texarkana Regional Airport by constructing an asphalt overlay. McClelland Consulting Engineers, Inc. is pleased to provide this proposal for engineering and design services associated with the Runway 4-22 Strengthening project. The scope of this proposal is to create and provide the construction drawings for the civil/site aspects of the project including site layouts, pavement design, site grading, lighting, and signage. MCE will provide engineering design services with the execution of this contract.

The ENGINEER will complete the following summary of engineering services under Work Order No. 1. Subsequent Work Orders will be developed as other needs arise. Engineering Services During Construction for future construction phases will be developed under another work order.

#### SECTION 1 – SCOPE OF SERVICES

#### **Project Development**

- The ENGINEER will meet with the Owner to discuss the project design criteria, budget, and schedule.
- The ENGINEER will hold meetings with the Airport staff, Commission members, Federal Aviation Administration (FAA), and local officials as the need arises. The ENGINEER will also prepare any presentational material needed for these types of meetings.
- The ENGINEER will hold meetings with the Airport users, including but not limited to the Airline, FBO, and other tenants or users. The ENGINEER will also prepare any presentational material needed for these types of meetings.
- The ENGINEER will compile existing data provided by the Airport that was prepared for previous projects at the Airport that pertain to the proposed project and are useful to the design. The existing data includes airport master plan, airport property map, engineering drawings, topographic surveys, and aerial photogrammetry data.

#### **Preliminary Engineering**

- The ENGINEER will prepare a preliminary estimate of probable construction costs and schematic design for each element of the project.
- MCE's key design staff will meet with the AUTHORITY and airport staff to review the preliminary plans, specifications, and cost estimate.
- The ENGINEER will prepare an overall CSPP per AC 150/5370-2G in order to maximize project constructability and minimize the impact to airport operations. MCE will coordinate with the AUTHORITY, FAA, and selected users of the airport to gain input for this plan. The CSPP will be in accordance with FAA AC 150/5370-2G. The CSPP will be submitted to the Obstruction Evaluation and Airport Airspace Analysis website.



- The ENGINEER will perform FAARFIELD Pavement Analyses utilizing the existing the pavement section depths determined from the geotechnical investigation and anticipated aircraft fleet mix. The analyses will be based on multiple strengthening methods, which will be compared to determine the most efficient solution to strengthen Runway 4-22.
- The AUTHORITY shall approve the aircraft fleet mix prior to pavement design options being developed.
- The ENGINEER will make four (4) site visits during the preliminary design phase. This will be done to document existing conditions.

#### **Topographic Survey**

- MCE will conduct the necessary topographic survey required for the design of the runway strengthening project and note the location of any known, local and FAA-owned utilities. The survey crew will coordinate the work with the Owner including all safety requirements.
- The topographic survey will include the entire Runway 4-22, Runway 4-22 Runway Safety Area (RSA), intersection with Runway 13-31, intersection with connecting taxiways, and all existing above ground features (i.e. runway edge lights & signage).

#### **Geotechnical Investigation**

- The ENGINEER will provide a geotechnical investigation and report for the runway strengthening project. The report will outline detailed information regarding existing pavement conditions and subsurface conditions.
- The ENGINEER will perform a laboratory analysis on the recovered samples to determine the engineering properties of the project soil strata. Laboratory testing will be conducted in accordance with the American Society for Testing and Materials (ASTM) designations.
- Upon completion of the geotechnical exploration and laboratory analysis, the ENGINEER will develop a written geotechnical report and distribute to all parties involved. The report will include the strength of the existing pavement.

#### **Environmental Coordination**

 Environmental Coordination – MCE will conduct an environmental review and coordinate with the OWNER and FAA to assure that all environmental requirements are met for the project. MCE will prepare a CATEX Evaluation to support FAA environmental determination for a categorical exclusion for the project.

#### **Engineering Design Documents**

MCE shall prepare and submit construction drawings, specifications, and applications to the AUTHORITY and the City of Texarkana as required as part of the In-House Large-Scale Development process required to obtain Planning and Engineering Department approvals. City staff review comments will be addressed at each interval of the City's review process.

- Construction drawing set to include but not limited to:
  - Cover Sheet
  - General Notes
  - Site Plan
  - Construction Safety & Phasing Plan
  - Demolition Plan
  - Grading and Drainage Plan
  - Erosion Control Plan
  - Runway Plan & Profile



- Cross Sections
- Pavement Marking Plan
- Lighting and Signage Plan
- Applicable Detail Sheets
- Pavement Section Alternatives MCE will develop at least 2 pavement strengthening options
  with opinions of the advantages and disadvantages of both. Using these alternatives MCE will
  look at life cycle cost analysis to determine the safest and economical pavement strengthening
  design. The final pavement strengthening section will be based on review with the AUTHORITY
  of the data presented.
- Pavement Geometry Using current industry design criteria and FAA Advisory Circulars, MCE will design the pavement geometry (i.e., longitudinal gradient, transverse gradient, etc.).
- Develop QC Plan MCE will develop a schedule of milestone activities for this project. Along
  with these milestones, MCE will develop goals and team member assignments. At a minimum,
  weekly design team meetings will be held and minutes kept throughout the design of the project.
  Completed tasks will be reviewed and new task assigned. A complete QC review of the plans will
  be conducted at 3 intervals during the design period.
- Lighting and Signage The MCE Design Team will evaluate the existing lights and signs and will adjust the necessary structures vertically as per FAA Advisory Circular standards.
- 90% Plan and Specification Submittal MCE will prepare and submit to the Owner the design drawings and specifications for review and comment.
- Final Site Visits MCE design staff will make 2 site visits during the final design phase. This will be done to review the preliminary plans in the field (Plan in Hand).
- Final Plans and Specifications Using all data previously mentioned and FAA's comments MCE's design team will assemble a final design of the project. This design will be based on FAA AC design guidelines along with sound engineering practices for this type of project. Specifications will be developed using the current FAA AC as they pertain to construction for airports (AC 150/5370-10).
- Final Construction Quantities and Estimated Costs MCE will prepare a list of construction work items and their associated quantities. Using these items, a detailed estimate of costs will be developed.
- Final Plans & Specifications MCE will incorporate comments and revisions received from the AUTHORITY into the final design documents.

#### **Bidding & Contract Awarding Services**

- The ENGINEER will prepare the advertisement for bids as well as prepare the bidding documents required.
- The ENGINEER will prepare a list of construction work items and their associated quantities. Using these items, a detailed estimate of probable construction costs will be developed.
- A pre-bid meeting will be conducted on site to review with the potential bidders the bidding requirements. Contractors will have the opportunity to tour the proposed construction site as well.
- Prepare and issue any /all necessary addendums, RFI's clarifications as necessary for the bidding process.
- The ENGINEER will conduct /attend the bid opening at TXK. Once bids are received a certified bid tab will be supplied of all the responsive bids.



- A review and recommendation of the lowest responsive bidder will be made and a Notice of Award will be drafted. Review of the Contractor's bonds and insurance will be made and the contract documents will be prepared.
- The ENGINEER will conduct a pre-construction meeting. At this meeting contract documents will be signed, plans reviewed, schedules established and a Notice to Proceed issued. This meeting will occur at TXK.

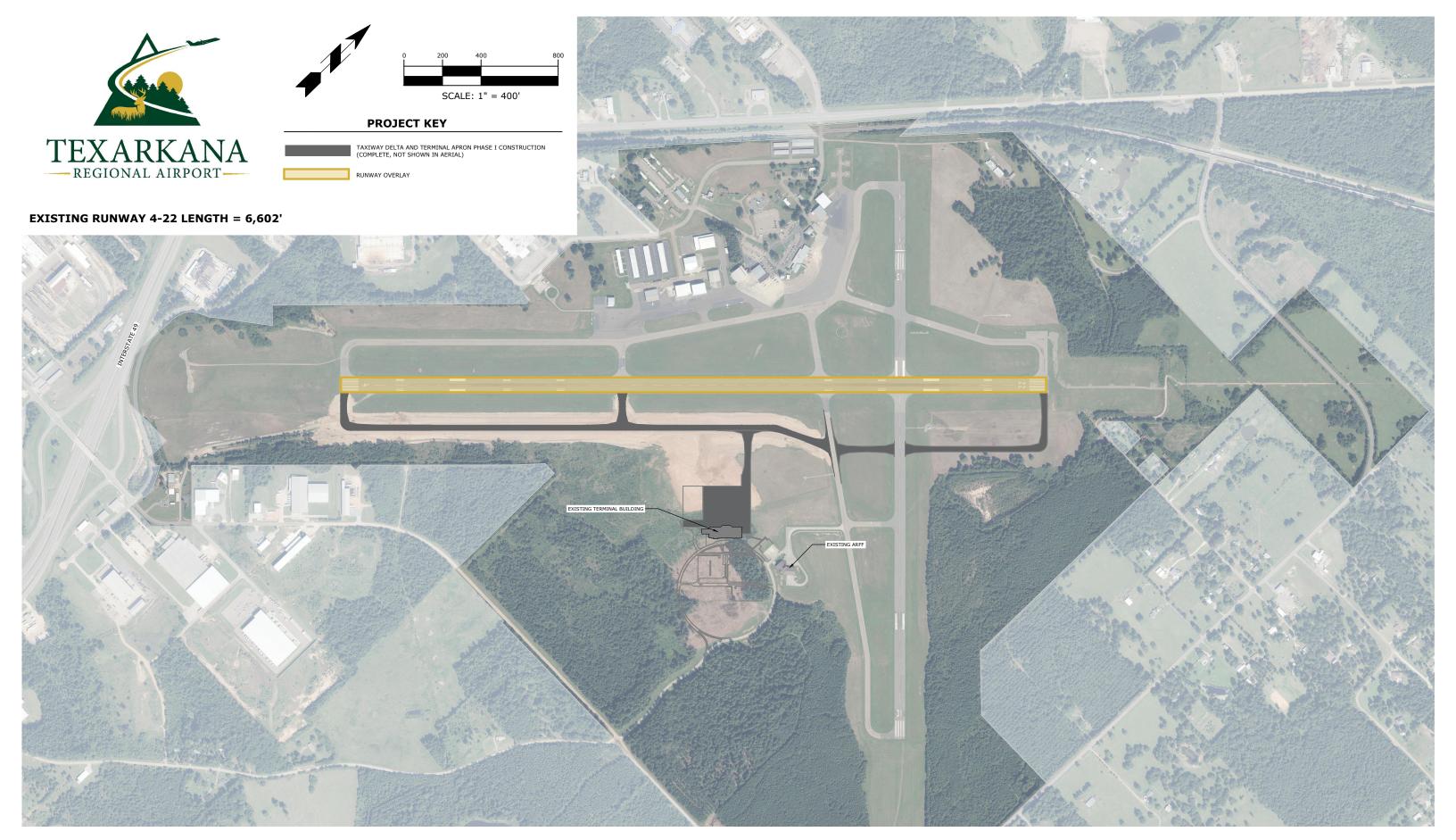

#### **CONTRACT**

THIS CONRACT made and entered into at Texarkana, Arkansas, by and between, ALLEN L. BROWN, Mayor, HEATHER SOYARS, City Clerk, and LAURA COWLING, Finance Director of the CITY OF TEXARKANA, ARKANSAS, composing the City Depository Board of the City of Texarkana, Arkansas, hereinafter referred to as the "CITY" and Commercial National Bank, Texarkana, U.S.A., hereinafter referred to as the "BANK".

#### WITNESSETH:

WHEREAS, the Commercial National Bank, Texarkana, U.S.A., has been designated by the Bank Commissioner of Arkansas, eligible to qualify as a City depository of public funds of the CITY OF TEXARKANA, ARKANSAS, and desires to contract as such depository; and

WHEREAS, the CITY by proper resolution hereto attached has designated the BANK as a depository for public funds of the CITY OF TEXARKANA, ARKANAS,

NOW, THEREFORE, it is agreed by and be the parties hereto:

Section 1. That the BANK shall duly and properly perform all the duties and obligations devolving upon it as a depository of public funds of the CITY OF TXARKANA, ARKANSAS, under Act No. 21 of the General Assembly of the State of Arkansas in reference to the deposit of public funds, for a period beginning January 15, 2025 and ending January 15, 2026, said BANK agreeing to pay promptly upon presentation all checks lawfully drawn upon said depository by the lawful agents and official of said City authorized and empowered under the laws of the State of Arkansas, to withdraw said funds to the amount of said public funds deposited in said depository, and in all things to comply with the laws of the State of Arkansas, in reference to the deposit and payment of public funds of city depositories;

Section 2. That the BANK shall at all times provide collateral for the CITY'S deposits to the extent said deposits exceed F.D.I.C., or other depository insurance. Such collateral

shall consist of a pledge of securities allowed by Section 4 of Act 61 of 1933, of the General Assembly of the State of Arkansas, as amended. Securities pledged to CITY deposits under this section need not be in the CITY'S name; provided, however, that all pledged securities shall be held by the CITY, an agent of the CITY, or the BANK'S trust department.

Section 3. That the BANK shall provide to the CITY the following information pertaining to the status of CITY deposits as of the last business day of the months of June and December:

- A. Total deposits on hand.
- B. Total amount of depository insurance on CITY deposits.
- C. Total pledged securities in CITY'S name.
- D. Total pledged securities not in the CITY'S name.
- E. Holder(s) of pledged securities.

### RULES OF ORDER AND PROCEDURE MANUAL



for the Board of Directors of the City of Texarkana, Arkansas

### RULES OF ORDER AND PROCEDURE FOR THE BOARD OF DIRECTORS OF THE CITY OF TEXARKANA, ARKANSAS

#### A. Title

The following rules and procedures shall be known as the "Rules of Order and Procedure for the Texarkana, Arkansas Board of Directors" and shall govern the conduct of all meetings of said Board unless suspended by proper vote of the members of that Board; and it is specifically understood that these rules and procedures shall be subject to and subordinate to those procedural requirements as established by the laws and the Constitution of the State of Arkansas.

#### **B. Board Meeting**

#### **Public Notification**

The City will, if necessary, go further than legally required in order to inform citizens of the items to be considered by the Board. The means used will include advertisements in a local newspaper, special notice to citizens who have shown a direct interest in matters to be considered and agenda copies available at Board meetings.

#### **Formulation of Agenda**

- 1) Preparation of the agenda for each Regular or Special Meeting of the Board of Directors shall be in accordance with the procedures set forth in the Code of Ordinances of the City of Texarkana, Arkansas.
- 2) Items added to the agenda upon the request of a member of the Board and endorsed by one or more members of the Board in accordance with the Code of Ordinances of the City of Texarkana, Arkansas, shall be identified on the agenda as so requested or endorsed.
- 3) The agenda shall be completed by the city clerk under the supervision of the city manager and distributed to the Board members and news media prior to the close of business on Thursday preceding the regular Board meeting.
- 4) The agenda for special meetings shall be available to the Board of Directors and news media as far ahead of the special meeting as practical.
- 5) Code of Ordinances of the City of Texarkana, Arkansas Sec. 2-17. Bringing business before the board Filing.

- a) All matters of business coming before any regular meeting of the board of directors for action shall be filed with the office of the city manager by 5:00 p.m. on the second Wednesday prior to the regular board meeting. Failure to file notice of intention to seek action on an item of business at least seven (7) business days prior to a regular board meeting shall prevent said business from being included as an agenda item at said meeting.
- b) Copies of filings made in accordance with this section shall be provided to the city manager, city attorney and to each city department head. Department heads and/or the city attorney may thereafter provide comments concerning each proposed item to the city manager. The city manager, by 5:00 p.m. on the Wednesday following the timely filing of an item, and after consideration of any comments received in accordance with this provision, shall make a recommendation of "staff recommends approval" or "staff does not recommend approval" as to each item filed. Unless board consideration is necessitated by other applicable law (for example, proper administrative appeal or consideration of prior action of the planning commission) items not recommended for approval by staff shall not be included on the agenda for the upcoming board meeting and, for any such item originally filed by a member of the board of directors, the city manager shall promptly (within at least thirty (30) days) schedule a workshop of the board of directors for the purpose of discussing the item and, in the event that the item thereafter receives the affirmative endorsement of at least two members of the board of directors, the same will be added to the agenda for the next regularly scheduled meeting occurring no sooner than seven (7) business days following the workshop.
- c) Matters which have been previously voted on and decided by the board of directors at a regular or special meeting of the board cannot be reconsidered at the meeting during which the same was voted and decided, nor resubmitted to the board of directors until the expiration of one hundred eighty (180) days after such vote and decision unless reconsideration is approved by a two-thirds (2/3) vote of the board of directors.

#### **Quorum**

A majority of the Board shall be necessary to constitute a quorum to do business. The concurring vote of a majority of those attending a meeting, provided a quorum is present, shall represent the acts of the Board except where otherwise provided by law or by these rules.

#### **Location**

The location of the Regular Board of Directors' Meetings shall be the Texarkana, Arkansas City Hall Board Room unless another place has been previously set by the Directors.

#### **Agenda Procedures**

Sections 2-16 through 2-20 of the Code of Ordinances of the City of Texarkana, Arkansas, apply to placing an item on a regularly scheduled meeting agenda. However, members of the public will be offered an opportunity to speak on all questions presented to the Board on that particular meeting's agenda. Any member of the public desiring to speak in regard to a particular agenda item will be recognized by the Mayor and given an opportunity to speak prior to action by the Board of Directors. Speakers shall be limited to five (5) minutes; provided, however, a speaker's time may be extended upon proper motion (followed by second and affirmative vote of two-thirds of the entire elected Board) to suspend the rules and extend the speaker's time for a specified period of time. Speakers may not yield time to one another.

#### **Regular Meetings**

The Board shall meet in regular session on the first and third Monday of each month at 6:00 p.m. When a holiday occurs on any such Monday the regular meeting shall be held on the following Tuesday at the same hour unless otherwise provided for by motion. The regular meeting time may be rescheduled by the Board in special circumstances. Any change must be made far enough in advance to allow normal public notification.

#### **Special Meetings**

Special meetings may be called at any time by the Mayor or by Directors representing a majority of the elected membership of the Board, which is four (4) Directors. Notification of a special meeting, including specific items to be considered, shall be at least two hours prior to the meeting. Such notification shall be by personal service to each member or by telephone, specifying time and place of meeting.

No business shall be transacted at any special meeting of the Board unless the same has been stated in the notice of such meeting. However, any additional business, which may lawfully come before a regular meeting, may be transacted at a special meeting if all the members of the Board present consent thereto and all the absent members file their written consent.

#### **Executive Session**

An executive session may be convened at the request of any member of the Board of Directors.

Executive sessions will be permitted only for the purpose of considering the employment, appointment, promotion, demotion, disciplining, or resignation of any public officer or employee.

All executive sessions shall be conducted strictly within the letter and the spirit of the Arkansas Freedom of Information Act.

#### **Consent Agenda**

Items placed in this section are matter of routine business, which are expected to involve little or no discussion by the Board or the public. The Consent Agenda is usually voted on in mass. However, if any Director so desires, individual items may be discussed and/or voted on as a separate matter of business.

#### **General Rules of Discussion**

All debate and comment on a specific agenda item should be limited to that item. Any speaker shall withhold comment until being recognized by the presiding officer. Any person addressing the Board in accordance with these rules shall make such comments from the lectern or such other place as is designated by the presiding officer. Comments should be addressed to the presiding officer or to the Board as a whole. All persons speaking at a meeting, including Directors, shall refrain at all times from rude or derogatory remarks, reflections as to integrity, abusive comments, statements as to motives and personalities. Consent of the presiding officer is required before any person may approach the Board dais beyond the lectern. Should a Director wish that the presiding officer recognize a member of the public or staff to be heard or respond to inquiry, the Director shall address such request to the presiding officer and not directly to the desired speaker.

#### Citizen Participation / Citizen Communication Time

The Board of Directors allows a time on the agenda for citizens, organizations or community groups to address or make presentations to the Board. Except for presentations by a member of the Board of Directors, City staff or City-appointed boards or commissions that may be placed elsewhere on the agenda, all comments by citizens or presentations by organizations or community groups concerning matters that are not otherwise being considered by the Board of Directors as an action item (i.e., for a vote) should be made during this period of the agenda. The Mayor chairs the meeting and will recognize members of the audience who wish to be heard. Citizens, organizations or community groups recognized by the Mayor are requested to approach the lectern, provide their name and address for the record and make their comment or presentation. Each citizen comment or, in the case of a presentation by an organization or community group, each presentation, shall be limited to five (5) minutes; provided, however, a speaker's (or, as applicable, organization's or group's) time may be extended upon proper motion (followed by a second and affirmative vote of two-thirds of the entire elected Board) to suspend the rules and extend the

speaker's time for specified period of time. Speakers or presentations may not yield time to one another.

Action by the Board is limited to those matters properly placed on the agenda or otherwise approved by the Board for consideration at a meeting in accordance with these rules, the *Code of Ordinances of the City of Texarkana*, *Arkansas*, and applicable law.

#### **Policy Statement**

Items not on the regularly scheduled agenda are usually scheduled for a future agenda to give the Board of Directors an opportunity to review the matter.

#### **Smoking Prohibited**

There will be no smoking allowed in the Board Room during Board meetings.

#### C. Duties And Privileges Of Board Members At Board Meetings

#### **Conduct**

During Board meetings Board members shall preserve order and decorum and shall neither by conversation or otherwise delay or interrupt the proceedings. Neither shall they refuse to obey the orders of the Presiding Officer or the rules of the Board.

Every member of the Board desiring to speak shall address the chair and, upon recognition by the Presiding Officer, shall confine herself or himself to the question under debate and shall avoid all personalities and indecorous language. A Board member once recognized shall not be interrupted while speaking unless called to order by the Presiding Officer, unless a point of order is raised by another member or unless the member chooses to yield to questions from another member.

#### **Personal Interest**

No member of the Board with a direct or indirect financial interest in any item before the Board shall participate in the voting on such matter.

#### **Voting**

Every member present when a question is put to a vote shall vote either "yes or no", except that a member may abstain from voting if he or she has not participated in the preceding discussion of the question and if that member briefly states the reason for the abstention. The Directors will vote at Board meetings in the order of their position number, but with a progressively different position voting first at each month.

#### Roll Call

Upon every vote the affirmative and negative votes shall be called and shall be recorded on every motion, resolution, and ordinance.

#### **D.** The Presiding Officer

#### **Mayor and Assistant Mayor**

The Mayor shall preside at all meetings of the Board; in the absence of the Mayor, the duties shall be performed by the Assistant Mayor.

#### **Privileges of the Presiding Officer**

The Presiding Officer may move, second, and debate from the chair and shall not be deprived of the rights and privileges of a member of the Board of Directors by reason of her or his acting as the Presiding Officer.

#### E. Procedures and Parliamentary Rules

#### **Order of Business**

The order of the Board's agenda shall be set by the City Manager. The Mayor, with the consent of the Board, may rearrange the order of the agenda. In addition, at the Presiding officer's discretion or by a majority vote of the Board, certain agenda items may be classified as a part of a "Consent Agenda" and may be approved and adopted as a whole by a single voting action of the Board of Directors.

#### Motion to be stated by the Chair/Withdrawal

When a motion is made and seconded, it shall be stated by the Presiding Officer before debate. After being stated by the Mayor, a motion may not be withdrawn by the mover without the consent of the member seconding it and approval of the Board.

#### **Readings**

All ordinances shall be read aloud at three different meetings unless the Board of Directors votes to suspend this rule in accordance with A.C.A. § 14-55-202. The reading of an ordinance's title shall constitute a complete reading of the ordinance unless objected to by any member of the Board of Directors in which case the ordinance shall be read in its entirety.

#### **Addendum to Agenda**

Any item to be added to the agenda its submission to the Board of Directors shall require a waiver executed by a majority of the members of the Board of Directors before it may be considered as a part of the agenda.

The Arkansas Code of 1987 Annotated (14-56-422B) requires the following – "All plans, recommended ordinances, and regulations shall be adopted through the following procedure for adoption of plans and regulations:

- (1) (A) The Planning Commission shall hold a public hearing on the plans, ordinances, and regulations proposed under this subchapter.
  - (B) Notice of public hearing shall be published in a newspaper of general circulation in the city, at least (1) time fifteen days prior to the hearing.
- (2) Following the public hearing, proposed plans may be adopted, and proposed ordinance and regulations may be recommended as presented, or in modified form, by a majority vote of the entire commission.
- (3) Following it adoption of plans and recommendation of ordinances and regulations, the commission shall certify adopted plans of recommended ordinances of and regulations to the legislative body of the city for its adoption.

- (4) The legislative body of the city may return the plans and recommended ordinances and regulations to the commission for further study or rectification, or, by a majority vote of the entire membership, may, by ordinance or resolution, adopt the plans and recommended ordinances or regulations submitted by the commission. However, nothing in this subchapter shall be construed to limit the city board's authority to recall the ordinances and resolutions by a vote of a majority of the council.
- (5) Following adoption by the legislative body, the adopted plans, ordinances, and regulations shall be filed in the office of the City Clerk. The City Clerk shall file, with the county recorder of the counties in which territorial jurisdiction is being exercised such plans, ordinances, and regulations as pertain to the territory beyond the corporate limits.

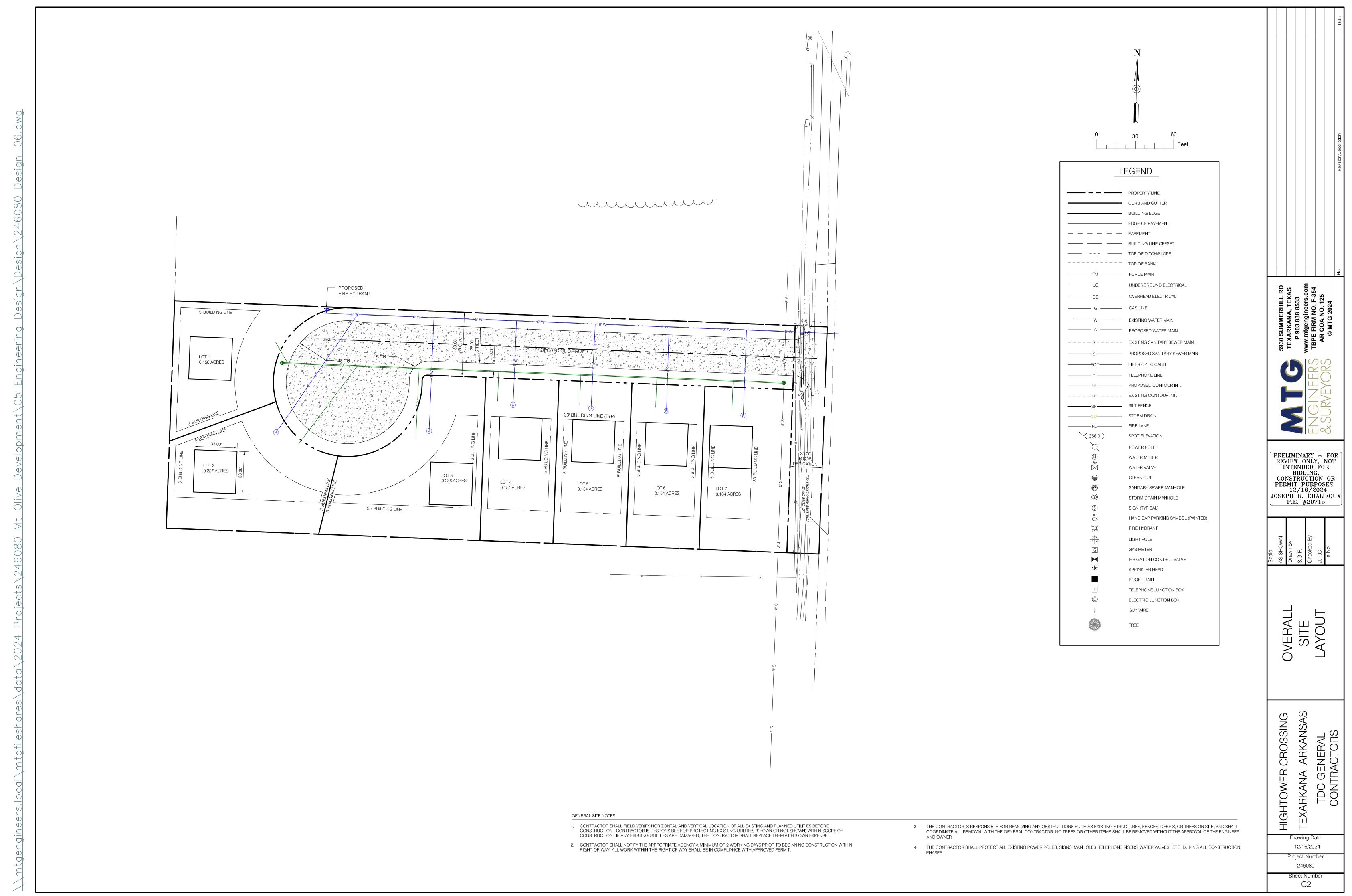
The Planning Commission met on October 8, 2024 and certified recommendation to rezone the property described previously in this document under "Legal Description". 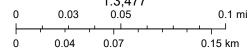

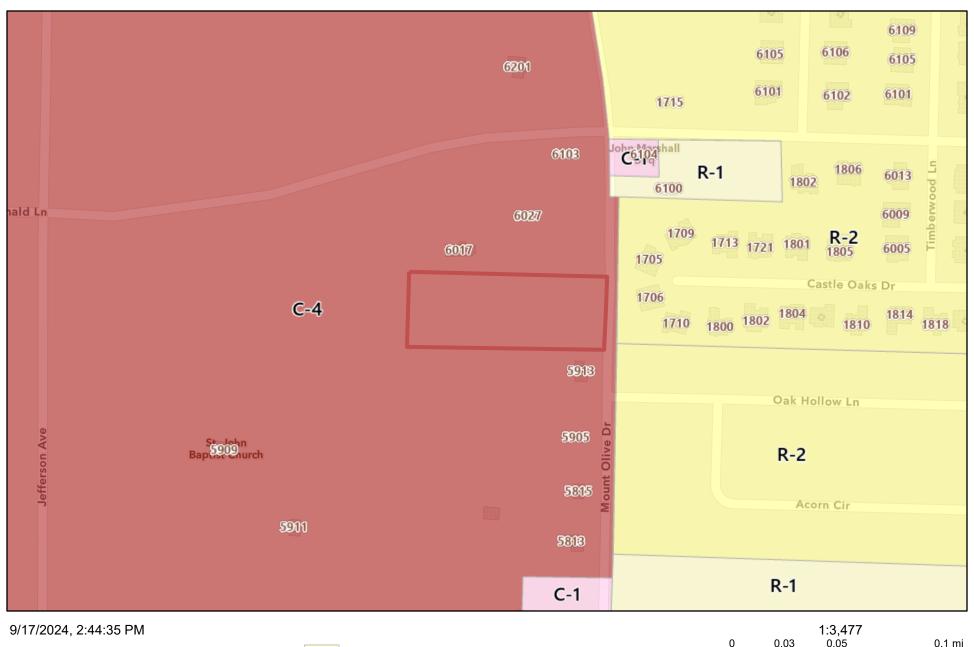
City Limits Outline SiteAddressPoint

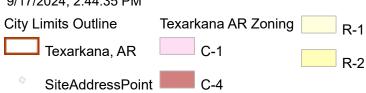

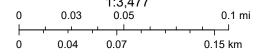
